


Modeled after the US Capitol, the Colorado State Capitol's dome, gilded with true gold leaf, commemorates the 1859 Gold Rush. EverGreene recently regilded the dome for the second time. The first was in 1993 as part of an extensive restoration after hail damage. EverGreene prepared the surface of the dome by stripping, acid washing and priming the copper substrate surface. We then regilded the surface with 23.75k double weight gold leaf. In 2013, EverGreene gilded a new dome that was constructed as part of a seismic upgrade. EverGreene conducted paint analysis of decorative finishes within dome to determine historic paint scheme and replicated original historic finishes. Conservators applied aluminum leaf with a amber shellac finish to pressed metal coffers and column capitols to create the look of gold leaf on the dome interior. EverGreene artists replicated the original sky mural directly on plaster dome ceiling as well as the original color scheme on walls behind columns.

On the dome's exterior, EverGreene removed existing deteriorated coatings of the main copper dome by hydrosilica power-washing. The copper cladding was rubbed clean, washed with solvent, neutralized and

primed. The surface was sized with Lefranc Mixtion 12-hour size and gilded with double-weight 23.75 karat gold leaf. Gilding of the two quarter domes included gilding of two cupolas on top of each quarter dome and the copper ribs.

Modeled after the US Capitol, the Colorado State Capitol's dome, gilded with true gold leaf, commemorates the 1859 Gold Rush. EverGreene recently regilded the dome for the second time. The first was in 1993 as part of an extensive restoration after hail damage. EverGreene prepared the surface of the dome by stripping, acid washing and priming the copper substrate surface. We then regilded the surface with 23.75k double weight gold leaf. In 2013, EverGreene gilded a new dome that was constructed as part of a seismic upgrade. The gold is locally mined, donated by Anglo Ashanti Mining Company and was beaten in Italy.



Conservators applied aluminum leaf with a amber shellac finish to pressed metal coffers and column capitols to create the look of gold leaf on the dome interior. EverGreene artists replicated the original sky mural directly on plaster dome ceiling as well as the original color scheme on walls behind columns.

On the dome's exterior, EverGreene removed existing deteriorated coatings of the main copper dome by hydrosilica power-washing. The copper cladding was rubbed clean, washed with solvent, neutralized and

primed. The surface was sized with Lefranc Mixtion 12-hour size and gilded with double-weight 23.75 karat gold leaf. Gilding of the two quarter domes included gilding of two cupolas on top of each quarter dome and the copper ribs.


