 - 1.1 Area 104: Currently all lights in areas 104, 105, and 109 are on a common switch, with one light being unswitched. The new plan shall divide this large area into three discreet switched areas. Area 104 shall have seven (7) fixtures removed, replaced with one (1) battery fixture near the door, and three (3) other fixtures placed around the area according to the attached drawing. The light switch will remain in the current location, but shall be replaced with a dimmer switch.
