## **Question 1:** Whether companies from Outside USA can apply for this? (like, from India or Canada)

**Answer 1:** It would be very difficult for a company outside the country to do the work due to the ongoing phone communication and training needed. Due to the development and implementation components, travel expenses need to be considered.

#### **Question 2:** Whether we need to come over there for meetings?

**Answer 2:** There is a chance a face to face meeting would be needed to ensure program staff and vendor are developing the required components of the system in the required time frame. Due to the development and implementation components, travel expenses need to be considered.

#### Question 3: Can we perform the tasks (related to RFP) outside USA? (like, from India or Canada)

- **Answer 3:** Based upon the multiple needs of the data system, it will be critical that program staff have accessibility to the vendor during the development and implementation of the system. Due to multiple federal reports, it will be critical for the system to be usable within the time frame of the specs. This could entail multiple face to face meetings during the design time.
- Question 4: Can we submit the proposals via email?
