


Public Consulting Group, Inc. (PCG) is pleased to present this quote to the West Virginia Offices of the Insurance Commissioner (WVOIC) in response to *RFQ 070 4INS1800000002* seeking assistance with WVOIC's prescription drug formulary review process.

PCG's Health Practice Area has developed a niche with state insurance departments. Over the past five years, PCG has established a specific bringing health insurance form reviews into compliance with major changes in federal and/or state law. We have a five-part, end-to-end process for doing so, which includes:

Members of this proposed project team are working in several other states and have built impressive formulary review skill sets. In addition to providing technical assistance to Pennsylvania's formulary review, PCG is supporting **Rhode Island**, the **District of Columbia**, and **Illinois** in their implementation of **health insurance enforcement and consumer protection initiatives**. Additionally, PCG will provide the WVOIC with subject matter expertise in **health policy**, and a regulatory relationship to insurance compliance.

This quote serves as PCG's proposed approach and budget for the completion of the services requested below. PCG is prepared to perform the following tasks:

- Review formularies for ACA-compliant plans for 2019 and 2020 plan years for compliance with all applicable state and federal laws and guidance, including federal nondiscrimination standards.
- 2. Communicate questions and comments regarding the formularies with WVOIC as well as with insurers, as directed by WVOIC.
- 3. Develop standard operating procedures (SOPs) and/or tools for WVOIC staff to use when reviewing formularies in future plan years.
- 4. Assess whether additional templates and/or guidance to insurers are appropriate to enable WVOIC and the contractors to effectively and efficiently evaluate formularies for compliance with applicable state and federal laws and guidance.
- 5. Provide training to Department staff on use of all SOPs, tools, and templates developed.
- 6. Provide training to insurers on use of tools and templates developed.
- 7. Analyze previously approved formularies to **identify areas of potential discrimination** and potential trends of nondiscrimination, and produce a report documenting the analysis.
- 8. Coordinate with other WVOIC consultants on related tasks.



The tracker allowed staff to review items for compliance and indicate the status of their review, and also provided the PID with a list of state-specific and federal standards and requirements to facilitate the review. Mr. Haney also assisted in developing a QHP Review Manual and in providing recommendations regarding changes to issuer guidance.
