

## **Vendor Questions**

- Q.1. Can we have at least five days beyond the time answers are made available to these questions to update our proposal?
- A.1. The date and time the solicitation closes remains unchanged.
- Q.2. What source(s) of data is West Virginia planning to use for their CAFR reporting (PBCS, EPBCS, Oracle Cloud ERP, something else)?
- A.2. The State of West Virginia's ERP system, wvOASIS. There is no requirement that the software being procured under this solicitation interface with wvOASIS.
- Q.3. Do the users of this solution have access to the data source(s)?
- A.3. Yes
- Q.4. How many documents currently make up the CAFR?
- A.4. 9 MS-Word Files 19 – MS-Excel Files
- Q.5. What are the formats of those documents (Financial Reports, PDF, Word, PowerPoints, etc.)?
- A.5. See A.4. above
- Q.6. What Oracle reporting tool(s), if any, are currently being used to generate the CAFR?
- A.6. None, other than a general ledger report by Fund from wvOASIS.
- Q.7. The RFQ does not discuss the importance of IT Security. The Public Sector is increasingly requiring direct SOC1, SOC2 and FedRAMP certification for vendor applications as minimum requirements to ensure the security and privacy of their data. Will the Purchasing Division change the RFQ to describe the IT Security Requirements you expect and add the requirement of direct SOC1, SOC2, and FedRAMP certification from the vendor to ensure the security and privacy of your Data?
- A.7. No, the specifications will remain the same.
- Q.8. In the RFQ, you list a requirement for a responding vendor to have 20 CAFRS that had successful submissions to the GFOA award program (Section 3.1). In addition to this, an effective measure of a vendor's ability to perform throughout the life of your award (Base plus 3 option periods) is to also require the vendors to submit at least 5 years of audited financial statements. Will the Purchasing Division change the RFQ to include at least 5 years of audited financial statements to ensure the State selects a vendor that is on strong financial footing?
- A.8. No, the specifications will remain the same.

- Q.9. In the Public Sector there is a strong emphasis on supporting the U.S. workforce. Will the Purchasing Division change the RFQ to require all vendor employees working with the Consolidated Public Retirement Board to be based in the U.S.?
- A.9. No, the State of West Virginia cannot limit competition due to geographical location.
- Q.10. In the Public Sector there is a strong emphasis on 24 / 7 Customer Support and dedicated personalized Customer Management who has experience successfully onboarding and working with similar customers. Will the Purchasing Division change the RFQ to describe the 24 / 7 and the dedicated support that is expected?
- A.10. No, the specifications will remain the same.
- Q.11. The Purchasing Division doesn't describe the importance of selecting a vendor that has created the software, routinely updates the software and provides direct ongoing support for the software. In the Public Sector there is a strong emphasis for vendors to develop a partnership relationship between the customer and the vendor that continues to deliver value long after the initial sale. Will the Purchasing Division update the RFQ to describe the importance of selecting a vendor that creates, owns, enhances and supports the proprietary software and to provide reference to any / all Patents owned on the software?
- A.11. No, the specifications will remain the same.
