

I would need to know the following in order to quote you a machine otherwise the machine may be wrong if ordered. There are different capacities, voltages, fork lengths etc. Do you have the phone number for the direct end user so that I may ask these questions?

1. Voltage:
 - A. 24 volts
2. Fork size:
 - A. Forks can be no thicker than 3¹/₄ inches and no wider than 9 inches
 - B. Forks can't be spaced closer than 7 inches together and over 27 inches wide from outside to outside of fork.
 - C. Forks length should be on greater than 47¹/₂ inches and no shorter than 47 inches
3. Capacity:
4. A. Maximum capacity 6,000 LB
5. Door ways or Aisles Width & Height:
 - A. Over all width of Jack should not exceed 38 inches.
 - B. Over all height of Jack should not exceed 60 inches.
6. How many hours will unit run daily:
 - A. 6 Hour ran time
7. Additional Known Safety devises required:
 - A. Any safety devises used should not impede the operator from using the Jack as a walk behind Jack as well.
