




- 1. PURPOSE AND SCOPE: The West Virginia Purchasing Division is soliciting bids on behalf of the Tax Division to establish a contract for the one-time purchase of nine servers and virtualization software.
- 2. **DEFINITIONS:** The terms listed below shall have the meanings assigned to them below. Additional definitions can be found in section 2 of the General Terms and Conditions.
 - 2.1 "Contract Item" means servers as more fully described by these specifications.
 - **2.2 "Pricing Page"** means the pages, contained in wvOASIS, upon which Vendor should list its proposed price for the Contract Items.
 - **2.3 "Solicitation"** means the official notice of an opportunity to supply the State with goods or services that is published by the Purchasing Division.
 - 2.4 "GB" stands for gigabyte
 - 2.5 "GHZ" stands for gigahertz
 - 2.6 "GUI" stands for graphical user interface
 - 2.7 "KVM" stands for keyboard, video, mouse
 - **2.8 "OEM"** stands for original equipment manufacturer which is a company that produces parts and equipment that may be marketed by another manufacturer.
 - 2.9 "RAID" stands for redundant array of independent disks
 - 2.10 "RDIMM" stands for registered dual in-line memory module
 - **2.11 "SSH"** stands for Secure Shell which is a cryptographic network protocol for operating network services securely over an unsecured network
 - 2.12 "TB" stands for terabyte
- 3. QUALIFICATIONS: Vendor shall have the following minimum qualifications:
 - 3.1 Vendor must be the manufacturer or an authorized reseller of its proposed hardware. Agency reserves the right to request proof of authorization. Vendor must provide any documentation requested by the State to assist in confirmation of compliance with this provision. References, documentation, or other information to confirm

compliance with this experience requirement may be requested after bid opening and prior to contract award.

4. GENERAL REQUIREMENTS:

4.1 Mandatory Contract Item Requirements: Contract Item must meet or exceed the mandatory requirements listed below.

4.1.1 Dell PowerEdge R740 Servers or Equal

- 4.1.1.1 Servers must be compatible with agency Microsoft Windows Server 2012 R2 and 2016 and Microsoft SQL Server Enterprise 2014. Servers must not require additional hardware or software to accomplish this compatibility.
- **4.1.1.2** Each server must have a minimum of two (2) processors with a minimum 3.2 GHz speed or greater. Each processor must have eight (8) physical cores.
- **4.1.1.3** Each server must have the capacity to hold a minimum of eight (8) or more hard drives.
- 4.1.1.4 Each server must have a 2U chassis.
- **4.1.1.5** Each server must have a Defective Media Retention option which allows the Agency to retain defective hard disks and SSD/Flash components containing sensitive data.
- **4.1.1.6** Servers must come with a minimum of two (2) solid state drives with a minimum of at least 240GB of space.
- **4.1.1.7** Each server must have a minimum of 768GB of 2666MHz memory (RDIMM).
- **4.1.1.8** Each server must have a minimum 2GB Storage Controller (RAID). Each server must provide backup power for these Storage Controllers.
- **4.1.1.9** Each server must have a minimum of two (2) 10GBASE-T ports, two (2) 16GB Fibre Channel Host Bus Adapter ports, and four (4) 1GB ethernet ports.
- 4.1.1.10 Each server must have redundant 500W power supplies.
- 4.1.1.11 Each server must have a rack mount kit.

- 4.1.1.12 Must have a minimum of one (1) USB 3.0 or 3.1 ports.
- **4.1.1.13** Servers must be new and genuine. Refurbished or secondary market equipment will not be accepted.
- **4.1.1.14** Each server must be assembled by the manufacturer prior to shipping.

4.1.2 Server Warranty

- 4.1.2.1 Must have a minimum five (5)-year hardware warranty for all hardware contained in Chassis, Vendor must provide OEM-supported replacement parts onsite by next business day.
- **4.1.2.2** Must be supported by firmware and driver updates while under warranty. Use of Open Source software will result in bid disqualification.

4.1.3 VMware or Equal

- 4.1.3.1 VMware vSphere Enterprise Plus or Equal for 1 processor
- **4.1.3.2** Item # BD715AA Production Support/Subscription for VMware vSphere Enterprise Plus for 1 processor for 3 years- technical support, 24-hour Severity 1 Support 7 days a week.

4.1.4 Alternative 'Or Equal' Submission

4.1.4.1 Contract Item if bidding an "or Equal" product will not require the purchase of any additional software or hardware for implementation. If Vendor is submitting an or Equal product, this information must be provided at the time of submitting bid response.

Any documentation supporting such should be submitted with bid response but may be requested before contract award.

5. CONTRACT AWARD:

- **5.1 Contract Award:** The Contract is intended to provide Agencies with a purchase price for the Contract Items. The Contract shall be awarded to the Vendor that provides the Contract Items meeting the required specifications for the lowest overall total cost as shown on the Pricing Pages.
 - 5.1.1 Vendor should include with their bid a copy of any Software Terms and Conditions or licenses that the State of West Virginia or the Agency will have to agree or accept as a part of this solicitation. This information will be required before Purchase Order is issued.
 - 5.1.2 Vendor should include a copy of Maintenance Terms and Conditions or Licenses that the State of West Virginia or the Agency will be required to agree or accept as a part of this solicitation. This information will be required before the Purchase Order is issued.
- **5.2 Pricing Page:** Vendor should complete the Pricing Page. Vendor should complete the Pricing Page in full as failure to complete the Pricing Page in its entirety may result in Vendor's bid being disqualified.

Vendor should type or electronically enter the information into the Pricing Page to prevent errors in the evaluation.

Vendors who wish to respond to a centralized Request for Quotation (CRFQ) online may submit information through the state's wvOASIS vendor self-service (VSS). If unable to respond online, vendor must submit their pricing page with their submitted bid prior to the scheduled bid opening date.

Vendor should electronically enter the information into the Pricing Pages through wvOASIS, if available, or as an electronic document. 6. PAYMENT:

6.1 Payment: Vendor shall accept payment in accordance with the payment procedures of the State of West Virginia.

7. DELIVERY AND RETURN:

7.1 Shipment and Delivery: Vendor shall ship the Contract Items immediately after being awarded this Contract and receiving a purchase order. Vendor shall deliver the Contract Items within fifteen (15) calendar days after receiving a purchase order.

7.2 Late Delivery: The Agency placing the order under this Contract must be notified in writing if the shipment of the Contract Items will be delayed for any reason. Any delay in delivery that could cause harm to an Agency will be grounds for cancellation of the Contract, and/or obtaining the Contract Items from a third party.

Any Agency seeking to obtain the Contract Items from a third party under this provision must first obtain approval of the Purchasing Division.

- 7.3 **Delivery Payment/Risk of Loss:** Vendor shall deliver the Contract Items F.O.B. destination to the Agency's location.
- 7.4 Return of Unacceptable Items: If the Agency deems the Contract Items to be unacceptable, the Contract Items shall be returned to Vendor at Vendor's expense and with no restocking charge. Vendor shall either make arrangements for the return within five (5) days of being notified that items are unacceptable, or permit the Agency to arrange for the return and reimburse Agency for delivery expenses. If the original packaging cannot be utilized for the return, Vendor will supply the Agency with appropriate return packaging upon request. All returns of unacceptable items shall be F.O.B. the Agency's location. The returned product shall either be replaced, or the Agency shall receive a full credit or refund for the purchase price, at the Agency's discretion.
