3.1.2.1 Wheelbase shall be 195-inches minimum to 206-inches maximum and shall be set forward axle design.

3.1.2.3 Cab to Axle Dimension: Shall be 116 inches minimum usable. (Back of cab to centerline of trunnion).

3.1.24.1 Rack shall be a minimum of 70-inches 5052 grade Polished Aluminum with window with minimum of 3-boxes lockable with bar light mount Protech Model #10-1153 or equal.

This letter is for clarification purposes only. We were not sure if the usable CA included the head ache rack or not.

Currently our tractor has a wheelbase of 206" and a calculated CA of 100" after the installation of the headache rack.

PURCHASING AFFIDAVIT

CONSTRUCTION CONTRACTS: Under W. Va. "Employer default" means having an outstanding balance or liability to the old fund or to the uninsured employers' fund or being in policy default, as defined in W. Va. Code § 23-2c-2, failure to maintain mandatory workers' compensation coverage, or failure to fully meet its obligations as a workers' compensation self-insured employer. An employer is not in employer default if it has entered into a repayment agreement with the Insurance Commissioner and remains in compliance with the obligations under the repayment agreement.

"Related party" means a party, whether an individual, corporation, partnership, association, limited liability company or any other form or business association or other entity whatsoever, related to any vendor by blood, marriage, ownership or contract through which the party has a relationship of ownership or other interest with the vendor so that the party will actually or by effect receive or control a portion of the benefit, profit or other consideration from performance of a vendor contract with the party receiving an amount that meets or exceeds five percent of the total contract amount.

AFFIRMATION: By signing this form, the vendor's authorized signer affirms and acknowledges under penalty of law for false swearing (W. Va. 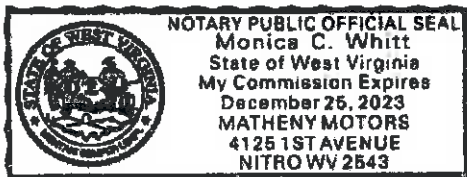

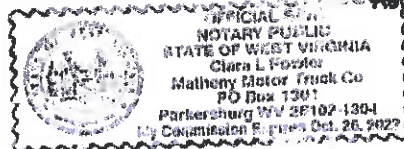
