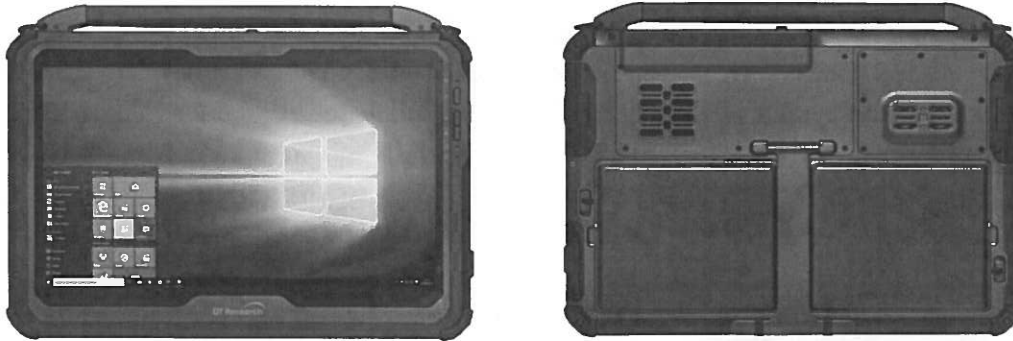
## 3. TECHNICAL CHARACTERISTICS

### 3.1. DT RESEARCH DT340 RUGGED TABLET

In this response Patriot is recommending the West Virginia Department of Transportation to go with DT Research's DT340T Rugged 14" Tablet. The DT340T rugged tablet features the integration of a brilliant 14" capacitive touch screen and high performance, energy efficient Intel 8<sup>th</sup> Generation Core i5 quad core processor within a slim, lightweight, durable package. This tablet offers seamless information capture for instant transmission in the field and in the office. With its large, vivid display this rugged tablet supports a wider working area and detailed application interface. The DT340 rugged tablet has two (2) 60W battery packs which can be hot swapped with spare batteries to provide continuous usage. The MIL-STD and IP ratings also make this tablet stand up to real world use for mission critical applications.

We believe the DT340 Rugged tablet provide a feature set which is richer than the Dell 5414 tablet. We have attached a copy of the DT340T product brochure for reference and listed below a quick comparison of the two products side by side.

### 3.2. DT DOCKING KEYBOARD

The Docking Keyboard is easy to connect to the Rugged Tablet and serves as a protective cover when folded over the tablet, shielding the screen from scratches and bumps. The 2-in-1 design of the Docking Keyboard and the Rugged Tablet provides users with both a laptop and tablet experience, useful for countless applications.

#### Using the Detachable Keyboard with the Tablet

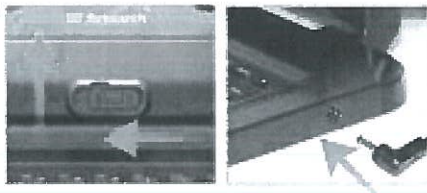
Rotate the center docking port so that it is facing up. Unfold/ lift up the metal stand from the back of the main Keyboard, and place on a flat surface.

### 3.3. NO FAULT ACCIDENT PROTECTION WARRANTY (TABLETS ONLY)

Patriot included pricing for four (4) year no fault warranty on the DT340T tablets. The four (4)-year, No-Fault Accident Protection Warranty plan replaces the Basic Warranty with expanded coverage that enhances the features and extends the term of the Basic Warranty. The 4-year term is measured from the date of original purchase. This optional warranty includes coverage for accidental damage to the Product. In addition, purchasers of the plan are eligible for 2-way shipping by DT Research when returning products for warranty repair (refer to Obtaining Warranty Service) when the plan is in effect.

#### The following limitations apply:

- Only Tablet products that are sold and for use within the USA are eligible for this option;
- The LCD (display) and the System Board (motherboard) are limited to one replacement/repair claim per unit, per year;
- Accessories are covered for the first year only and coverage is limited to defects in workmanship and materials;
- Battery packs are covered for the first year only and coverage is limited to defects in workmanship and materials.
- The No-Fault Accident Protection Warranty applies only to products with authentic product serial numbers and to defects in materials and workmanship which occur under normal use and for accidental damage. The coverage DOES NOT EXTEND TO: damage to products or parts which results from alteration, modification, faulty installation or service by anyone other than an authorized DT Research Service Provider; damage to products or parts caused by fire, submersion, theft or loss, abuse or misuse (such as exposure to liquids with protective covers left open), application software, virus or malware (regardless of origin), improper maintenance, mishandling, misapplication, or use in violation of instructions furnished by DT Research, acts of war and acts of God (such as lightning and earthquakes); damage which occurs during shipment; and, cosmetic damage with no effect on product functionality.

### 3.4. PRICING

Patriot is offering the DT340 rugged 14" tablet with an Intel 8<sup>th</sup> generation i5-8250U processor, 16GB RAM, 512GB Flash, Windows 10 IoT Enterprise, digital pen, 2-in-1 detachable keyboard with backlit keys and a 4 year no fault warranty at a unit price of \$2,752. # ATTACHMENT A

**Question 1: “...Can vendors include optional pricing for protective cases to add value to their bid”**

**Answer 1:** Vendors are permitted to include optional pricing for accessories. However, pricing for additional items not requested in the bid will be considered information. WV DOT will not be able to purchase accessories that were not specified in the requirements.

**Question 2: “Why is a pen needed for a non-touch screen?”**

**Answer 2:** Section 3.1.1 has been modified, the requirement for a pen has been removed and is no longer required.

**Question 3: “Also, Dell tells me that the 5414 is nearing end of life and there is not enough inventory to fill the order”**

**Answer 3:** The specifications included enough detail to identify the technical requirements of the equipment being requested. The vendor may propose an alternative model if it meets or exceeds the requirements outlined in the specifications. For additional clarification review section 3.1.3.

**Question 4: “The 5420 has replaced the 5414. The specifications are the same except for the battery. The battery in the 5420 is not a 65 W battery it is only 51 watts. Will this model be acceptable?”**

**Answer 4:** Section 3.1.1. has been modified to accept a minimum 50-watt hour battery.

**Question 5: “Can you identify the battery a bit more? The Dell rugged 14” series has a 3 cell 51-Watt battery. They offer a possibility of 2 batteries, but neither is individually 6 cell or 65 Watts?”**

**Answer 5:** See response to question 4.

**Question 6: “The Dell 5414 did not have a 65-Watt 6 cell battery but the laptop appears to have been discontinued in favor of the newer 5424 or 5420 that does not have a 65 Watt or 6 cell battery.”**

**Answer 6:** See response to question 4

**Question 7:** “Can you explain the active pen with Bluetooth launch a little more? Is there a particular part number? Typically, the pens are used with touch capabilities, but the bid specified it does not need to be a touch model.”

**Answer 7:** See response to question 2.

**Question 8:** “The warranty was specified for 4 years but the Absolute Reliance was requested at 5 years, was this intentional?”

**Answer 8:** No, this is not an oversight, 5 years of licensing is required by the WV Office of Technology. **NOTE: only (70) Absolute Reliance license are required.**

**Question 9:** “Are these going to be used in vehicles and docked? The bid did not clarify any kind of pass through or docking stations?”

**Answer 9:** Docking stations are not required.

**Question 10:** “Do you want 4G LTE connectivity? I know it is not listed but it is a very popular feature...”

**Answer 10:** 4G LTE is not required.

**Question 11:** “How are you verifying the equipment is installed by the factory? Are you verifying part numbers with factory representatives? We’ve observed some folks will quote products with aftermarket parts to shave the price down and if a practice is not in place those folks get away with it at an alarming rate.

**Answer 11:** The vendor is required to submit specifications with manufacturer part numbers.

**Question 12: "Will a Rugged 2 in 1 Tablet and detachable keyboard be acceptable as long as it meets the other requirements."**

**Answer 12:** The proposed equipment must meet or exceed the mandatory requirements. This equipment will be utilized in a dusty and dirty environment. 3.1.1 has been modified to include the following statement:

Laptop must be designed to withstand drops and or falls. It must also be designed to withstand shock, vibration, rain, dust, sand, altitude, extreme temperature changes (freezing to boiling temperatures)

**Question 13: "Can you clarify the requirement for a 40 hour battery life? Is a device with hot swappable batteries to allow continuous operation acceptable?"**

**Answer 13:** See response to question 4.

**Question 14: "Will these be mounted in a vehicle? If so, and an alternative is proposed do you need a mounting dock?"**

**Answer 14:** See question 9.

**Section 3.1.1 has been modified to require a minimum 256 GB solid state hard drive or equal.**

## West Virginia Ethics Commission



### Disclosure of Interested Parties to Contracts

Pursuant to *W. Va. Code* § 6D-1-2, a state agency may not enter into a contract, or a series of related contracts, that has/have an actual or estimated value of \$1 million or more until the business entity submits to the contracting state agency a Disclosure of Interested Parties to the applicable contract. In addition, the business entity awarded a contract is obligated to submit a supplemental Disclosure of Interested Parties reflecting any new or differing interested parties to the contract within 30 days following the completion or termination of the applicable contract.

For purposes of complying with these requirements, the following definitions apply:

- (3) the person or business entity, if any, that served as a compensated broker or intermediary to actively facilitate the applicable contract or negotiated the terms of the applicable contract with the state agency. (This subdivision does not apply to persons or business entities performing legal services related to the negotiation or drafting of the applicable contract.)

*"State agency"* means a board, commission, office, department or other agency in the executive, judicial or legislative branch of state government, including publicly funded institutions of higher education: Provided, that for purposes of *W. Va. Code* § 6D-1-2, the West Virginia Investment Management Board shall not be deemed a state agency nor subject to the requirements of that provision.

The contracting business entity must complete this form and submit it to the contracting state agency prior to contract award and to complete another form within 30 days of contract completion or termination.

# PURCHASING AFFIDAVIT

**CONSTRUCTION CONTRACTS:** Under W. Va. Code § 5-22-1(i), the contracting public entity shall not award a construction contract to any bidder that is known to be in default on any monetary obligation owed to the state or a political subdivision of the state, including, but not limited to, obligations related to payroll taxes, property taxes, sales and use taxes, fire service fees, or other fines or fees.

**ALL CONTRACTS:** Under W. Va. Code §5A-3-10a, no contract or renewal of any contract may be awarded by the state or any of its political subdivisions to any vendor or prospective vendor when the vendor or prospective vendor or a related party to the vendor or prospective vendor is a debtor and: (1) the debt owed is an amount greater than one thousand dollars in the aggregate; or (2) the debtor is in employer default.

**EXCEPTION:** The prohibition listed above does not apply where a vendor has contested any tax administered pursuant to chapter eleven of the W. Va. Code, workers' compensation premium, permit fee or environmental fee or assessment and the matter has not become final or where the vendor has entered into a payment plan or agreement and the vendor is not in default of any of the provisions of such plan or agreement.

**DEFINITIONS:**

"Debt" means any assessment, premium, penalty, fine, tax or other amount of money owed to the state or any of its political subdivisions because of a judgment, fine, permit violation, license assessment, defaulted workers' compensation premium, penalty or other assessment presently delinquent or due and required to be paid to the state or any of its political subdivisions, including any interest or additional penalties accrued thereon.

"Employer default" means having an outstanding balance or liability to the old fund or to the uninsured employers' fund or being in policy default, as defined in W. Va. Code § 23-2c-2, failure to maintain mandatory workers' compensation coverage, or failure to fully meet its obligations as a workers' compensation self-insured employer. An employer is not in employer default if it has entered into a repayment agreement with the Insurance Commissioner and remains in compliance with the obligations under the repayment agreement.

"Related party" means a party, whether an individual, corporation, partnership, association, limited liability company or any other form or business association or other entity whatsoever, related to any vendor by blood, marriage, ownership or contract through which the party has a relationship of ownership or other interest with the vendor so that the party will actually or by effect receive or control a portion of the benefit, profit or other consideration from performance of a vendor contract with the party receiving an amount that meets or exceeds five percent of the total contract amount.

**AFFIRMATION:** By signing this form, the vendor's authorized signer affirms and acknowledges under penalty of law for false swearing (W. Va. Code §61-5-3) that: (1) for construction contracts, the vendor is not in default on any monetary obligation owed to the state or a political subdivision of the state, and (2) for all other contracts, that neither vendor nor any related party owe a debt as defined above and that neither vendor nor any related party are in employer default as defined above, unless the debt or employer default is permitted under the exception above.
