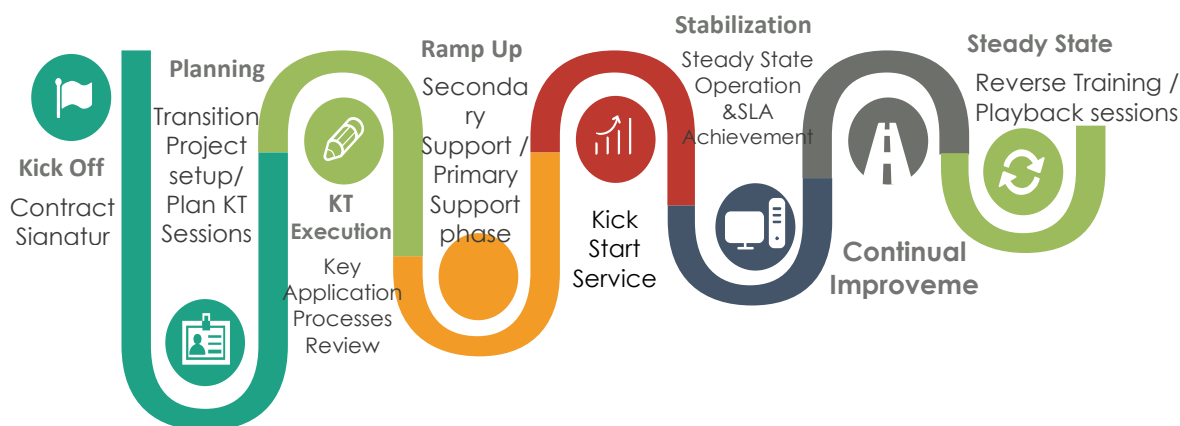

GBSI currently have more than 20, 000 prescreened resources with atleast 200 candidates of each job roles for this engagement such as Telecom Engineer, System Administrator, Network Operations Center Manager, Service Desk Supervisors and Network Administrators. These are the resources which are prescreened and submitted to one of the requirements in past. These candidates include our full time employees, W2 contractors, Independent contractors, candidates from our subcontractors and retirees. We understand that not all these resources will be available all the times when we have the requirements. But keeping them in our cloud ATS system ensures that these candidates are searchable from anywhere from any device including mobile devices. Also our complex search capabilities to search resumes allow recruiters to search all matching profiles with a click of a button from this database.

GBSI recruitment process takes **reference check** as a very important function to validate authenticity and fitness of the candidate. We request candidates to provide minimum 2 references from their past assignments. Our senior recruiters contact these references and seek feedback regarding technical and team performance of the candidate and rehirability.

The relevant candidates go through multiple rounds of HR and technical screening to ensure that they have the right soft and hard skills along with the cultural fit required to fit in and deliver results on the assignment. Our Technical screening involves interview with technology expert in relevant field, Online Skills assessment tests, problem solving case studies based on required skills expected to carry out the job.

Our Propitiatory Screening process works at multiple levels. We do not stop at primary screening but go deeper to ensure right fit. Below is list of check points we use when screening



the candidates to ensure we get the best fit candidate and filter out non matching candidates.

Preliminary/ basic assessment criteria:

- 1) Skills - whether the candidate possesses the skills required for the position. this involves technical screening, online proficiency evaluation, video conferencing, etc.
- 2) Experience - whether the candidate has related experience in job, function, industry and geography as the ones required for the job.
- 3) Salary - whether the expectations can fit within the budget
- 4) Cultural fitment,
- 5) Organizational fitment, Team Fitment, Ramp up time

- 6) Key achievements
- 7) Ask about real-world work examples to evaluate whether they possess the technical knowledge/ exposure/ expertise
- 8) Ask about challenges faced in previous jobs/projects and how they were overcome/mitigated
- 9) Any for instances of failure and learning from them
- 10) Ask to provide a self-evaluation of strengths and areas of opportunity

### **3.1 Resource Performance Evaluation**

We understand that Project success mainly depends on how successful our project resources are in carrying out their job duties. We understand that the onboarding is not the end but the start of the process. Our customer success teams touch base with our clients on 30-60-90-day periods to get candidate evaluation to understand the candidate performance and take necessary steps to enable the candidate if needed.

For each candidate, we request feedback from immediate client supervisor of the candidate on GBSI proprietary 50 point method, involving 10 questions. This feedback takes less than 3 minutes for the manager to complete and gives us objective way of rating performance of the candidate. Any candidate scores below 35 out of 50 , we assign GBSI manager to work with the candidate on improvement plan to increase their score above 40 and ways to keep it above 40.

### 3.2 Quality Assurance during Project Engagement

GBSI team believes that in order to deliver projects and services effectively Audits and assessments are required in very stage of the engagement, not just at the end. With that philosophy, we focus on following levels of Audit.





There may be additional reviews introduced into the quality assurance plan of a project, depending upon client's requirements. 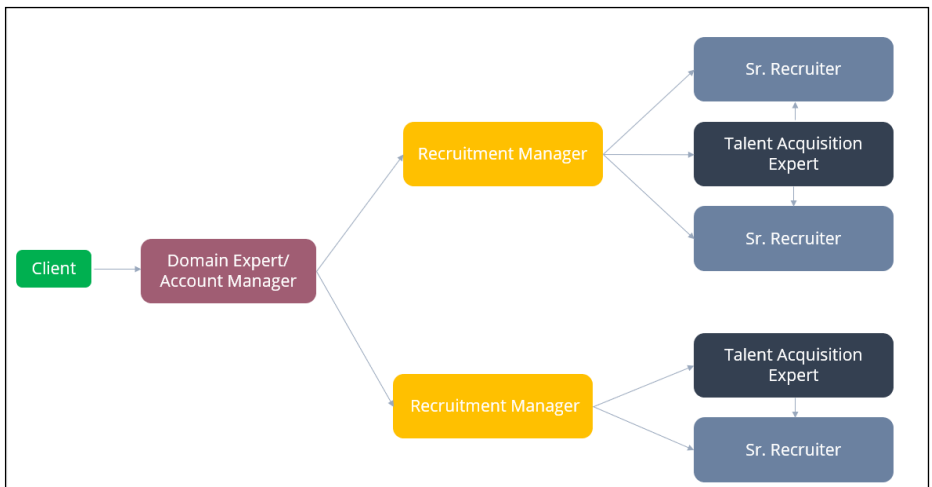

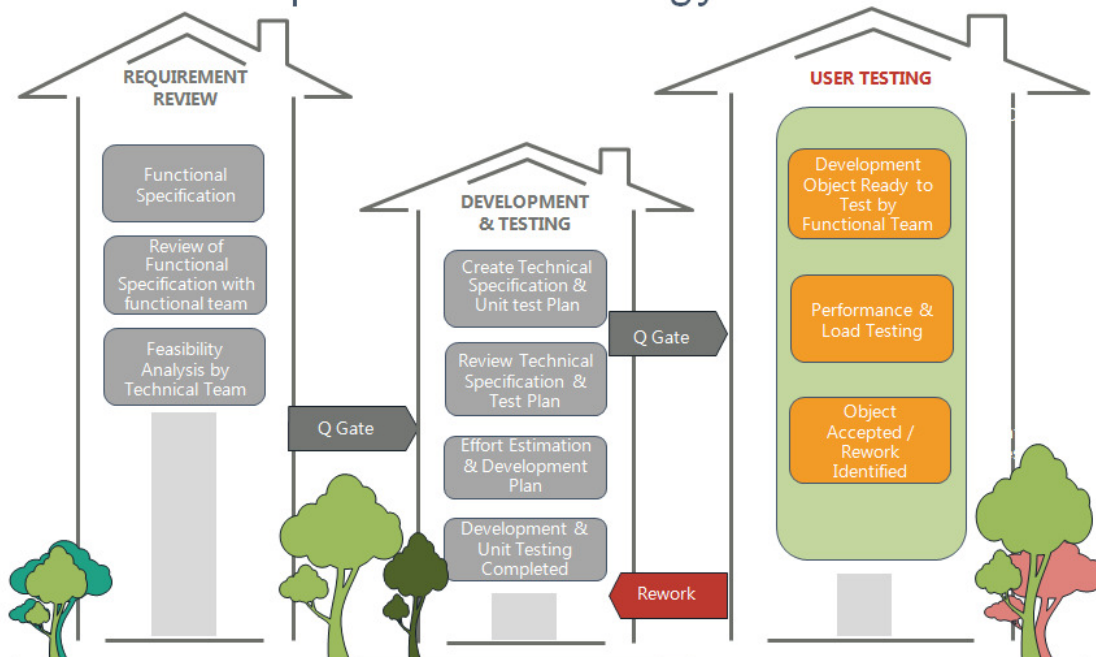
