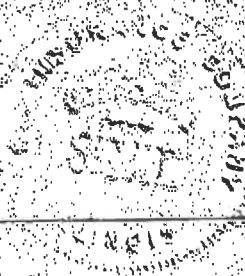

PURCHASING AFFIDAVIT

CONSTRUCTION CONTRACTS: Under W. Va. Code § 5-27-1(f), the contracting public entity shall not award a construction contract to any bidder that is known to be in default on any monetary obligation owed to the state or a political subdivision of the state, including, but not limited to, obligations related to payroll taxes, property taxes, sales and use taxes, fire service fees, or other taxes or fees.

ALL CONTRACTS: Under W. Va. Code § 34-4-10a, no contract or renewal of any contract may be awarded by the state or any of its political subdivisions to any vendor or prospective vendor when the vendor or prospective vendor or a related party to the vendor or prospective vendor is a debtor and: (1) the debt owed is an amount greater than one thousand dollars in the aggregate, or (2) the debtor is in employer default.

DEFINITIONS

Debt means any assessed permit, liability, fire, tax, or other amount of money owed to the state or any of its political subdivisions because of a contract, fee, permit, license, license assessment, assessed workers' compensation premium, permit or other assessment prescribed by the state and required to be paid to the state or any of its political subdivisions, including any interest or additional penalties or other charges.

Employer default means a failure to maintain a liability to the old union or the named employer and/or being in employer default, as defined in W. Va. Code § 23-26-2, failure to maintain liability workers' compensation coverage, or failure to fully meet its obligations as a workers' compensation self-insured employer, an employer who in employer default is not entered into a repayment agreement with the Insurance Commissioner and remains in compliance with the obligations under the repayment agreement.

Related party means a party, whether an individual, corporation, partnership, association, limited liability company, or any other form of business association or other entity whatsoever, related to any vendor by blood, marriage, ownership or contract through which the party has a relationship of ownership or other means with the vendor so that the party will actually be able to recover control a portion of the benefit, profit or other consideration from performance of a vendor contract with the party, including an amount that exceeds five percent of the total contract amount.
