### STATE OF WEST VIRGINIA Purchasing Division PURCHASING AFFIDAVIT

**CONSTRUCTION CONTRACTS:** Under W. Va. Code § 5-22-1(i), the contracting public entity shall not award a construction contract to any bidder that is known to be in default on any monetary obligation owed to the state or a political subdivision of the state, including, but not limited to, obligations related to payroll taxes, property taxes, sales and use taxes, fire service fees, or other fines or fees.

ALL CONTRACTS: Under W. Va. Code §5A-3-10a, no contract or renewal of any contract may be awarded by the state or any of its political subdivisions to any vendor or prospective vendor when the vendor or prospective vendor or a related party to the vendor or prospective vendor is a debtor and: (1) the debt owed is an amount greater than one thousand dollars in the aggregate; or (2) the debtor is in employer default.

**EXCEPTION:** The prohibition listed above does not apply where a vendor has contested any tax administered pursuant to chapter eleven of the W. Va. Code, workers' compensation premium, permit fee or environmental fee or assessment and the matter has not become final or where the vendor has entered into a payment plan or agreement and the vendor is not in default of any of the provisions of such plan or agreement.

#### **DEFINITIONS:**

"Debt" means any assessment, premium, penalty, fine, tax or other amount of money owed to the state or any of its political subdivisions because of a judgment, fine, permit violation, license assessment, defaulted workers' compensation premium, penalty or other assessment presently delinquent or due and required to be paid to the state or any of its political subdivisions, including any interest or additional penalties accrued thereon.

"Employer default" means having an outstanding balance or liability to the old fund or to the uninsured employers' fund or being in policy default, as defined in W. Va. Code § 23-2c-2, failure to maintain mandatory workers' compensation coverage, or failure to fully meet its obligations as a workers' compensation self-insured employer. An employer is not in employer default if it has entered into a repayment agreement with the Insurance Commissioner and remains in compliance with the obligations under the repayment agreement.

"Related party" means a party, whether an individual, corporation, partnership, association, limited liability company or any other form or business association or other entity whatsoever, related to any vendor by blood, marriage, ownership or contract through which the party has a relationship of ownership or other interest with the vendor so that the party will actually or by effect receive or control a portion of the benefit, profit or other consideration from performance of a vendor contract with the party receiving an amount that meets or exceed five percent of the total contract amount.

AFFIRMATION: By signing this form, the vendor's authorized signer affirms and acknowledges under penalty of law for false swearing (*W. Va. Code* §61-5-3) that: (1) for construction contracts, the vendor is not in default on any monetary obligation owed to the state or a political subdivision of the state, and (2) for all other contracts, that neither vendor nor any related party owe a debt as defined above and that neither vendor nor any related party are in employer default as defined above, unless the debt or employer default is permitted under the exception above.

The tabletop exercise was conducted concurrently in 13 separate counties via video telephone conferencing. Nine counties participated, separately but concurrently, in the functional exercise. The functional exercise utilized a common simulation-cell and video-telephone conferencing for coordination and control. The exercises were designed to test the plans, policies, and procedures of the counties within HSEM Regions 1 and 5. SES analyzed the participant and evaluator notes and developed After-Action Reports and Improvement Plans for the Regions.

As a follow-up to the full-scale agriculture movement control exercise conducted in 2009, the MSPSA wanted to use lessons learned from the exercise to bring those practices to the rest of the MSPSA states. This project began with SES conducting a thorough review of authorities related to agriculture movement control for the MSPSA states, plus the surrounding states and Canadian provinces. The resultant product was a compilation of authorities review, the SES team developed a model agriculture movement control permit that could be used in emergency circumstances, either as a stand-alone permit or a supplement to the state's existing permitting system. The team also developed guidance for the states to use in assembling a MOU between border states to use as a guide in developing consistent standards for agriculture movement control during a disease outbreak. SES conducted MOU workshops with participating states, helping to facilitate the MOU process between border states. SES facilitated the development of MOUs between 22 sets of states, including Minnesota and all its border states.

SES developed and delivered county-level agriculture emergency plan development workshops, targeting county emergency management, for the Minnesota Department of Agriculture and the Board of Animal Health. These workshops were delivered to all counties in the southern two-thirds of the state.

SES conducted an FMD vaccination plan development workshop for the KDA. SES took the information developed in the workshop and drafted an FMD vaccine deployment plan for the state.

SES conducted a multi-day planning workshop to update the state's FAD plan and develop both a food contamination and a plant disease/pest emergency response plan.

SES has worked with KDA on the following exercises:

- From 2016 to 2019, SES has supported KDA FEs by managing the simulation cell and supplying simulators.
- From 2009 to 2015, SES designed, conducted, and reported on four multi-day FEs between KDA and various Emergency Management Regions throughout the state.
- Worked with key border counties in Kansas to develop animal movement control and temporary housing plans.
- Worked with KDA and all its bordering states to develop animal movement control MOUs.
- Designed, implemented, controlled, evaluated, and reported on an animal stop movement full-scale exercise for KDA and the ODAFF.

1. It was not clear in the RFP if a technical proposal or statement of qualifications was needed to accompany the cost proposal. How does West Virginia want proposers to show their proposed staff meet the qualifications stipulated in Section 3.1, *Qualifications*, of the RFP?

Vendor must provide the following information for 3 customers for whom they have completed similar plans for. Name of agency, point of contact for agency with whom the vendor worked with, e-mail address and phone number and a one-page summary of the work completed

2. In the *Instructions to Vendors Submitting Bids*, Section 6, *Bid Submission*, the number of "convenience copies" was not indicated. How many "convenience copies" are required for a valid submission?

This is an RFQ. No convenience copies are required.

- 3. In the *Instructions to Vendors Submitting Bids*, Section 41, *Background Check*, it is specified that the successful contractor will incur the costs of all staff background checks. Will the Division of Protective Services require the successful contactor's staff to undergo these background checks? This may be a requirement as defined in the terms and conditions.
- 4. Under the *Instructions to Vendors Submitting Bids*, Section 45, *Prohibition Against Used of Refurbished*, is recycled photocopier paper included in the used or refurbished prohibition?

No.

5. Under Section 1 of the Specifications Section, the FAD Plan and FMD Annex resulting from this contract are required to meet or exceed the requirements of United States Department of Agriculture's FMD plans. In some cases, it is possible that West Virginia may choose to deviate from recommendations to account for state-specific policies or capacities. Will this level of variance be allowed?

Yes, WV could deviate from USDA's plans. Depending on the severity of the deviation and how that deviation will affect WV's ability to implement will be discussed and decided as the plans are developed. Vendor needs to consider the USDA plans as a minimum for the initial phase of development.

Yes, both would be considered acceptable.
