VeriTrace operates under the ANSI accredited security standards and protocols of NASPO, maintaining a Class II Certification.

The VeriTrace facility has multiple layers of security intended to deter and prevent unauthorized access, and to provide security for our products and employees.

- The exterior of the facility is surrounded by metal fencing with only three controlled access points.
- Directly inside of the perimeter fencing are six light curtain beams that provide full coverage around the facility.
- VeriTrace facility is monitored 24/7.
- All entrances are controlled by a restricted key-card access system.
- All Fire Doors have break-alarms that sound if they are opened either from the inside or outside.
- A total of 26 motion-activated cameras record the exterior and interior of the facility, 24 hours a day.

- All non-employees who enter the building are required to provide a valid driver's license or state issued ID. A photocopy is made and kept on file. Visitors are also required to complete a Visitor Sign-In Sheet, even if he or she is a returning guest.

- All visitors remain with a designated escort if the need arises to be in the production area. While in the production area, no visitor is permitted to view any in-process materials or to stray from the designated path through the plant. VeriTrace employees maintain the security culture.
- All VeriTrace employees undergo a criminal background check, as well as pre-employment drug testing.
- A picture of every employee, along with a copy of his/her fingerprints are kept on file.
- All employees are required to sign a Non-Disclosure Agreement preventing them from discussing any customer or project information with non-approved persons, including other VeriTrace employees
- Every employee undergoes extensive security training, reviewed annually, based on the requirements of NASPO, to ensure that VeriTrace continues to maintain the appropriate security culture essential to the protection of our customers, and their products.
- No backpacks, purses, cellphones, cameras or other recording devices are allowed in the production area.
- VeriTrace implements strict inventory control of both raw materials and finished product.
- All raw materials are stored within VeriTrace's secure material storage area until needed for production. At that time, only an employee with access to that area moves the materials for production.
- All printing plates are made in-house, under strict security controls, in order to provide another level of protection for our customers and their products.
- Any inks not commercially available are mixed in-house by appropriate personnel.
- All raw materials consumed in production are recorded real time via VeriTrace's ERP Manufacturing System.
- All unused material is returned to secure storage and quantities verified immediately following production completion.
- All work-in-progress material is securely stored when not active in production, including end-of-day.
- All secure production waste is stored in VeriTrace's secure Shred Room until destroyed. Secure waste is either shredded on-site and then recycled or escorted to an off-site incineration facility where the incineration is witnessed by appropriate VeriTrace personnel.
- All Finished Goods are stored within VeriTrace's 18,000 cubic ft Class 5 vault. VeriTrace's vault is a dual-access entry requiring both an alarm code and lock combination. No single employee has the ability to disarm and unlock the vault. Finished Goods remain in the vault until shipment.

VITAL RECORD SECURITY FEATURE DEFINITIONS


- 01 Engraved Intaglio Printing**
Fine line border printed via intaglio process as used in currency and other high security printing through the use of steel engraved plates. Intaglio printing has a recognizable raised, tactile property that cannot be replicated by any other printing method or electronically reproduced by photocopiers or scanners.
- 02 Engraved Intaglio Latent Images ("V" and "R")**
The letters "V" (Vital) and "R" (Record) are hidden in the corners of the top border. These are part of the engraving and are viewed when laying the document flat at eye level in natural light.
- 03 Engraved "Vital Record" Micro-Print Line**
Also forming part of the engraving is a continuous, repeated micro-line of the legend VITAL RECORD along the interior of the bottom border. This micro-line is only legible under a magnifying glass and will appear as a straight blurred line when copied.
- 04 Engraved CERTIFICATION OF VITAL RECORD Outlined Text and State Name (optional)**
As an integral part of the engraved border this outline text enhances document recognition and authenticity.
- 05 Engraved State/County/Departmental Seals**
State Seals, County Seals and Departmental Seals can be included as an integral part of the engraved border. The raised feel of these seals assist in document recognition and authenticity. These are recommended in preference to embossed seals that are easily replicable.
- 06 "Void" Copy Background**
The hidden word "VOID" forms part of the anti-photocopy background. When color copied, the word "VOID" pops thereby deterring the forger from attempting to use copied documents as counterfeits.
- 07 Prismatic Print**
By dividing the press inking fountain by color, the printer can create a background of varying colors which merge gradually from one to another. Color copiers and scanners have difficulty resolving these subtle color migrations.
- 08 Screened State/County/Departmental Seal**
The State, County or Departmental name is imprinted as a screened image on the face of the document.
- 09 Erasure Sensitive Inks**
The erasable ink is sensitive to mechanical abrasion. Attempts to mechanically remove data will remove the printed ink also, thereby evidencing tampering of the document.
- 10 Sequential Control Numbering & Barcoding**
Each document is sequentially numbered or sequentially bar-coded for inventory/audit and issuing/tracking purposes.
- 11 Watermark Security Paper**
Paper with two tone Fourdrinier security watermark depicting "Stars & Stripes" flag and the words "OFFICIAL VITAL RECORD" in repeated and continuous format running diagonally down the sheet left to right.
- 12 Security Fibers**
Security fibers are difficult to reproduce. The security fibers are embedded in the paper during the manufacturing process and fluoresce under ultraviolet light.
- 13 Optically Dead, Chemically Sensitive Security Paper**
Optically dead security paper permits the inclusion of ultraviolet (black light) reactive security features. In addition, the paper is sensitized to those families of chemical agents such as: oxidants (i.e. bleach), solvents (i.e. Acetone), alcohol (i.e. methanol), and acids/bases (i.e. sulfuric acid) which are commonly used by forgers to alter personalized information. Use of these agents will cause noticeable stains to appear the instant anyone attempts to alter the document.
- 14 Paper Treated With Laser Toner Retention**
Paper is surface treated to significantly enhance toner adhesion during laser printing. The heat from the laser printer activates a chemical reaction that fuses the toner to the paper. This feature protects documents against fraudulent alteration by frustrating attempts to remove or scrape the printed area.
