Roy Hampton, architectural historian, has more than 20 years of professional experience working with Midwestern history and architecture.

Hampton directed the Phase I and Phase II History/Architecture surveys for the Ohio Department of Transportation I-71/70 split improvement project in Columbus, Ohio. Hampton participated in the Phase I History/Architecture Survey for the Cleveland Innerbelt. He also conducted the architectural survey of the Jarvis Hunt–designed Beaux Arts buildings and cultural landscape at Naval Station Great Lakes in Chicago, Illinois. Hampton has completed over 100 Ohio Historic Inventory forms. He co-wrote *The Historic Context Report for the Ohio Department of Highways Bureau of Bridges, 1911–1945*. Hampton also wrote *The Historic Context for Evaluating Mid-Century Modern Military Buildings* for the Department of Defense, which provides guidance for the National Register evaluation of Modernist buildings built from 1950–1975. Hampton co-authored the successful National Register district nomination for Rockefeller Park and the Cleveland Cultural Gardens, and he wrote and listed the Gambier Historic District in Mount Vernon, Ohio, in the National Register in March 2000. The Gambier Historic District consists of residential and downtown commercial contributing buildings ranging from 1826–1949. Hampton also wrote the National Register nominations for the Wright Field Historic District and the Wright Brothers Memorial at Wright-Patterson Air Force Base, which are currently pending federal review. Hampton completed the HAER documentation of the National Historic Landmark listed NASA Rocket Engine Test Facility in Cleveland, Ohio, prior to its demolition, and co-researched and co-wrote the nationally significant Hanford Village George Washington Carver Addition Historic District nomination. Most recently, Hampton co-wrote the successful National Register nomination for the Theresa Building in Columbus, Ohio. Hampton also co-wrote African American themed Theresa Building, the Edna Building and the Franklin Park Medical Center. Hampton is a co-author of the National Register Multiple Property Document form *Twentieth-Century African American Civil Rights in Ohio*.

Hampton has a master's degree in art history from the University of Louisville and has participated in the National Preservation Institute's Identification and Evaluation of Mid-Twentieth Century Buildings training. He exceeds the Secretary of the Interior's Professional Standards for architectural history and history and is included in the Ohio Historic Preservation Office's prequalified consultants list.

Rory Krupp, Historian

Rory Krupp, the principal of Owen & Eastlake, has more than 20 years of experience in cultural resource management. Krupp has worked in Alabama, Florida, Indiana, Illinois, Idaho, Ohio, Maryland, Nevada, North Carolina, Pennsylvania, Tennessee and West Virginia. He is the lead historian and co-author of the National Register Multiple Property Document form *Twentieth-Century African American Civil Rights in Ohio*. He wrote the historic context for the Phase II history-architecture survey of the Cleveland Innerbelt. Krupp researched and contributed social, economic and cultural landscape histories of the North Lot Union Village Shaker settlement for an Ohio Department of Transportation monograph series. He has researched and written five historic property management plans for the United States Army Corps of Engineers.

Krupp researched and co-wrote the statewide National Register Multiple Property Document *Twentieth-Century African American Civil Rights in Ohio, 1900–1970*. The project located new sites associated with civil rights, identified new site types, and laid out National Register evaluation guidelines for the new types.

Krupp co-researched and co-wrote the historic district nomination for the nationally significant Hanford Village George Washington Carver Addition Historic District in Columbus, Ohio. He researched and co-authored the National Register nomination for the Theresa Building in Columbus, Ohio. The Theresa Building is a 1925 Mission-style professional building constructed by and for black professionals during the Great Migration; it was listed in the National Register in June 2015.

Krupp also researched and wrote the successful National Register nomination for the Edna Building, a 1903 mixed use building that housed black-owned businesses. Krupp also researched and wrote the National Register nomination for the Franklin Park Medical Center listed in 2016 and was significant for ethnic history and civil rights.

Recently, Krupp wrote an article pending publication by the *Journal of Ohio Archaeology* that explores politically driven changes to the cultural landscape at Serpent Mound State Memorial and their resultant effects on the park's archaeological deposits.

Krupp has a master's degree in American history with a certificate in historic preservation from the University of Cincinnati. He has completed the following National Historic Landmark program webinars: *Writing Section 8 for Criteria 1 & 2; NHL Nuts and Bolts; National Register or National Historic Landmark; Understanding Cultural Landscapes; Writing Section 8: Archaeology; Writing Section 8 for Criterion 4: Architecture; Preparing for the Landmarks Committee Meeting; and Writing Section 7 and Evaluating Integrity for Criteria 1, 2, 4 and 5.*

SELECTED PROJECTS

Department of Defense Legacy Grant, *Historic Context for Evaluating Mid-Century Modern Buildings* (2012). Funded by a Department of Defense Legacy Grant, Hampton wrote an illustrated guide to the National Register inventory and evaluation of Department of Defense buildings constructed during the Cold War era. The property covered a wide variety of Cold War building types, including air facilities, laboratories, and base support facilities. The guide was uploaded to the Department of Defense legacy website where it is still available for use.

Integrated Cultural Resource Management Plans for Naval Facilities Engineering Command, Mid-Atlantic (2010). Hampton managed this project to establish cultural resource management plans at the Portsmouth Naval Shipyard in Maine and the Navy Yard Annex and Naval Support Activity in Philadelphia. The project included developing a new format for the management plans, completing building and landscape feature surveys, and writing three programmatic agreements. The project also included GIS mapping and completion of state historic inventory forms. Part of the work was to inventory and evaluate Cold War-era resources constructed as these bases continued to develop from the end of World War II through 1991.

Mitigation of Naval Weapons Industrial Reserve Plant Bloomfield (2009). Hampton managed this project to provide mitigation for a Cold War-era helicopter factory and research center that the Navy was transferring to private ownership. The Bloomfield plant was built by the U.S. Navy and used by the Kaman Aerospace Corporation; Kaman developed several major advances in helicopter technology at the site during the 1950s and 1960s. The project involved Connecticut state-level documentation of the plant, including photography of the site and a written report. The central mitigation item of the project was a softcover book on the history of the plant and the Kaman Aerospace Corporation that was later distributed by the Connecticut Commission on Culture and Tourism. Hampton worked with professional graphic designers and specialists in industrial and technological history to develop the book and the state-level documentation.

Historic Facilities Inventory and Evaluation at Eglin Air Force Base, Florida (2006). Hampton managed this project to inventory and evaluate over 60 resources at the main base and at outlying test ranges at Eglin. The project included researching the history and significance of each building and structure and filling out Florida historic inventory forms. Resources surveyed included World War II buildings and a 1950s rocket test range. The results of the survey and inventory forms were accepted by the Florida State Historic Preservation Office. Many of the properties evaluated were Cold War resources that had recently reached the fifty-year mark.

Historic Building Survey, Marine Corps Air Station, Miramar, California (2006). Hampton was Senior Historian in this project that inventoried and assessed over 400 buildings constructed between 1941 and 1989 to prepare a comprehensive and updated survey of the base. Many of these facilities were Cold War-themed properties. The project included maps that coordinated with the base GIS system as well as literature reviews conducted at repositories in Washington, D.C., and California.

Historic Cold War Building Survey Updates, Wright-Patterson Air Force Base, Ohio (1998-2008). Hampton was project manager on several efforts to inventory and evaluate Cold War properties at or near the fifty-year mark at Wright-Patterson. Notable resources evaluated included a large early-1950s steel-frame hangar that served as a Cold War fighter alert facility, and a later Cold War bunker that originally functioned as a flight crew alert facility. Other building types included warehouses, administrative facilities, and utility buildings.

HABS Documentation of Building 600, NEACP Alert Facility, Grissom Air Reserve Base, Indiana (2005). Hampton completed the HABS documentation of this 1986 structure that was originally used as an alert facility for the National Emergency Airborne Command Post (NEACP). The facility housed an aircraft crew that in the event of a nuclear war could serve as an airborne command post for the U.S. Armed Forces. The building is an effective representation of the Cold War—era threat of nuclear war and the U.S. military’s response to this threat.

Multiple National Register Eligibility Inventory and Evaluation Projects, Tinker Air Force Base, Oklahoma City (2001-2008). Hampton was project manager and field team leader on several efforts to inventory and evaluate buildings at Tinker AFB that were at or near the fifty-year mark. Most of these facilities were Cold War-era facilities and included hangars and other flightline buildings, warehouses, and utility buildings. A multi-building Cold War-era alert facility station from the 1950s, located in a remote area of the base, was one of the properties inventoried and evaluated.

National Register Evaluation of Nike Missile Battery, Cleveland Burke Airport (2009-2010). Hampton supervised a team of architectural historians and planners in an effort to complete a National Register evaluation of a repurposed Nike missile battery at this small airport. The complex included multiple buildings constructed during the Cold War era. Hampton oversaw the project, edited the report, and reviewed and had final approval of the National Register eligibility evaluations for the project.

Inventory of Boardman Bombing Range, Idaho (2008-2009). Hampton directed a project to inventory and evaluate Cold War-era buildings, structures, and landscape features at this Air Force bombing range that was more recently taken over by the U.S. Navy. In researching the history of the site and its connection to strategic B-52 bomber units at Fairchild Air Force Base, Hampton determined that one surviving building had been a training facility for B-52 anti-aircraft gunners, but recommended that the building was too altered to be eligible for the National Register. The Idaho State Historic Preservation Office concurred with the recommendations, and completion of the project cleared the way for demolition of several deteriorated buildings that posed safety hazards.

Phase I and II Surveys for I-70/71, Columbus, Ohio (2006). Hampton assessed the National Register eligibility of more than 400 buildings as part of a large highway interchange study. The project included evaluation of buildings that had not been previously surveyed, as well as identification and reassessment of contributing and non-contributing properties in several National Register and City of Columbus local historic districts.

National Register District Nomination, Rockefeller Park and the Cleveland Cultural Gardens, Cuyahoga County, Ohio (2005). Hampton co-authored a National Register District Nomination covering Rockefeller Park, a major urban park space that is an excellent example of the Victorian Picturesque landscape style. The nomination also included the Cleveland Cultural Gardens, a series of landscapes within the park that commemorate Cleveland's ethnic diversity. The district was successfully listed in the National Register in 2005.

National Register Nomination, Village of Gambier, Knox County, Ohio (2000). Hampton surveyed over 150 buildings in the Village of Gambier and listed the village in the National Register of Historic Places. The new Gambier historic district included the village's significant commercial and residential properties as well as an existing National Register historic district covering the Kenyon College campus.

Quinn Chapel A.M.E. Church (Individual Nomination)

Owen & Eastlake researched and prepared an amended nomination for the [Quinn Chapel A.M.E. Church](#). The clients, Develop Louisville and the Louisville Metro government, received a grant from the Department of the Interior and the National Park Service's African American Civil Rights Historic Preservation Fund. The City of Louisville wanted to recognize the Quinn Chapel's role in the civil rights movement.



While the Quinn congregation had a storied role in Louisville's civil rights movement from the 1870s through the 1960s, Owen & Eastlake focused on a particular episode when the chapel served as a mass meeting place for those opposed to segregative zoning requirements instituted in Louisville during the early 20th century. In 1914–1915, the nascent NAACP combined forces with Louisville's civil rights leaders to fight the new zoning ordinance, financing the court battle through mass meetings held at Quinn Chapel. The court case, *Warley v. Buchanan*, went to the Supreme Court in 1917, and Louisville's ordinance was overturned. This marked the beginning of using mass meetings in churches to finance and gain support for national civil rights cases. For its role in the process Quinn Chapel was listed in the National Register in June 2020 with national significance. Funded by the National Park Service, Department of the Interior, African American Civil Rights Grants program.

George Washington Carver Addition (District Nomination)

The [George Washington Carver Addition Historic District](#) is an African American World War II veterans' preference suburb in Columbus, Ohio. Consisting of 90 buildings and a city park in a discontinuous district, the George Washington Carver Addition Historic District was listed under Criterion A. The veterans' preference subdivision was built in 1946–1947 in spite of substantial community opposition. The development was already well known for being the home of many Tuskegee Airmen based in Columbus, Ohio.

However, research by Owen & Eastlake revealed that the subdivision was also used by the Federal Housing Administration to market minority loans across the country. The FHA noted in speeches and marketing materials that Carver Addition loans were paid promptly, and, contrary to contemporary opinion, the development had not sunk into blight.

Owen & Eastlake's research also identified another chapter in the Tuskegee Airmen story, detailing how just as the Airmen had broken barriers in wartime Europe, they continued to do so after the war. In addition to extensive research, Owen & Eastlake conducted community meetings and interviewed residents.



The district was listed under Criterion A with national significance in 2013 not only in community development, the original intended theme, but also in civil rights. It is a featured case study in the Ohio State Historic Preservation Office's statewide historic preservation plan, *A Historic Preservation Plan for Ohioans, 2016–2020*.

The Theresa Building (Individual Nomination)

The Theresa Building is a 1925 Spanish Colonial Revival–Mission Style building that incorporates design elements common after the 1915 Panama Exhibition. It was nominated under Criterion A for its role as an African American professional building constructed during the Great Migration. It was also nominated under Criterion C as an example of a 1920s vernacular office space with high integrity.



The Theresa Building unanimously passed the Ohio Historic Site Preservation Advisory Board in March 2015 and was listed in the National Register in June 2015. The project was funded by the Ohio Department of Development using a Historic Tax Credit Pipeline Initiative Grant. This grant program funds the nomination of buildings that could benefit from federal and state historic tax credits in the future.

Franklin Park Medical Center (Individual Nomination)

The Franklin Park Medical Center is a mid-century modern medical practice constructed in 1962.

Built by a group of African American medical specialists, the building provided much-needed specialized care to the black community. Because of their race, the founders experienced hurdles in obtaining land and financing. However, over the course of several years, the building was constructed with out-of-town loans and was subsequently a focal point for community health until the 1990s.



The Franklin Park Medical Center was listed in the National Register in 2016. The areas of significance are ethnic history, health/medicine, and social history. The project was funded by Ohio Department of Development using a Historic Tax Credit Pipeline Initiative Grant and administered by the City of Columbus Land Bank and the Franklin County Land Bank.

Approach and Methodology

Survey Objectives

The survey objectives are to identify any Readiness Centers (armories) and Federal Maintenance Shops (FMS) that are eligible for the National Register of Historic Places. The survey will also record and evaluate all resources in the Readiness Center and FMS complex.

The survey will consider significance of the readiness centers under National Register criteria A, B, C, and, where applicable, D. Criterion C architectural significance will be considered. However, as standard-plan military buildings, the survey team does not anticipate that Criterion C architectural and engineering significance will be a large factor in the evaluations for most of the buildings

It is possible that some of the facilities have Criterion A historical significance in association with Cold War themes and events. Criterion A is anticipated as the criterion that will most likely be cited if facilities are recommended as eligible for the National Register.

It is also possible that some of the buildings of complexes could be eligible for the National Register under Criterion B for association with persons important in history. Criterion D is normally not cited for buildings or complexes except in unusual circumstances where the building or facility has potential for revealing new historical information.

Also under National Register Criterion D, the survey will also identify and document potential archaeological resources based on archival research or previous documentation. These will be recorded separately. No archaeological testing or other ground disturbance will be performed as part of this project. All archaeological potential will be evaluated via historical records and other documentation, and visual observation of surface features during fieldwork.

The Readiness Center and the associated features will be mapped to sub-meter accuracy with the federal GIS template and corrected locational data.

Geographical Description

The seven Readiness Centers are located throughout the State of West Virginia. The facilities are in both rural areas and suburban/industrial areas within urbanized territory. The field team anticipates that a variety of maps, deed records, and other resources will be consulted depending on whether the Readiness Center being evaluated is part of an urban or rural context. The field team will also interview past and present building occupants.

Research Design and Methodology

The Owen & Eastlake team, Rory Krupp and Roy Hampton, will conduct archival research at the:

West Virginia Division of Culture and History

County historical and public libraries near each Readiness Center

Previous research and reports supplied by the West Virginia National Guard.

University libraries, federal repositories, and newspapers databases will also be utilized.

It is anticipated that readiness centers in a rural context will be documented via county real estate atlases, aerial photographs, county or local histories, and deed and other historic real estate records. Survey properties in urban and suburban areas will benefit from review of the above sources, plus resources unique to the urban context such as Sanborn maps. Newspaper articles and local history accounts, if relevant, may shed light on the history and development of both urban and suburban resources. National Guard records such as unit histories will also help to document the significance of both urban and rural readiness centers.
