





Central bathing rooms are located on each floor in the core of the building, for use by two nursing neighborhoods.

The resident rooms have bathrooms with a European-style shower, toilet, and a sink. Neighborhoods have the required soiled and clean utility rooms, clean linen, general storage, and equipment storage rooms. Resident rooms are heated and cooled using an electric through-wall packaged thermal air conditioner (PTAC).



Additional main program spaces include a physical therapy gym, multi-purpose room, administrative office suite, beauty/barber shop and laundry room. Support spaces will include a kitchen, mechanical rooms, receiving, trash, and an employee break room. Project Type New

The PA Soldiers' and Sailors' Home, built in 1886, is a 175-bed nursing and domiciliary care facility set on a 26-acre campus overlooking Lake Erie. The H.F. 




