

NetZero USA hereby warrants to the below listed Lighting Owner(s) that; (i) all Lighting Products shall substantially conform within industry tolerances to their published specifications for the period(s) listed under "Product Warranty Period Enumeration" on page two of this document, provided they are installed in accordance with the manufacturer's instructions and specifications, from and after the date on which the Property Improvement Work is completed (the "Warranty Date") by NetZero USA. or from and after the date on which the Lighting Products were sold to the Lighting Owner (in cases where NetZero USA did not install the Lighting Products). NetZero USA further warrants that it will repair or replace, at no cost to the Lighting Owner(s), any Lighting Product that does not comply with this warranty, subject to the terms and conditions herein. In lieu of repair or replacement, NetZero USA may, at its option, refund the purchase price of the Lighting Products that do not conform to this warranty. THIS WARRANTY IS EXCLUSIVE AND IS IN LIEU OF ALL OTHER WARRANTIES, EXPRESSED OR IMPLIED, INCLUDING, BUT NOT LIMITED TO, ANY IMPLIED WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR USE AND/OR NON-INFRINGE-MENT, AND NetZero USA HEREBY EXPRESSLY DISCLAIMS ALL SUCH OTHER WARRANTIES.
