
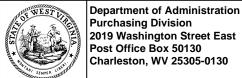

Section 1: INTRODUCTION

Dataview Consulting LLC is pleased to present this proposal to the West Virginia Enterprise Planning Board to provide Nightly Cycle Services and Staff Augmentation services.

wvOASIS project has been live since Fiscal year 2015 when both the ERP Vendor and Dataview had been supporting the operations of wvOASIS. Since 2016 Dataview filled the vacant positions and took full responsibility of supporting the wvOASIS technical team with the technical tasks of wvOASIS. Currently the Dataview Technical team augments the State of West Virginia Technical Staff in the maintenance and operations of Financial, HRM/Payroll and Vendor/Employee self-serve ERP System. Dataview provides distributed team operational staff, Application Developers, Functional Domain experts, BI Architects and Application Technical architects who provide 24/7 operational support of the Statewide Financial ERP System, including running of the nightly batch cycles, design and development of custom applications for State Agencies, design and develop data warehouse solutions and BusinessObjects reports and universes as well as Microsoft Power BI.

Our understanding of the scope of this proposal is for the Dataview team to provide the same services as it currently does in both operational tasks and staff augmentation.

Additionally, Dataview will work with the State management team to identify other staffing needs and timelines in order successfully staff and implement additional project initiatives in an efficient manner and without any disruption to the State conducting its business using wvOASIS.

2.2. PROPOSAL

2.2.1 Scope Summary

The Dataview team has the institutional knowledge and know-how to provide the services listed in this RFQ. Dataview is committed to providing resources who have a deep understanding of the ERP products as well resources who are familiar with West Virginia business processes that no other vendor can match. Dataview is proposing the following services in this proposal:

2.2.1.1 Nightly Cycle Support

Dataview will provide experienced resources for the execution of the Nightly processes for production and non-production cycles at a fixed price as show in the pricing spreadsheet. The nightly operations consist of running the various nightly cycles as well as monitoring nightly scheduled jobs. The cycles will continue to be executed by offsite team members to take advantage of the 24x7 operations window. **Exhibit 1** describes the specifics of the nightly cycles and the scope of support.

2.2.2 Staff Augmentation

2.2.2.1 Technical & Operational Support Staff augmentation

The Technical and Operational Staff will augment the State Technical team and provide support to the system software, application software and 3rd Party software required for the operation and management of the wvOASIS Enterprise IT environment.

The application support will include the following activities:

- Assist State Functional and Technical Team in Design and Code Review
- Assist State Developers with Budget, FIN and HRM development
- Assist in troubleshooting Production issues
- BIRT Forms Printing Software upgrade and configuration
- 1099 Convey Printing Support
- Troubleshoot ECM and ePay Integration
- InfoAdvantage ETL and infoAdvantage Data Warehouse

The support will include the following major components of the wvOASIS ERP system:

- JBoss Application Server and HTTP Servers
- JIRA
- SOS Job Scheduler
- BIRT
- BusinessObjects
- Pervasive Data Integrator

In addition, to the software components listed above, Dataview will provide Technical Architects and Subject Matter Experts to support the various wvOASIS Applications. As part of the support services, Dataview will provide support for the following applications:

- Business Intelligence
- Data Warehousing

Dataview will provide the following additional services to support the application including:
