

The Axis cameras included in the RFP are among the best in the industry. Axis cameras are consistently ranked at or near the top of the video surveillance industry; they have become the industry standard by which all others are judged.

Similarly, Salient NVRs and Video Servers are consistently ranked at the top of the video surveillance industries. The combination of Axis cameras and Salient servers is a truly an Enterprise solution that will provides customers with performance, ease-of-use and durability.

Salient offers an open platform architecture that is scalable as increased needs arise. Salient has three versions of software. Their Pro Edition is tailor-made for the demands outlined in the RFP. The Pro Edition is designed for organizations with multiple locations and can support unlimited cameras; unlimited clients and free web and mobile clients.

Accordingly, ADT Commercial Security has elected to offer a Salient video server solution as an alternative to the Axis server specified in the RFP. We believe this combination of products will best serve the State of West Virginia Treasurers' Office.

The Axis camera station appliance specified in the RFP cannot achieve 90 days of storage at 30 ips (images-per-second) for the camera count at each location without increasing the hard-drive to 64TB. The Axis server identified in the RFP is a quality NVR best suited for smaller applications.

The Salient server configurations and statistics documentation provided with ADT's proposal demonstrates that our solution meets the requirements specified in the RFP.

In order to provide a true and accurate price comparison with ADT's Salient server solution, an Axis solution must provide a similar server configuration demonstrating that the Axis server is equipment with sufficient additional storage to achieve the required 90 days of storage at 30 ips. Otherwise, the reader may not be comparing equal solutions and therefore cannot accurately evaluate the two solutions from either a performance or pricing stand-point.
