Sir/Madam:

I found the bid for the purchase of ATT First Net Wireless routers for the state of West Virginia too late to ask questions. I am bidding using the IBR900 CradlePoint Device and the IBR650C CradlePoint Device.

The problem is that the 2 requested CradlePoint devices are sold as packages which include the router and the software to manage the routers (NCM).

First, I will discuss the IBR900.

- The IBR900 is sold for the Mobile Market and for the IOT Market. I have made the assumption that you are interested in the Mobile SKUs as these versions of the IBR900 do not come with power supplies or antennas. The IOT versions do come with power supplies and paddle antennas.
- The management software functionality is also different. Please see 'NetCloud Features for Mobile & IoT' at the following URL: <u>https://cradlepoint.com/product/endpoints/ibr900/</u>. There is also advanced functionality which may be seen using the above link.
- The next difference is the duration the software is valid for. The Mobile SKUs are available in 1 year, 3 year, and 5 year packages. The IOT SKUs are available in 3 year and 5 year packages. Each of these SKUs is also available with the advanced functionality.
- I have included a spreadsheet, 'CradlePoint Options Pricing', which includes my pricing for each of the above differences.



Next, I will discuss the IBR650C.

• The IBR650C is an IOT Device. The only difference is the duration the software is valid for. The SKUs are available in 3 year and 5 year packages. These packages are also available with the advanced functionality.

If I had been aware of this bid prior to the end of question period, I would have asked these questions. But as previously mentioned, I found out about this bid on Tuesday, 7/11/23.
