

PURPOSE AND SCOPE: The West Virginia Purchasing Division is soliciting bids on behalf of WVDOH Equipment Division to establish a contract for the one-time purchase for a quantity of (4) four Virage VS600M or equal truck driving simulator with snow plow. VS: Virage Simulation is the sole manufacturer and distributor of the Virage VS600M truck driving simulator. We are proposing the specified brand and model.
- 2. **DEFINITIONS:** The terms listed below shall have the meanings assigned to them below. Additional definitions can be found in section 2 of the General Terms and Conditions.
 - **2.1 "Contract Item"** means the list of items identified in Section 3.1 below and on the pricing pages.
 - 2.2 "Pricing Page" means the pages, contained in WV OASIS or attached as Exhibit A, upon which Vendor should list its proposed price for the Contract Items.
 - 2.3 "Solicitation" means the official notice of an opportunity to supply the State with goods or services that is published by the Purchasing Division.
 - 2.4 "PSI" means an abbreviation Pounds per square inch.
 - 2.5 "Total Bid Price" means the sum of the bid total column.
 - 2.6 "HP" means horsepower.
 - 2.7 "RPM" means revolutions per minute.
 - 2.8 "MM" means Millimeter.

3. GENERAL REQUIREMENTS:

3.1.1.8 Three channel visual system, 180 degree forward field of view using 55 inch LED 4K, with a minimum 3840x2160 pixel high resolution displays.

- 3.1.1.9 Shall have additional 60 degree (out of driver window view) inset in left display for angle parking and alley docking.

 VS: Yes compliant.
- **3.1.1.10** Simulation of the adjustable left and right side mirrors both standard and convex on each side.

VS: Yes compliant.

3.1.1.11 Shall have adjustable tilt, height steering wheel with adjustable active force feedback to match selected vehicle to mimicking real vehicle steering wheel operation.

VS: Yes compliant.

3.1.1.12 Shall have High fidelity 5.1 3D surround sound.

VS: Yes compliant.

3.1.1.13 Shall have multiple tractor semi trailer configurations including flatbed, tanker, straight truck, dump truck.

- 3.1.1.14 Shall have changeable driving situations such as different terrains, elevations, asphalt, snow and ice, city, urban, expressways, highways, mountainous roads, practice field and CDL testing area. VS: Yes compliant.
- **3.1.1.15** Shall have 3 axis motion/vibration system to give a real feel driving simulation. VS: Yes compliant.
- **3.1.1.16** Shall have a CDL proficiency-based training programs including shifting, backing, turns, coupling procedures, air brake pre trip inspection and skill assessments.

- 3.1.1.22 Unit shall not require an internet connection for normal operation. VS: Yes compliant.
- 3.1.1.23 Simulator unit shall be a maximum of 72 inches by 98 inches and be open operator station design. VS: Yes compliant.
- 3.1.1.24 Operator station and electronic cabinet shall be a maximum size of 42inches by 26 inches by 58 inches.

 VS: Yes compliant.
- 3.2 Snowplow training program shall be provided with truck simulator, the mandatory requirements are listed below.
 - 3.2.1 Snow plow controls shall be certified power solutions

 Freedom XDS. VS: Yes compliant. Virage will include the Freedom XDS power controller plus the other simulated controls, selectable from the
 - **3.2.2** Simulation of spreader, left, right or rear shall be configurable by the instructor. VS: Yes compliant.
 - **3.2.3** Shall have Instructor selectable configuration of front plow and wing plows. VS: Yes compliant.
 - **3.2.4** Sound and motion cues shall correlate with snow plow's position. VS: Yes compliant.
 - 3.2.5 Vehicle performance shall be affected by the amount of snow being pushed. VS: Yes compliant.
 - **3.2.6** Stopping, backing up and replowing a given area shall be allowed. VS: Yes compliant.
 - 3.2.7 Shall have visible road lines in the mirror allowing driver to assess the vehicles lane position. VS: Yes compliant.

Note: As two simulators are installed in each location, the two simulators will be able to train in the same visual environment and scenario using the Virage Multi-sim Operator Station feature. This is great for snowplow echelon training.

3.2.8 Shall include snowplowing city, snowplowing rural, snowplowing freeway, backing up and practice field.

3.3 Warranty:

- 6.3 Late Delivery: The Agency placing the order under this Contract must be notified in writing if the shipment of the Contract Items will be delayed for any reason. Any delay in delivery that could cause harm to an Agency will be grounds for cancellation of the Contract, and/or obtaining the Contract Items from a third party. VS: yes compliant. Any Agency seeking to obtain the Contract Items from a third party under this provision must first obtain approval of the Purchasing Division. VS: no third party is involved.



Vendor shall be exclusively responsible for payment of employees and contractors for all wages and salaries, taxes, withholding payments, penalties, fees, fringe benefits, professional liability insurance premiums, contributions to insurance and pension, or other deferred compensation plans, including but not limited to, Workers' Compensation and Social Security obligations, licensing fees, etc. and the filing of all necessary documents, forms, and returns pertinent to all of the foregoing.

Vendor shall hold harmless the State, and shall provide the State and Agency with a defense against any and all claims including, but not limited to, the foregoing payments, withholdings, contributions, taxes, Social Security taxes, and employer income tax returns.

- 36. INDEMNIFICATION: The Vendor agrees to indemnify, defend, and hold harmless the State and the Agency, their officers, and employees from and against: (1) Any claims or losses for services rendered by any subcontractor, person, or firm performing or supplying services, materials, or supplies in connection with the performance of the Contract; (2) Any claims or losses resulting to any person or entity injured or damaged by the Vendor, its officers, employees, or subcontractors by the publication, translation, reproduction, delivery, performance, use, or disposition of any data used under the Contract in a manner not authorized by the Contract, or by Federal or State statutes or regulations; and (3) Any failure of the Vendor, its officers, employees, or subcontractors to observe State and Federal laws including, but not limited to, labor and wage and hour laws.
- 37. NO DEBT CERTIFICATION: In accordance with West Virginia Code §§ 5A-3-10a and 5-22-1(i), the State is prohibited from awarding a contract to any bidder that owes a debt to the State or a political subdivision of the State. By submitting a bid, or entering into a contract with the State, Vendor is affirming that (1) for construction contracts, the Vendor is not in default on any monetary obligation owed to the state or a political subdivision of the state, and (2) for all other contracts, neither the Vendor nor any related party owe a debt as defined above, and neither the Vendor nor any related party are in employer default as defined in the statute cited above unless the debt or employer default is permitted under the statute.
- 38. CONFLICT OF INTEREST: Vendor, its officers or members or employees, shall not presently have or acquire an interest, direct or indirect, which would conflict with or compromise the performance of its obligations hereunder. Vendor shall periodically inquire of its officers, members and employees to ensure that a conflict of interest does not arise. Any conflict of interest discovered shall be promptly presented in detail to the Agency.

39. REPORTS: Vendor shall provide the Agency and/or the Purchasing Division with the following reports identified by a checked box below:

"Steel Products" means products rolled, formed, shaped, drawn, extruded, forged, cast, fabricated or otherwise similarly processed, or processed by a combination of two or more or such operations, from steel made by the open heath, basic oxygen, electric furnace, Bessemer or other steel making process.
 - c. The Purchasing Division Director may, in writing, authorize the use of foreign steel products if:
 - 1. The cost for each contract item used does not exceed one tenth of one percent (.1%) of the total contract cost or two thousand five hundred dollars (\$2,500.00), whichever is greater. For the purposes of this section, the cost is the value of the steel product as delivered to the project; or
 - 2. The Director of the Purchasing Division determines that specified steel materials are not produced in the United States in sufficient quantity or otherwise are not reasonably available to meet contract requirements.

42. PREFERENCE FOR USE OF DOMESTIC ALUMINUM, GLASS, AND STEEL: In Accordance with W. Va. Code § 5-19-1 et seq., and W. Va. If the domestic aluminum, glass or steel products to be supplied or produced in a "substantial labor surplus area", as defined by the United States Department of Labor, the cost of domestic aluminum, glass, or steel products may be unreasonable if the cost is more than thirty percent (30%) of the bid or offered price for foreign made aluminum, glass, or steel products. This preference shall be applied to an item of machinery or equipment, as indicated above, when the item is a single unit of equipment or machinery manufactured primarily of aluminum, glass or steel, is part of a public works contract and has the sole purpose or of being a permanent part of a single public works project. This provision does not apply to equipment or machinery purchased by a spending unit for use by that spending unit and not as part of a single public works project.

All bids and offers including domestic aluminum, glass or steel products that exceed bid or offer prices including foreign aluminum, glass or steel products after application of the preferences provided in this provision may be reduced to a price equal to or lower than the lowest bid or offer price for foreign aluminum, glass or steel products plus the applicable preference. If the reduced bid or offer prices are made in writing and supersede the prior bid or offer prices, all bids or offers, including the reduced bid or offer prices, will be reevaluated in accordance with this rule.

43. INTERESTED PARTY SUPPLEMENTAL DISCLOSURE: W. Va. Code § 6D-1-2 requires that for contracts with an actual or estimated value of at least \$1 million, the Vendor must submit to the Agency a disclosure of interested parties prior to beginning work under this Contract. Additionally, the Vendor must submit a supplemental disclosure of interested parties reflecting any new or differing interested parties to the contract, which were not included in the original pre-work interested party disclosure, within 30 days following the completion or termination of the contract. 

DOT24*76 Simulator

1. Regarding section 3.1.1.4, the RFQ states, "Shall have 10, 13, 18 speed manual, 18 speed Eaton fuller shifter knob with selectable gear ratio software." QUESTION:

A. With reference to the shifter/transmission, should the requirement be that the simulator transmission sub-system provide the same feedback as in a truck; 'lock-out' and 'grind' as in a real-commercial vehicle? Answer: Yes, it should provide the same feedback.

B. With reference to the shifter knob, should it be required that the SPLITTER and RANGE SELECTOR be pneumatically driven, as in a real commercial vehicle? Answer: Will accept air or non-air shift.

VS: ok

2. Regarding section 3.1.1.5, the RFQ states, "Selectable manual or automatic transmission including the new automated manual transmissions."

QUESTION: A. With reference to the shifter / transmission, shall the requirement be that the simulator automatic-transmission be controlled by a column-mounted lever (such as an OEM Freightliner Cascadia DT12) as in a real-vehicle? Answer: Shifter for automatic transmissions shall be push button style shown on the LCD display.

VS: ok

B. Follow-up: With reference to the Brake-pedal component, shall the simulator Brakesystem be pneumatically powered by air-pressure feedback, as in a real-commercial vehicle? Answer: Will accept air-pressure feedback or electronic as long as it is a real feel design.

VS: ok

3. Regarding section 3.1.1.8, the RFQ states, "Three channel visual system, 180 degree forward field of view using 55 inch LED 4K, with a minimum 3840x2160 pixel high resolution displays."

QUESTION: With reference to the visual system, would it be beneficial to WVDOH to receive a simulator with a field of view greater than 180°? Answer: Will accept 180 VS: ok degree or better field of view as long as the minimum 4K 3840x2160 pixel high resolution is achieved. VS: Note, we also support greater than 180 degrees projected visual systems

on the supplied screens. It's selected via a button on the operator station.

4. Regarding section 3.1.1.8, the RFQ states, "Three channel visual system, 180 degree forward field of view using 55 inch LED 4K, with a minimum 3840x2160 pixel high resolution displays." 9800 4th Street North, Ste 204 St Petersburg, FL 33702 2438 Cades Way, Vista, CA 98081 800.870.5782

QUESTION: With reference to the visual system, would it be beneficial to WVDOH to receive a simulator with six channels and a field-of-view of 270°? **Answer: Will accept three channel 180 degree field of view or six channel 270 degree field of view.**

VS: ok

5. Regarding section 3.1.1.10, the RFQ states, "Simulation of the adjustable left and right side mirrors both standard and convex on each side."

QUESTION: With reference to the Driver's perspective should the images in the mirrors change and correspond to the movement of the Driver's head-position and movement, as in a real-vehicle? In other words, should the images in the mirrors be dynamic according to driver's head movement? **Answer: Will accept either.**VS: ok

6. Regarding section 3.1.1.11, the RFQ states, "Shall have adjustable tilt, height steering wheel with adjustable active force feedback to match selected vehicle to mimicking real vehicle steering wheel operation."

QUESTION: Is the requirement/preference that the steering system include actual OEM components, such as the turn signal cluster, steering wheel column and wheel, controls, pedals, levers, and switches? **Answer: Turn signal activation shall be presented on the LCD display. Steering wheel, steering column, controls, pedals, levers and switches shall be OEM style.**

VS: ok

7. Regarding section 3.1.1.15, the RFQ states, "Shall have 3 axis motion/vibration system to give a real feel driving simulation"

QUESTION: Regarding the motion-system, is the requirement that the system simulate Linear motion (such as acceleration / braking) and Yaw-motion (such as traction-loss) as in an actual commercial-vehicle? **Answer: Yes.**

VS: ok

- 8. Regarding section 3.1.1.18, the RFQ states "Shall have an interactive air brake training system with usable fault scenarios"
- A. Regarding the Air-brakes system (Parking Brake / Trailer Brake), is the requirement that the brake valve controls be a physical push/pull-type mechanism as in an actual commercial-vehicle? **Answer: Brake valves shall be displayed on a touchscreen LCD.**

VS: ok

B. Further regarding the dash-mounted brake-valves, should the system replicate the Air-Brake test / Air-Brake failure and pneumatically deploy/retract the brake-valve

knobs, as in an actual commercial vehicle? Answer: Brake valves shall be displayed on a touchscreen LCD display and replicate the air brake test/air brake failure digitally. $\begin{tabular}{ll} $VS: ok \end{tabular}$
