


ATTACHMENT A

CRFQ FOR2500000002 PROFESSIONAL SURVEYING SERVICES

- 1. Is the contractor expected to only mark boundaries of Designated Improvement Areas (DIA)?
 - A. The DIA boundaries are the only boundary lines that must be marked.
- 2. What is the frequency/interval of hacking and painting the trees to mark the proposed Designated Improvement Area (DIA)? Will the contractor be expected to mark only trees that fall within the DIA boundary lines, or within a designated length from the boundaries?
 - A. Since the trees are growing naturally in the forest, they are irregularly spaced. As a result, it is not possible to specify a fixed frequency or interval, along or from the DIA boundary lines, for marking and painting the trees. The trees must be marked and painted frequently enough so someone can see the marks and paint and be able to determine where the lines are. The marked and painted trees must occur on the inside or outside of the DIA boundary lines and they must point to where the lines are. Marked and painted trees closer to the DIA Boundary lines are better than those that are far away. Trees that point to corners have 3 painted marks and trees pointing to boundary lines have two painted marks.
- 3. To clarify the requirements of 4.1.1.2, is the selected contractor to simply annotate calls meandering Old Capon Road and Ice Lick Branch, if deemed the boundary lines, instead of simply stating "with Old Capon Road xxxx" to the beginning?
 - A. The Old Capon Road centerline and Icelick Run must be described by bearings and distances (if deemed the boundary lines). In other words, new surveyed bearings and distances are needed each time the road centerline and stream change direction.
- 4. Is there open access to the entirety of the property on foot and/or with vehicle/utv/atv?
 - A. Foot travel is permitted on the entirety of the property. Vehicle/ATV/UTV may be used on roads.
- 5. Are there any restrictions for certain hunting seasons?
 - A. Yes. Access to the property will not be provided during buck gun season (the week of Thanksgiving and the week after).
- 6. Will all adjoiners be notified by vendor or coordinator?
 - A. The CRFQ does not require Vendor or Agency to notify adjoiners.
- 7. Will T-Posts be required if they cannot be driven?
 A. No.

- 8. Designated Improvement Area (DIA) boundaries are based on plats via Exhibits C & D. Do these boundaries include platted roadways?
 - A. For DIAs, a road becomes part of its boundary, if it is on its exterior boundary. Roads on the interior of a DIA do not become part of its boundaries.
- 9. Can original copies of Exhibit C & D plats be mailed to vendor from buyer for easier interpretation of previous surveys?
 - A. No. The Exhibits provided are directly from the Hardy County, WV Courthouse, where they are recorded, so Agency does not have the originals. The copies were not clean when they were provided to Agency.
- 10. Payment It appears that this will be a one-time payment after the work is completed and the deliverables have been submitted, with a 365 day timeframe. Would it be possible to invoice the project in stages of completion so that we are not carrying the entire cost of the project for up to 1 year?
 - A. No. Invoice may be submitted upon completion of all work as specified in the Mandatory Requirements section of the CRFQ.


