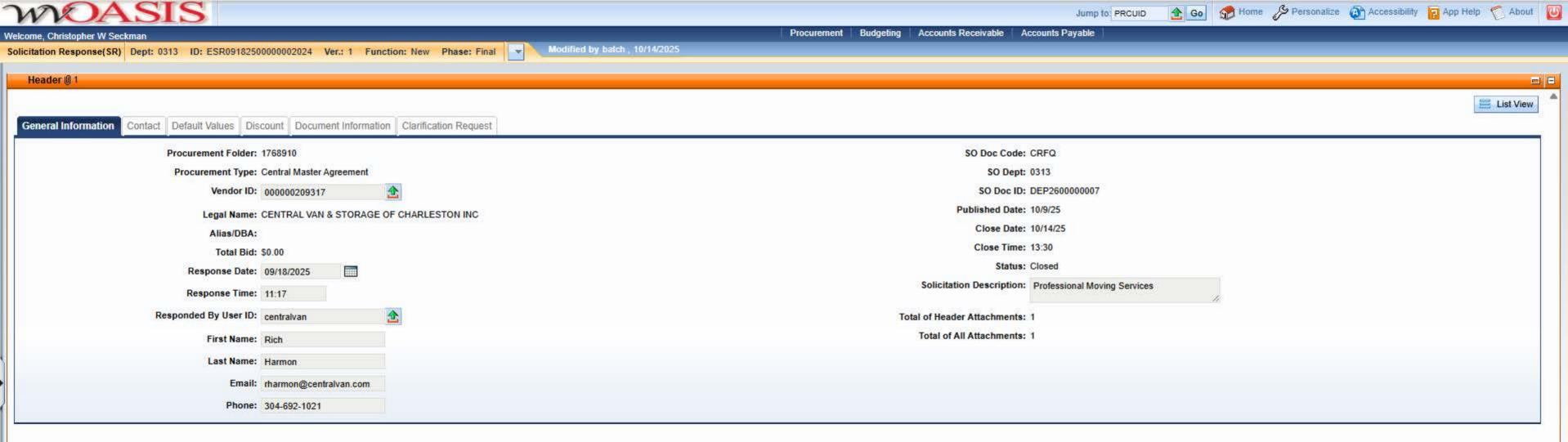

Questions and Answers

- Q.1. I was looking at the purchase page and do not see items to be packed and a rate for doing that. Also, the rates for drivers labor and supervisor, If I have three drivers and three labor people do I submit the bid for each?
- **A.1.** The agency will do all packing. The bid would be the price for one person. For example, one driver, one laborer, and one supervisor.
- Q.2. When I do the final bill, do I bill for 3 drivers, 3 labor and 3 supervisors times the rate?
- A.2. You would bill the rate for the position (driver, laborer, or supervisor) times the quantity provided.
- Q.3. Is there a walk through available to see what needs to be packed disassembled and reassembled. Also, if I have to provide boxes, tape and other supplies, where on the pricing page do I put the rate for that?
- A.3. Yes, the agency will schedule a walk-through of the facility to be moved post award but prior to the move services being scheduled. This walk through will either be in person or via video call. This contract is for moving services only. Bidding on materials is not required.
