- PURPOSE AND SCOPE: The West Virginia Purchasing Division is soliciting bids on behalf of District 10 to establish a contract for the one time purchase of materials, labor, equipment and all incidentals to replace the entire existing ballasted roofing system at Raleigh County WVDOH headquarters with a fully adhered membrane roofing system at 379 Market Road Beckley WV 25801.
- 2. The Vendor shall furnish all materials, labor, and equipment necessary to complete all Construction Services. The Vendor shall furnish any incidental work, materials, labor, and equipment that are necessary to complete the Construction Services, even if such incidental work is not explicitly included in the Project Plans.
- 3. **DEFINITIONS:** The terms listed below shall have the meanings assigned to them below. Additional definitions can be found in section 2 of the General Terms and Conditions and in the Project Plans as defined below.
 - A) "Construction Services" means replacement of existing ballasted roof with a fully adhered *EPDM* roofing system.
 - B) "Pricing Page" means the pages contained in wvOASIS, attached hereto as Exhibit A, or included in the Project Plans upon which Vendor should list its proposed price for the Construction Services.

CRFQ DOT 2600000018 RALEIGH CO. HEADQUARTERS ROOF REPLACEMENT

1. The Specifications shows for ½ inch OSB to go on top of the insulation. We cannot do that because it will void the Warranty. With the taper system being installed, that will consist of two layers. You do not need a cover board for a 20 year warranty. So my question is, do you still want to install a cover board?

Answer: Yes, we do wish to have cover board. It is to be a minimum High- Density (HD) cover board, consisting of 2 layers with staggered joints.

2. In the Specifications, it shows for the insulation R value to be a minimum of R2.5 and an average R value of R25. It must either be an average R value or a minimum R value so that we don't have to build up the edge with a lot of extra woodwork that will not be known until we do the work. An average R value is usually used on garages, workshops, etc. My question is, do you want to use the average or minimum R value insulation?

Answer: The specs call for a low-rise foam, a minimum of 2.5 inches.

The specs call for an average R-Value of tapered insulation shall be R-25 at a minimum.
