Mark-up Multiplier example

- 0.50 Vendor sells parts to the agency at one-half the vendors cost
- 1.00 Vendor sells parts to the agency at the vendors cost
- 1.10 Vendor sells parts to the agency at the vendors cost plus 10% mark-up
- 1.25 Vendor sells parts to the agency at the vendors cost plus 25% mark-up
- 1.50 Vendor sells parts to the agency at the vendors cost plus 50% mark-up
