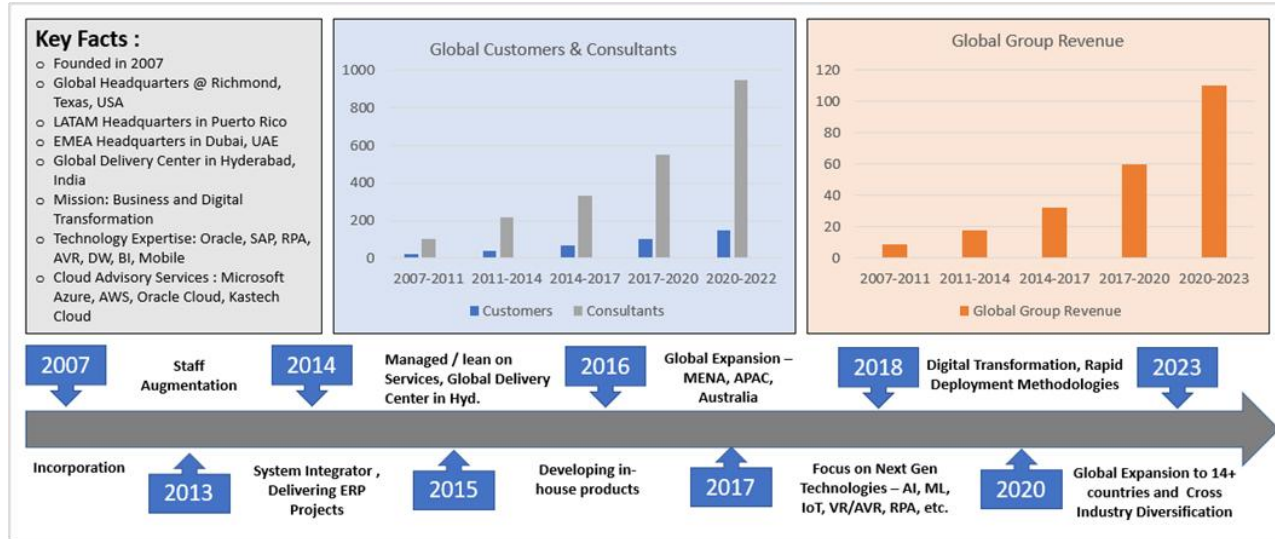


Exhibit 2: Kastech's Journey



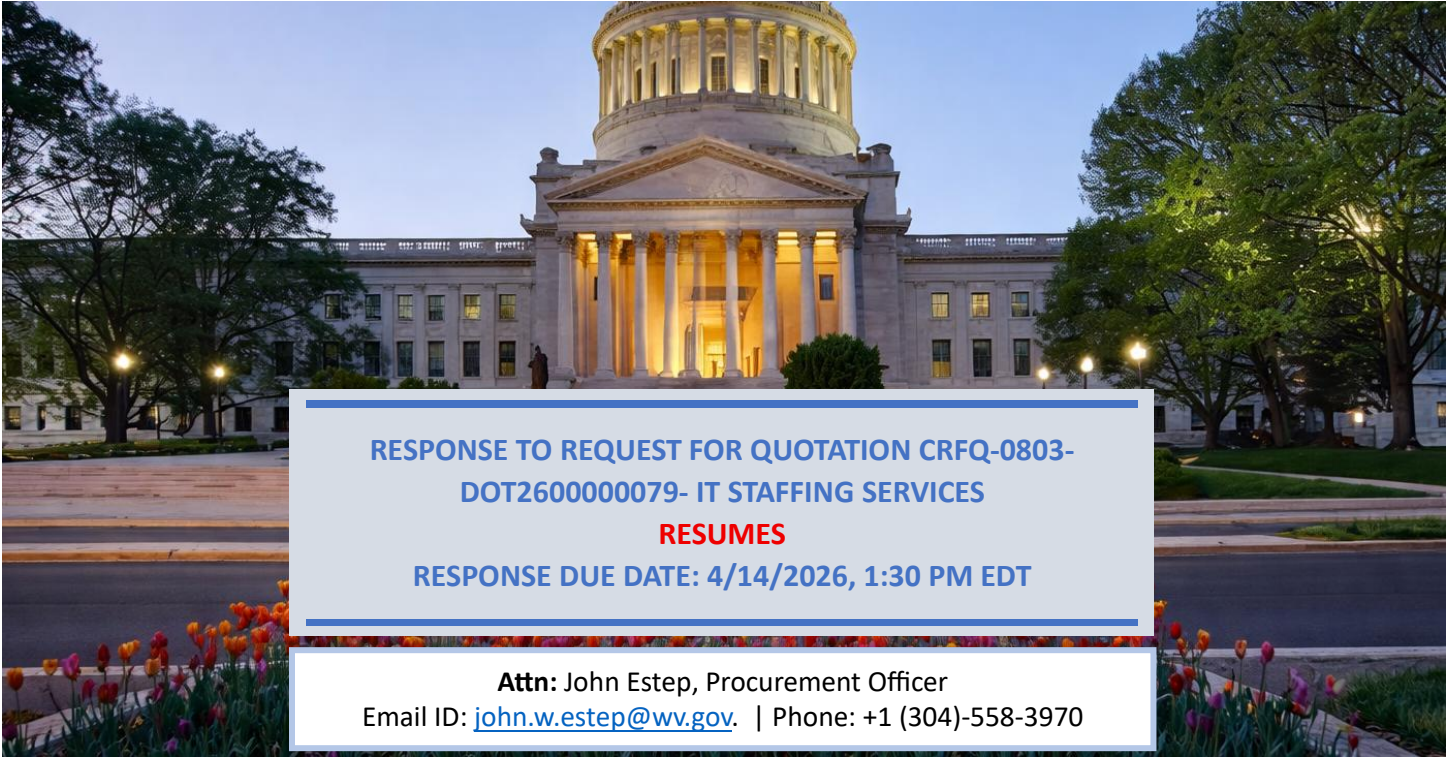
