

**1. PURPOSE AND SCOPE:** The West Virginia Purchasing Division is soliciting bids on behalf of WV Department of Agriculture, Huttonsville State Farm, to establish a contract for the one-time purchase of Beef Cattle Minerals.

**2. DEFINITIONS:** The terms listed below shall have the meanings assigned to them below. Additional definitions can be found in section 2 of the General Terms and Conditions.

**2.1 “Contract Item”** means beef cattle minerals as more fully described by these specifications.

**2.2 “Pricing Page”** means the pages, contained in wvOASIS or attached as Exhibit A, upon which Vendor should list its proposed price for the Contract Items.

**2.3 “Solicitation”** means the official notice of an opportunity to supply the State with goods or services that is published by the Purchasing Division.

**2.5 “IU/LB”** IU stands for International Unit. IU/LB is a way to express the potency of a substance in relation to its biological effect, rather than its mass.

**2.6 “KELP”** refers to seaweed and assists with fly control and reproduction.

**2.7 “IGR”** refers to Insect Growth Retardant to control flies.
