Dear Valued Customer,

I would like to thank you for your business and your continued support of our products. However, the past 12 months has presented many challenges to our industry. Cost increases in raw material as (lead, tin, silver, antimony, poly, acid, pallets and packaging) as well as recycling conversion cost and freight. We have also experienced cost inflation relative to the attraction and retention of key skilled positions.

Our largest raw material "lead" has escalated from \$82.95 per cwt. in 4th quarter of 2020, to 105.13 per cwt. currently. This lead cost is reviewed and implemented to us quarterly based on the LME. At this point we have had an increase total of \$22.18 per cwt. over the past 12 months, which has had an overall percentage increase to our cost of 12.2% with an additional increase of 7.8% coming in 1Q of 2022.

Please see the following price increases that we have incurred over the past 4 quarters.

- 1.) September 24, 2020 letter with October 1, 2020 LME level of \$82.95 per cwt. (4Q of 2020) pricing, in which we bided from.
- 2.) December 17, 2020 letter with January 1, 2021 LME level of \$84.24 per cwt. (1Q of 2021) with an increase of 0.5%.
- March 19, 2021 letter with April 1, 2021 LME level of \$92.51 per cwt. (2Q of 2021) with an increase of 6.9%.
- June 17, 2021 letter with July 1, 2021 LME level of \$93.01 per cwt. (3Q of 2021) with an increase of 0.2%.
- September 17, 2021 letter with October 1, 2021 LME level of 105.13 per cwt. (4O of 2021) an increase of 4.6%.
- December 17, 2021 letter with January 1, 2022 LME level of 104.98 per cwt. (1Q of 2022) an increase of 7.8%.

With the above increases Taylor Blackburn is asking for a 10% price increase to be added to the current pricing for the upcoming renewal period of the current AEBATTERY21 contract.
