GENERAL TERMS & CONDITIONS PURCHASE ORDER/CONTRACT

- 1. ACCEPTANCE: Seller shall be bound by this order and its terms and conditions upon receipt of this order.
- 2. APPLICABLE LAW: The laws of the State of West Virginia and the *Legislative Rules* of the Purchasing Division shall govern all rights and duties under the Contract, including without limitation the validity of this Purchase Order/Contract.
- 3. NON-FUNDING: All services performed or goods delivered under State Purchase Orders/Contracts are to be continued for the terms of the Purchase Order/Contract, contingent upon funds being appropriated by the Legislature or otherwise being made available. In the event funds are not appropriated or otherwise available for these services or goods, this Purchase Order/Contract becomes void and of no effect after June 30.
- 4. **COMPLIANCE:** Seller shall comply with all Federal, State and local laws, regulations and ordinances including, but not limited to, the prevailing wage rates of the WV Division of Labor.
- **MODIFICATIONS:** This writing is the parties final expression of intent. No modification of this order shall be binding unless agreed to in writing by the Buyer.
- **6. ASSIGNMENT:** Neither this Order nor any monies due, or to become due hereunder may be assigned by the Seller without the Buyer's consent.
- 7. WARRANTY: The Seller expressly warrants that the goods and/or services covered by this Order will: [a] conform to the specifications, drawings, samples or other description furnished or specified by the Buyer; [b] be merchantable and fit for the purpose intended; and/or [c] be free from defect in material and workmanship.
- 8. CANCELLATION: The Director of Purchasing may cancel any Purchase Order/Contract upon 30 days written notice to the Seller.
- 9. SHIPPING, BILLING & PRICES: Prices are those stated in this order. No price increase will be accepted without written authority from the Buyer. All goods or services shall be shipped on or before the date specified in this Order.
- **10. LATE PAYMENTS:** Payments may only be made after the delivery of goods or services. Interest may be paid on late payments in accordance with the *West Virginia Code*.
- **11. TAXES:** The State of West Virginia is exempt from Federal and State taxes and will not pay or reimburse such taxes.
- **12. RENEWAL:** Any reference to automatic renewal is hereby deleted. The Contract may be renewed only upon mutual written agreement of the parties.
- **13. BANKRUPTCY:** In the event the vendor / contractor files for bankruptcy protection, this contract is automatically null and void, and is terminated without further order.

AMENDMENT FOUR to the LICENSE AGREEMENT between ORACLE CORPORATION and STATE OF WEST VIRGINIA

DEFINITIONS

Oracle's E-Business Suite application products are not standard base products used by State agencies and must be competitively bid using standard purchasing procedures. If Oracle application software is part of the winning bid, the Oracle software licensing and support will be governed by the terms and conditions of this Master Contract.

ORDERING INSTRUCTIONS:

Software licenses and support for Oracle's Database products, Integration products, Rdb products, and Education subscriptions may be acquired under this contract as sole source purchases using the following procedures:

- 1. The agency will contact Oracle to request a cost estimate for the software license or support they wish to acquire.
- 2. Oracle Corporation will provide the State entity with an Ordering Document (as attached) which is to be signed by Oracle and the State agency.
- 3. The State entity will prepare a Blanket Release Order showing the Oracle components listed on the Ordering Document and the price for each.

If Ordering Document is less than \$10,000:

The State entity will send the Blanket Release Order and a copy of the signed Ordering Document directly to Oracle Corporation. The State entity will also be required to send a copy of the package to the attention of IS&C's Oracle Master Contract Coordinator.

If Ordering Document is more than \$10,000:

State agencies will be required to send the Blanket Release Order and the signed Ordering Document to IS&C's Consulting Services for review. IS&C will review the procurement and forward it on to the GOT Office for approval. The GOT representative will send the State agency an approval letter to be maintained in the agency's files and sent with the invoice to the State Auditor's Office. IS&C's Consulting Services is responsible for insuring that the Oracle Master Contract Coordinator receives a copy of the package.

After approval is obtained from the GOT Office, the State entity will send the Blanket Release Order and a copy of the signed Ordering Document directly to Oracle Corporation.
