A confirmation letter is mailed to all registered vendors with this access information.

To subscribe to this bulletin and actively participate in the competitive bid process, a completed Vendor Registration & Disclosure Statement and Small, Women-, & Minority-Owned Business Certification (Form WV-1) and an annual fee of \$125.00 is required. [The WV-1 is available on our website.](#)

The following information is required for each requested bid package: Request for Quotation/Proposal number; state buyer's name; vendor’s complete business name and mailing address; Federal Employers Identification Number (FEIN) and/or Social Security number; and the name and telephone number of a contact person for clarification purposes.

All bids must be received by the Purchasing Division **PRIOR TO** the date and time of the bid opening. Public bid openings are held at the Purchasing Division located at 2019 Washington Street, E., Charleston, WV 25305. It is the vendor's responsibility to make sure their bids are properly identified with the Request for Quotation/Proposal number, bid-opening date and time on the outside of the envelope.
