The contractor will be responsible for all labor, equipment, electrical fittings and wire for the complete installation to provide power. Installation must include an emergency stop button and contactors at nearby building. The complete installation will also include pipe and fittings for start up and to check out the operation.

The Division of Highways will be responsible for the concrete foundation, to set tank with ladders, platforms and pumps bolted in place. - 3. Lincoln County Headquarters located at 7338 WV 10 in West Hamlin, WV.
- 4. Wayne County Headquarters located at 326 Central Avenue, Wayne, WV.


