The Lorrie Yeager Juvenile Center is located at 907 Mission Drive, Parkersburg, (Wood County) West Virginia, 26103. This center is a 24 bed facility which serves residents from the north central part of the state.

RE: Addendum 1, clarifications #4,5

The RFQ for mental health services included the positions for Program Director and Psychiatric Facilitator. The job description for the Program Director reflects this to be a job that is already being performed by DJS employees. This was raised at the pre-bid and should be excluded from the RFQ. The additional cost to the taxpayers of this state is unwarranted.

The Psychiatric Facilitator position was implemented to assist the psychiatrist with the telemedicine operations at the juvenile facilities as they were opening. This position is no longer necessary as all facilities are now open and with the exception of the WVIHY, telemedicine is being provided.

This bid is for the provision of psychiatric services for all the juvenile facilities via telemedicine. The creation of the above two positions would serve no benefit to the juvenile population, and funding such positions would only waste taxpayers money.

ADDENDUM 1 DJS010234 Mental Health Services

Clarifications

- 1. Mental health crisis intervention services will be available 24/7 via on-call duties. A list of available on-call mental health staff will be provided with names and contact numbers. (Mental health equivalent of duty officers.)
- 2. When formulary medications cannot be utilized, a letter/note of justification must be provided for billing documentation purposes.
- 3. It is understood that there are some medication that cannot be phoned in, but all appropriate steps shall be taken in order to provide the prescribed meds at the earliest possible time. Any necessary documentation shall be forwarded immediately.
- 4. Program Director shall be a forty (40) hours a week position. Duties and recommendations will be reviewed and directed/determined by the division's Assistant Director of Programs and Treatment in conjunction with the Deputy Director or designee. Travel will be as required or requested. Travel expenses with be the responsibility of the vendor. Clinical expertise and guidance will be utilized to assist in development of appropriate programs and treatments in various areas, for the Division's resident population, as well as specialized programs and/or treatment for those residents determined to have special needs. They will assist, as requested, in monitoring implemented plans and collecting statistical data and providing data analysis.
- 5. Psychiatric Clinic Facilitator to be provided for each institution with a minimum of 3 hours per week spent on location. Signed documentation will be required for time spent on grounds.
- 6. The Division will utilize the clinical expertise of the mental health staff, as requested by the agency's Assistant Director of Programs and Treatment and/or the Deputy Director or designee, in the form of guidance and/or recommendations in the division's efforts to improve/develop and implement programs and treatments for the division's juvenile population.
- 7. Copies of all credentials and/or certifications for any employees to be utilized through this contract will be provided for review with the bid.
