## SPECIFICATIONS

### TRUCK AND BODY TO SERVE AS A MOBILE MINE RESCUE STATION.

Desired truck is a 7500 GMC, Freightliner MD 80, International 4300 series or equivalent, with a 24-foot box body with a three-foot over the cab extension.

Bids must apply to purchase of more than one truck. (One or two trucks may be purchased at this time )

The truck must have:

A GVW of less than 26000 lbs.

A height to the top of the frame rails of not more than 36 inches.

Tire size 245/75 R22.5, mud and snow on rear, straight tread on front

Dual saddle fuel tanks of at least 45 gallons each

A diesel engine rated at a minimum of 275-horse power with at least 700 lbs of torque.

An automatic transmission with dash mounted selector switch.

Air brakes with dash mounted park brake.

Dual bucket seats in cab.

Heater, defroster, air conditioner, rubber floor mat and FM radio in cab.

Mirrors to be single post design with flat and convex mirrors in same frame.

All standard gauges, controls, switches and indicators as usually found in such vehicles.

Vehicle must meet all accepted standards for the motor truck industry for frame size and length to accept and properly mount the 24-foot box body.

Vehicle must meet all state and federal laws and requirements for lighting, signaling and air brakes and meet all inspection requirements.

Body to be 24 feet long from back of cab to rear end, and have a 3-foot extension over the cab.

Body to be steel or aluminum skin attached to steel framing members with plastic or fiberglass reinforced plywood lining on the inside of the body.

Floor to be one and one half inch thick wood planks bolted to a steel frame.

Roof to be one piece stainless steel or aluminum with steel cross members.

Roof to be reinforced to support a center mounted heater/air conditioner and to have 12-inch square opening and wiring for same.

Body floor, walls and roof to be insulated to the fullest extent possible with Styrofoam or equivalent insulation. Bidder must state type and thickness of insulation for floor, walls and roof.

Body to have one sliding, 36 inch man door with a recessed step well to the floor of the body. This door to be on the passenger or curb side of the body 48 inches from the front of the body. Second door to be in the rear center of the body, 36 inches wide. Both doors to be lockable and keyed the same, and must be operable from inside or outside of the body.

Interior height of the body to be seven feet.

Body will be mounted as close to frame (as low) as practical

Body will have 4 aluminum underbody storage boxes installed in dual 3-inch channel iron mounts welded to the body frame. Three boxes will be 24X24X48 and will have dual swing out doors latched in the center. The right front box to be 24X24X24. Boxes to be "Highway Products" brand or equal. All four boxes to be lockable and keyed alike.

Body to have a steel frame welded to the underside to support a 7500-watt diesel generator. Frame to be enclosed to cover generator but still allow access for maintenance. Bidder will furnish and install a 7500 watt diesel generator (Onan "quiet diesel" or equal). Generator to use fuel from truck fuel system and start from the truck battery system.

Rear of body to have steel diamond plate step bumper and frame for steps to rear door. Bidder will supply a set of steps, with hand rail, to allow access to the rear door. These steps will fold or slide into the frame for transport while the truck is in motion. DOT bar to be part of rear frame or bumper.

Bidders must clearly state items in the bid requirements they are not in compliance with or wish to take exception to. Bidders must state delivery dates. Bidders should state any options they offer or think would better serve the purpose of this vehicle.

# AFFIDAVIT

**West Virginia Code §5A-3-10a states:**

No contract or renewal of any contract may be awarded by the state or any of its political subdivisions to any vendor or prospective vendor when the vendor or prospective vendor or a related party to the vendor or prospective vendor is a debtor and the debt owned is an amount greater than one thousand dollars in the aggregate

**DEFINITIONS:**

"Debt" means any assessment, premium, penalty, fine, tax or other amount of money owed to the state or any of its political subdivisions because of a judgment, fine, permit violation, license assessment, defaulted workers' compensation premium, penalty or other assessment presently delinquent or due and required to be paid to the state or any of its political subdivisions, including any interest or additional penalties accrued thereon

"Debtor" means any individual, corporation, partnership, association, limited liability company or any other form or business association owing a debt to the state or any of its political subdivisions. "Political subdivision" means any county commission; municipality; county board of education; any instrumentality established by a county or municipality; any separate corporation or instrumentality established by one or more counties or municipalities, as permitted by law; or any public body charged by law with the performance of a government function or whose jurisdiction is coextensive with one or more counties or municipalities. "Related party" means a party, whether an individual, corporation, partnership, association, limited liability company or any other form or business association or other entity whatsoever, related to any vendor by blood, marriage, ownership or contract through which the party has a relationship of ownership or other interest with the vendor so that the party will actually or by effect receive or control a portion of the benefit, profit or other consideration from performance of a vendor contract with the party receiving an amount that meets or exceed five percent of the total contract amount.

**EXCEPTION:**

The prohibition of this section does not apply where a vendor has contested any tax administered pursuant to chapter eleven of this code, workers' compensation premium, permit fee or environmental fee or assessment and the matter has not become final or where the vendor has entered into a payment plan or agreement and the vendor is not in default of any of the provisions of such plan or agreement

**LICENSING:**


Vendors must be licensed and in good standing in accordance with any and all state and local laws and requirements by any state or local agency of West Virginia, including, but not limited to, the West Virginia Secretary of State's Office, the West Virginia Tax Department, West Virginia Insurance Commission, or any other state agencies or political subdivision. Furthermore, the vendor must provide all necessary releases to obtain information to enable the Director or spending unit to verify that the vendor is licensed and in good standing with the above entities.

**CONFIDENTIALITY:**

The vendor agrees that he or she will not disclose to anyone, directly or indirectly, any such personally identifiable information or other confidential information gained from the agency, unless the individual who is the subject of the information consents to the disclosure in writing or the disclosure is made pursuant to the agency's policies, procedures and rules. 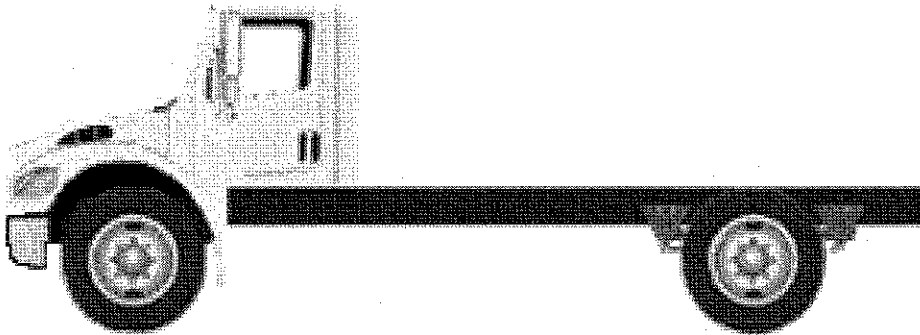

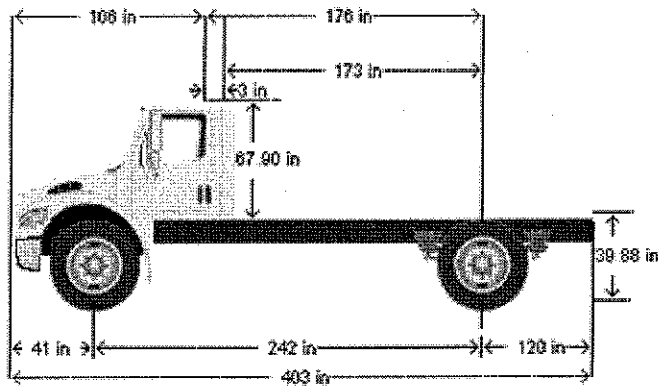
