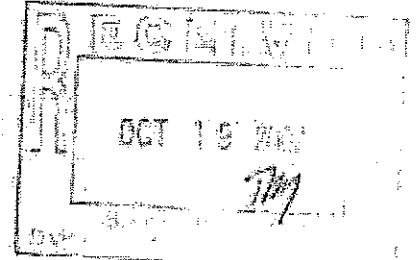

Questions and Answers

Q1. What about the timbers?

A1. No, everything, the timbers are to be disposed of. And along with all the other odds and ends and metal debris.

Q2. As far as the stake out stuff in (RFQ) there. What is there to stake out?

A2. Virtually nothing. It's a standard bid item we put in there. Maybe you want to check to make sure that your area sheet flows.

Q3. I didn't catch what you said about the concrete. All the concrete can be buried on-site as long as the steel is removed flush?

A3. Yes. All the concrete can be buried on-site once it is broken up in pieces no larger than four foot in any direction and the steel removed flush with the concrete. If it's (Steel) encapsulated in concrete you can bury it on-site. And the steel and/or rebar has to be disposed of off-site. And that is in item seven in the scope of work.

Q4. Dave, this bundle (Railroad Ties) here stays and this pile goes. Is that right?

A4. Yes this pile goes and the one that is bundled up and stacked stays, ok, on this side. The ones over here on this side go. Those over there he set off the limits of the work area.

Q5. Where's your topsoil at Dave? For your borrow sites.

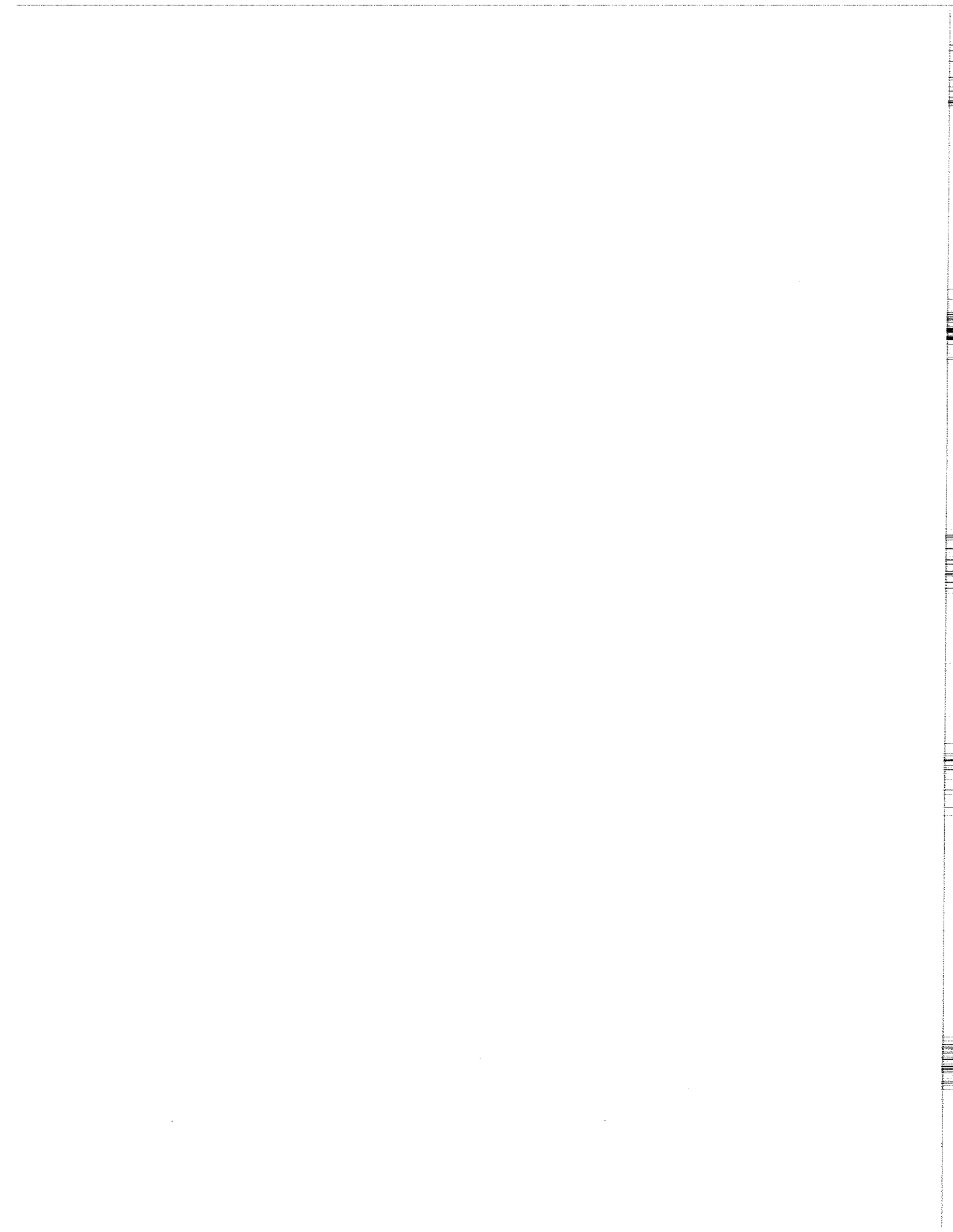
A5. Topsoil is wherever you can find it, ok, within the bounds of the permitted area. Any place within that that you can get brown-type soil to cover with.

Q6. This railroad grade, are you going to cover (Topsoil) this whole railroad grade?

A6. No, unless you tear it up.

Q7. Dave, the large hopper (Bin) there, is the association hooked on it?

A7. No, I don't think so. I think they want that little one that's attached to the building.

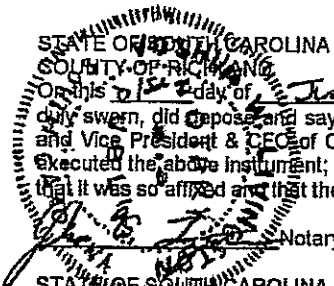


