Addendum No. 1

- Q1. Do we have to put any rock or anything back in there (area of washed out haulroad pipe)?
- A1. We will just open it up and regrade the slopes back, you need to pull them back more than they are now.
- Q2. Do you have a (specified) sized pipe on that (temporary pipe on the haulroad)? A2. We did not specify, just adequate to carry the flow.
- Q3. If you got in here this winter, I saw the specs. You can't topdress after September 15, if we demobilize, do we take the crossing out?
- A3. We will wave that topdressing (deadline), if you get in here. I would highly doubt you would get in here this year since this is the 18th of October and this is not a site you would want to work when it is wet.
- Q4. The rest of the slopes that don't have the black (material), you don't mess with it? A4. No, we're not going to mess with it. There are a few areas that are bare that you'll need to do something with, but if it's got vegetation on it we're just going to topdress it. Don't disturb the vegetation, tree, or shrubs anymore than you have to.
- Q5. In your topdressing you have black locust, you're not going to put it in there (area or site currently mowed by landowner) are you?
- A5. We are going to plant it, it is a permit requirement.
- Q6. Does the borrow area go above the road up around the top of that (slope)? A6. There is really no road up around the top of it. Above the top of it they took some material off previously, there is a flat area up there. The borrow area goes into the timber, it's undisturbed area.



"Related party" means a party, whether an individual, corporation, partnership, association, limited liability company or any other form or business association or other entity whatsoever, related to any vendor by blood, marriage, ownership or contract through which the party has a relationship of ownership or other interest with the vendor so that the party will actually or by effect receive or control a portion of the benefit, profit or other consideration from performance of a vendor contract with the party receiving an amount that meets or exceed five percent of the total contract amount.

EXCEPTION: The prohibition of this section does not apply where a vendor has contested any tax administered pursuant to chapter eleven of this code, workers' compensation premium, permit fee or environmental fee or assessment and the matter has not become final or where the vendor has entered into a payment plan or agreement and the vendor is not in default of any of the provisions of such plan or agreement.

LICENSING: Vendors must be licensed and in good standing in accordance with any and all state and local laws and requirements by any state or local agency of West Virginia, including, but not limited to, the West Virginia Secretary of State's Office, the West Virginia Tax Department, West Virginia Insurance Commission, or any other state agencies or political subdivision.
