The Department of Administration, General Services Division is seeking qualified Contractors to perform Window Cleaning Services on selected properties owned by the Department of Administration on a one-time basis. The selected contractor will be responsible to comply with the following specifications and complete schedule of work within a 60 day period from receipt of a Notice to Proceed.

- 1. Contractor will furnish all Labor, Materials, Equipment, Rigging, tools, permits or other material as needed to complete the work outlined on the cleaning specifications/schedule.
- 2. Contractor is responsible to pay prevailing wage for the job classification suited to the performance of the work as outlined by the Department of Labor and for the county of location of the facility specified. Such compensation is subject to payroll verification of payment at the discretion of the agency.
- 3. Successful vendor is required to furnish documentation of method and cleaning agents (eg, MSDS sheets) for specific type of surfaces. Some buildings are designated "green buildings" with special window tinting. It is the Contractor's responsibility to identify the appropriate best Industry practice or method for each building to avoid damage to the windows or framing. Contractor will be liable for any such damage to window coverings, tinting or framing from improper cleaning methods.
- 4. Contractor must obtain an authorized signature of the Agency designee on the service ticket document. Schedule of work will be coordinated and approved by GSD prior to work being initiated. Work is to be accomplished during normal business hours (generally from 7:00am to 5:00pm, but this may vary slightly in certain buildings) unless approved in writing by GSD in advance.
- 5. State of West Virginia reserves the right to accept or reject all proposals in part or as a whole based on the needs of the State of West Virginia.
- 6. Potential Contractors may contact the General Services Division Operations Manager to arrange Pre- bid Inspections of Buildings prior to Bid Opening Date: David Parsons (304) 558-0689. These inspections are not mandatory, but are strongly suggested. Technical questions arising from said inspections must be presented in writing to the Senior Buyer, Purchasing Division by the vendor, prior to the assigned deadline for such questions.

PURCHASING AFFIDAVIT

West Virginia Code §5A-3-10a states: No contract or renewal of any contract may be awarded by the state or any of its political subdivisions to any vendor or prospective vendor when the vendor or prospective vendor or a related party to the vendor or prospective vendor is a debtor and the debt owed is an amount greater than one thousand dollars in the aggregate

DEFINITIONS:

"Debt" means any assessment, premium, penalty, fine, tax or other amount of money owed to the state or any of its political subdivisions because of a judgment, fine, permit violation, license assessment, defaulted workers' compensation premium, penalty or other assessment presently delinquent or due and required to be paid to the state or any of its political subdivisions, including any interest or additional penalties accrued thereon.

"Debtor" means any individual, corporation, partnership, association, limited liability company or any other form or business association owing a debt to the state or any of its political subdivisions. "Political subdivision" means any county commission; municipality; county board of education; any instrumentality established by a county or municipality; any separate corporation or instrumentality established by one or more counties or municipalities, as permitted by law; or any public body charged by law with the performance of a government function or whose jurisdiction is coextensive with one or more counties or municipalities. "Related party" means a party, whether an individual, corporation, partnership, association, limited liability company or any other form or business association or other entity whatsoever, related to any vendor by blood, marriage, ownership or contract through which the party has a relationship of ownership or other interest with the vendor so that the party will actually or by effect receive or control a portion of the benefit, profit or other consideration from performance of a vendor contract with the party receiving an amount that meets or exceed five percent of the total contract amount.

EXCEPTION: The prohibition of this section does not apply where a vendor has contested any tax administered pursuant to chapter eleven of this code, workers' compensation premium, permit fee or environmental fee or assessment and the matter has not become final or where the vendor has entered into a payment plan or agreement and the vendor is not in default of any of the provisions of such plan or agreement.

LICENSING: Vendors must be licensed and in good standing in accordance with any and all state and local laws and requirements by any state or local agency of West Virginia, including, but not limited to, the West Virginia Secretary of State's Office, the West Virginia Tax Department, West Virginia Insurance Commission, or any other state agencies or political subdivision. Furthermore, the vendor must provide all necessary releases to obtain information to enable the Director or spending unit to verify that the vendor is licensed and in good standing with the above entities.

CONFIDENTIALITY: The vendor agrees that he or she will not disclose to anyone, directly or indirectly, any such personally identifiable information or other confidential information gained from the agency, unless the individual who is the subject of the information consents to the disclosure in writing or the disclosure is made pursuant to the agency's policies, procedures and rules. Vendors should visit www.state.wv.us/admin/purchase/privacy for the Notice of Agency Confidentiality Policies.

Under penalty of law for false swearing (West Virginia Code, §61-5-3), it is hereby certified that the vendor acknowledges the information in this said affidavit and are in compliance with the requirements as stated.
