GENERAL TERMS & CONDITIONS REQUEST FOR QUOTATION (RFQ) AND REQUEST FOR PROPOSAL (RFP)

- 1. Awards will be made in the best interest of the State of West Virginia
- 2. The State may accept or reject in part, or in whole, any bid.
- 3. All quotations are governed by the West Virginia Code and the Legislative Rules of the Purchasing Division
- 4. Prior to any award, the apparent successful vendor must be properly registered with the Purchasing Division and have paid the required \$125 fee.
- 5. All services performed or goods delivered under State Purchase Order/Contracts are to be continued for the term of the Purchase Order/Contracts, contingent upon funds being appropriated by the Legislature or otherwise being made available. In the event funds are not appropriated or otherwise available for these services or goods, this Purchase Order/Contract becomes void and of no effect after June 30.
- 6. Payment may only be made after the delivery and acceptance of goods or services.
- 7. Interest may be paid for late payment in accordance with the West Virginia Code.
- 8. Vendor preference will be granted upon written request in accordance with the West Virginia Code
- 9. The State of West Virginia is exempt from federal and state taxes and will not pay or reimburse such taxes
- 10. The Director of Purchasing may cancel any Purchase Order/Contract upon 30 days written notice to the seller

#### 6. CONTRACT REQUIREMENTS

The purpose of this contract is to establish unit prices for Items 1 thru 17, which are to be used as the basis for requisition of materials for the repair and maintenance of silicone, asphalt, and concrete. All components bid as equal, must prove they are equal, through supporting research and analysis of composition to the satisfaction of the West Virginia Department of Transportation, Division of Highways. At the discretion of the West Virginia Department of Transportation, Division of Highways, Items bid as equal may be required to undergo a performance evaluation, under field conditions, to assure performance before being accepted as equal.

Bid price for Items 1 thru 17 shall be "F.O.B." Division of Highways storage sites as indicated on the Approved State Contract Purchase Order (SCO). Refer to bid schedule for a listing of the Division of Highways storage sites.

Vendor may bid any or all items on the bid schedule. However, the amount bid on any one item may be conditioned on the acceptance of the bid on any other item.

Any qualification of bids or modification of the specification or conditions governing the bid may be cause to reject bids.
