Specifications

Background disclosure statement investigations (BI) are to be conducted within and outside the boundaries of WV. Applicants for a solid waste facility may include both persons living in WV or outside of WV. These BI's will include all information necessary to grant or deny a solid waste facility permit based upon the statutory requirements of WV Code Chapter 22-15-5(c).

DEP will enter into an open-end contract for these investigative services with up to three (3) vendors. The bidders must be competent to work in both aspects of criminal and environmental investigations. Vendors may be assigned multiple investigations for different facility permit applications.

A flat rate per hour will be the total charge to the state and will cover the full cost of all work hours including labor, travel and materials. The vendors will be contracted to provide these investigative services on an "as needed" basis only. The vendor will invoice DEP for services on a monthly basis. All invoices must be accompanied by a sworn statement detailing actual hours of work. A quarterly progress report shall be submitted by the contractors to DEP describing the investigative work performed for that quarter and shall include an estimated time frame for completing the investigation and problems encountered.

Vendors must agree in writing to hold harmless and indemnify the state of West Virginia and its officials from and against any and all liability arising from any action, claim, demand, lawsuit, or cause of action which may be asserted against the state or its officials by reasons of any acts of negligence of the bidder in the performance of services contemplated by this contract.

All vendors must be familiar with 33CSR1 Subsection 3.14 and the WV Code Chapter 22-15-5 (c), (j) and (k). Copies of 33CSR1 and WV Code Chapter 22-15-5 may be obtained by contacting the Secretary of State's Office at 304-558-6000.

General Requirements

The vendor with the lowest hourly cost will be issued the work directive first. All BI's will be ordered by the Secretary by his or her agent by issuance of the work directive. The vendor will then be responsible for contacting DEP to arrange for a meeting at the Division of Water and Waste Management, Solid Waste Management Section, in order to receive the completed disclosure statement applications and begin an investigation.

If the low bid vendor cannot begin work within two (2) weeks after receiving the work directive, the DEP may rescind the work directive and reassign the BI to the second low bidder who must
