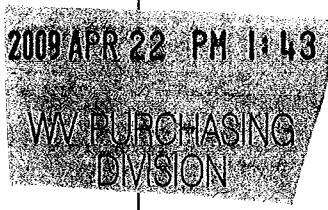

1. Awards will be made in the best interest of the State of West Virginia.
2. The State may accept or reject in part, or in whole, any bid.
3. All quotations are governed by the *West Virginia Code* and the *Legislative Rules* of the Purchasing Division.
4. Prior to any award, the apparent successful vendor must be properly registered with the Purchasing Division and have paid the required \$125 fee.
5. All services performed or goods delivered under State Purchase Order/Contracts are to be continued for the term of the Purchase Order/Contracts, contingent upon funds being appropriated by the Legislature or otherwise being made available. In the event funds are not appropriated or otherwise available for these services or goods, this Purchase Order/Contract becomes void and of no effect after June 30.
6. Payment may only be made after the delivery and acceptance of goods or services.
7. Interest may be paid for late payment in accordance with the *West Virginia Code*.
8. Vendor preference will be granted upon written request in accordance with the *West Virginia Code*.
9. The State of West Virginia is exempt from federal and state taxes and will not pay or reimburse such taxes.
10. The Director of Purchasing may cancel any Purchase Order/Contract upon 30 days written notice to the seller.
11. The laws of the State of West Virginia and the *Legislative Rules* of the Purchasing Division shall govern all rights and duties under the Contract, including without limitation the validity of this Purchase Order/Contract.
12. Any reference to automatic renewal is hereby deleted. The Contract may be renewed only upon mutual written agreement of the parties.
13. **BANKRUPTCY:** In the event the vendor/contractor files for bankruptcy protection, this Contract may be deemed null and void, and terminated without further order.

## **REVISIONS TO SPECIFICATIONS**

Add **7.2.4 Random Backfill** – Random backfill shall be as specified in Section 604.8 of the WVDOT Standard Specifications for Roads and Bridges. The backfill considered for use must first be visually approved by the WVDEP.

## **DRAWINGS**

A detail drawing of pipe backfill utilizing random backfill is attached.

Sheet 4 of 6 – Delete the TYPICAL V-DITCH 4' RIPRAP CHANNEL detail drawing. A new detail drawing of the rock rip channel showing the channel to be 1.5' deep and 6' wide v-ditch is attached.

## **QUESTIONS AND ANSWERS**

### Questions asked at the mine seal area:

Q: Is this the access road that is to be gravelled? Which part? All the way to the road?

A: Yes. The road is to be stoned as shown on the drawings and as outlined in the construction specifications.

Q: Where is the portal?

A: On the hill at the location shown on the drawings.

Q: How is the drainage to go?

A: The drainage is to be taken from the portal around the hill at the location shown on the drawings.

Q: Will we need railroad insurance?

A: Yes.

Q: Will we be able to use any of this dirt for backfilling the seal?

A: The seal is to be backfilled according to the drawings and construction specifications. Material excavated from the site can be used as soil cover if the material will support vegetation.

Q: Will the large tree beside the portal need to be cut?

A: Yes, the roots will be cut during construction activities and will cause the tree to eventually die. The tree will need to be cut and stockpiled.

Questions asked at the end of drainage area:

Q: Is this the area to be cleared?

A: Yes, but only to the extent necessary to complete the work. Timber that has roots damaged by construction activities will also need to be cut down and stockpiled.

Q: Where are we to put the drainage down the hill?

A: At the location shown on the drawings.

Q: Is there a wingwall on this project?

A: No. Rock riprap is to be placed at the discharge end of the pipe where it empties into the riprap channel.

Q: That is the end of the project down there?

A: Yes, at the location shown on the drawings.

Q: Is this a concrete cistern?

A: Appears to be a concrete pad. The pipe is to be placed up the hill above the pad at the location shown on the drawings. The Contractor shall take care not to damage the concrete.

Q: Where is the last manhole?

A: At the location shown on the drawings.

Q: How deep are the manholes?

A: The required depth will need to be measured on the drawings.

Q: Where does the riprap ditch start?

A: At the location and elevation shown on the drawings.

Q: Are the existing survey ribbons at the end of the ditch?

A: No, the survey ribbons were placed during mapping activities. Construction layout will be the responsibility of the Contractor.

Q: Are the manholes round?

A: Yes.

Q: Is there a grate on top of the manhole?

A: No, a manhole cover.

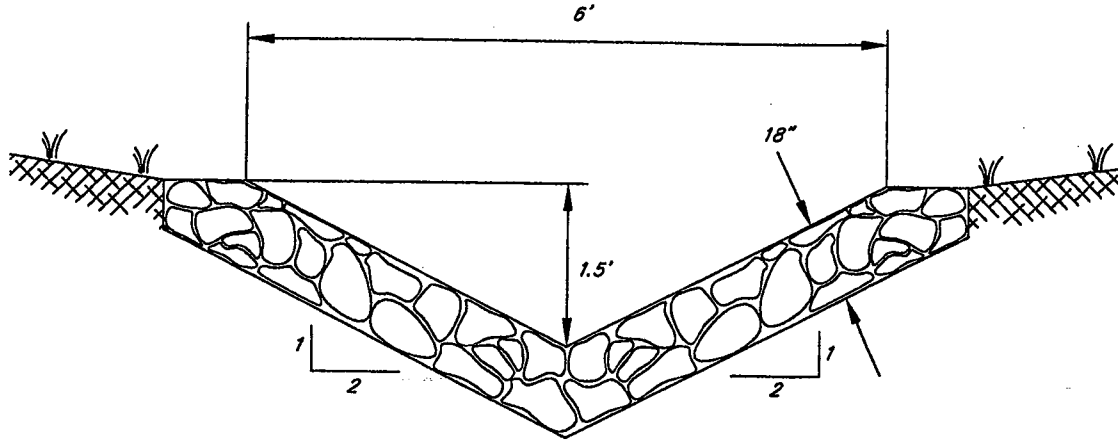
Question asked at the parking area:

A: No. Only pipes damaged by construction activities will need to be replaced.

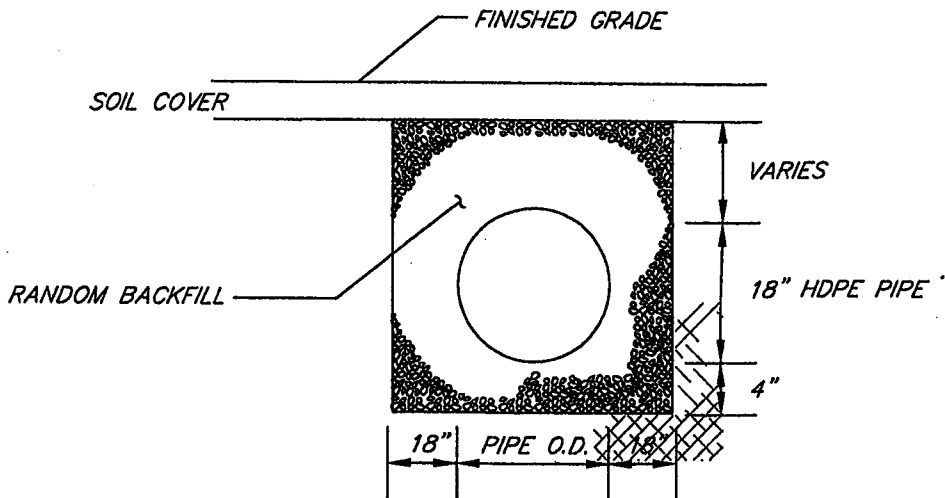

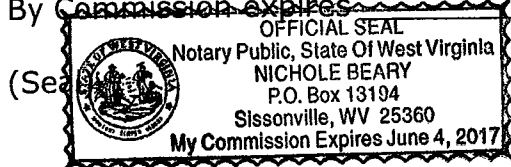
