**GENERAL TERMS & CONDITIONS
REQUEST FOR QUOTATION (RFQ) AND REQUEST FOR PROPOSAL (RFP)**

1. Awards will be made in the best interest of the State of West Virginia.
2. The State may accept or reject in part, or in whole, any bid.
3. All quotations are governed by the *West Virginia Code* and the *Legislative Rules* of the Purchasing Division.
4. Prior to any award, the apparent successful vendor must be properly registered with the Purchasing Division and have paid the required \$125 fee.
5. All services performed or goods delivered under State Purchase Order/Contracts are to be continued for the term of the Purchase Order/Contracts, contingent upon funds being appropriated by the Legislature or otherwise being made available. In the event funds are not appropriated or otherwise available for these services or goods, this Purchase Order/Contract becomes void and of no effect after June 30.
6. Payment may only be made after the delivery and acceptance of goods or services.
7. Interest may be paid for late payment in accordance with the *West Virginia Code*.
8. Vendor preference will be granted upon written request in accordance with the *West Virginia Code*.
9. The State of West Virginia is exempt from federal and state taxes and will not pay or reimburse such taxes.
10. The Director of Purchasing may cancel any Purchase Order/Contract upon 30 days written notice to the seller.
11. The laws of the State of West Virginia and the *Legislative Rules* of the Purchasing Division shall govern all rights and duties under the Contract, including without limitation the validity of this Purchase Order/Contract.
12. Any reference to automatic renewal is hereby deleted. The Contract may be renewed only upon mutual written agreement of the parties.
13. **BANKRUPTCY:** In the event the vendor/contractor files for bankruptcy protection, the State may deem this contract null and void, and terminate such contract without further order.
14. **HIPAA BUSINESS ASSOCIATE ADDENDUM:** The West Virginia State Government HIPAA Business Associate Addendum (BAA), approved by the Attorney General, and available online at the Purchasing Division's web site (<http://www.state.wv.us/admin/purchase/vrc/hipaa.htm>) is hereby made part of the agreement. Item 2: Q) Will the rock over-hang be laid back or cut vertically?

A) The contractor shall remove the overhanging rock to provide a slope of $\frac{1}{4}$ H:1 V on the rock face on the highwall.

Item 3: Q) Do we have access (R/W) to get above the top of the block wall mine seals?

A) Yes, the limits of construction are above the mine portals. However no access road in this area will be approved to be constructed.

Item 4: Q) Will the contractor be responsible for coordinating activities with the property owner (buildings, etc)?

A) Yes

Item 5: Q) Will the contractor be responsible for removal of excess material?

A) Yes

Item 6: Q) Does the construction limits extend to the front of the house?

A) No

Item 7: Q) Will the contractor be responsible to address the septic system?

A) No

Item 8: Q) Are we going to install the block wall mine seals where the portals have collapsed?

A) Yes, behind the house.

Item 9: Q) What if the mine portals are unstable?

A) The contractor shall provide temporary roof support during construction to secure the area and make portals safe during the construction of the mine seals. The contractor will implement safety procedures to secure the roof of the mine portals.

Item 10: Page 36 of the Technical Specifications Section 8.5, "Pay Items", Item 8.2 "Double Block Wall Mine Seal" shall be measured and paid "per each" instead of "per linear foot".

Item 11: The Contractor's Bid Sheet (attached) has been revised to show that Item 8.2 "Double Block Wall Mine Seal" shall be paid per each mine seal installed.

- Item 12: Page 40 of the Technical Specifications, Section 10.7, "Pay Item" should be Item 10.0 instead of Item 8.1.
- Item 13: The contractor will have 90 days from the date of the Notice to Proceed to complete Construction activities on the project. The \$250 per day liquidated damage clause will be in effect after the 90 days. However, the total performance period will be 365 days from the date of the Notice to Proceed for invoicing purposes.

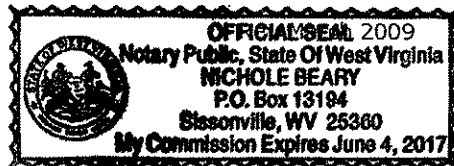

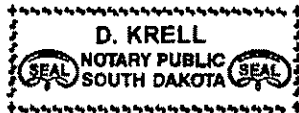

The signature of any such officer and the corporate seal may be printed by facsimile.
