REQUEST FOR QUOTATION (RFQ) AND REQUEST FOR PROPOSAL (RFP)**

1. Awards will be made in the best interest of the State of West Virginia.
2. The State may accept or reject in part, or in whole, any bid.
3. All quotations are governed by the *West Virginia Code* and the *Legislative Rules* of the Purchasing Division.
4. Prior to any award, the apparent successful vendor must be properly registered with the Purchasing Division and have paid the required \$125 fee.
5. All services performed or goods delivered under State Purchase Order/Contracts are to be continued for the term of the Purchase Order/Contracts, contingent upon funds being appropriated by the Legislature or otherwise being made available. In the event funds are not appropriated or otherwise available for these services or goods, this Purchase Order/Contract becomes void and of no effect after June 30.
6. Payment may only be made after the delivery and acceptance of goods or services.
7. Interest may be paid for late payment in accordance with the *West Virginia Code*.
8. Vendor preference will be granted upon written request in accordance with the *West Virginia Code*.
9. The State of West Virginia is exempt from federal and state taxes and will not pay or reimburse such taxes.
10. The Director of Purchasing may cancel any Purchase Order/Contract upon 30 days written notice to the seller.
11. The laws of the State of West Virginia and the *Legislative Rules* of the Purchasing Division shall govern all rights and duties under the Contract, including without limitation the validity of this Purchase Order/Contract.
12. Any reference to automatic renewal is hereby deleted. The Contract may be renewed only upon mutual written agreement of the parties.
13. **BANKRUPTCY:** In the event the vendor/contractor files for bankruptcy protection, this Contract may be deemed null and void, and terminated without further order.

DJS010261 – PSYCHOLOGICAL SERVICES**

**PERSONNEL SELECTION AND RETENTION REQUIREMENTS.**

- a. The Contractor shall provide adequate qualified staff for the provision of the aforementioned services in compliance with ACA Standards.
- b. The Contractor shall cover periods of absences necessitated by vacations, holidays, and extended sick leave.
- c. The Contractor shall be responsible for providing educational services for staff. The Contractor's contractual relationship with qualified professionals shall provide for support of continuing education activities required for maintenance of licensure either by direct monetary supplementation or providing paid continuing education units.
- d. The Contractor shall be responsible for assuring that all required registrations, licenses, and credentials associated with the operation are active and in good standing. This includes, but is not limited to licenses, as well as registration with appropriate State Boards. The Contractor shall provide the Division with current resumes and licenses, required by statute, on all applicable qualified professional employees as well as those subcontracted professional employees. Licensed individuals, who have license restrictions or mandatory disciplinary stipulations upon their scope of practice, are unacceptable candidates for employment within the facility setting. All professionals shall possess an unrestricted license. Any professional who has been convicted of a felony in accordance with any State or Federal law is unacceptable.
- e. In order to be eligible for employment within a facility under the control of the WV Division of Juvenile Services, all contract and subcontracted employees must pass a background investigation conducted by the Division or its designee prior to providing any services. Such investigation shall be the equivalent of the investigations conducted for all Division applicants.
- f. The Contractor agrees to require all newly hired employees to attend no more than a 40 hour training and orientation program provided by the Division. When such training program is available, the Contractor shall require such employees to be in attendance prior to engaging in the delivery of health care services within the juvenile facility. If training is unavailable, the facility administrator may grant a waiver until the next training class convenes.
- g. The Contractor shall require all employees to be in attendance at annual in-service security training. Training costs will be covered by the Division.
- h. With respect to those employees and subcontractors engaged by the Contractor, the Division, at its sole discretion, reserves the right to request random drug testing and to demand the immediate dismissal or replacement of any individual who fails said drug screening or who has violated the rules and/or regulations of the Division, or who poses a risk or unacceptable threat to security of the facility. The Division shall provide written documentation to substantiate its demand for immediate replacement of the Contractor's employees or sub contractors. The employee will not be formally dismissed until there has at a minimum been discussion between the Division and the Contractor regarding the rationale for the Division's request.
- i. The Division reserves the right to reassign FTEs based on need and site mission. The Division shall reserve the right to deny employment of any staff member without cause.

**The operating environment for this RFQ will be present and future Division of Juvenile Services facilities and programs. Listed below are the current Division of Juvenile Services sites and future planned expansions.**

The Central Office of the Division of Juvenile Services is located at 1200 Quarrier Street (2<sup>nd</sup> Floor), Charleston, WV 25301. However, delivery of services will be at the following locations.

The West Virginia Industrial Home for Youth is located at 7 Industrial Blvd., Industrial, (Harrison County) West Virginia 26375. This maximum secured correctional facility is a 210 bed facility.

The Davis Center is located at Blackwater Falls Road, Davis, (Tucker County) West Virginia 26260. This minimum security correctional facility is a 60 bed facility.

The Vicki Douglas Juvenile Center is located at 900 Emmett Rousch Drive, Martinsburg, (Berkeley/Jefferson Counties) West Virginia, 25401. This center is a 24 bed facility which serves residents from the eastern part of the state.

The Northern Juvenile Center is located at 1000 Chapline Street, Wheeling (Ohio County) West Virginia, 26003. This center is a 19 bed facility which serves residents from the northern panhandle part of the state.

The Lorrie Yeager Juvenile Center is located at 907 Mission Drive, Parkersburg, (Wood County) West Virginia, 26103. This center is a 24 bed facility which serves residents from the north central part of the state.

The Sam Perdue Juvenile Center is located at 843 Shelter Road, Princeton, (Mercer County) West Virginia, 24740. This center is a 24 bed facility which serves residents from the southern part of the state.

The J.H. "Tiger" Morton Juvenile Facility is located at 60 Manfred Holland Way, Dunbar, (Kanawha County) West Virginia, 25064. This center is a 24 bed facility and serves residents from the south central region of the state.

The Donald R. Kuhn Juvenile Diagnostic and Detention Center is located at One Lory Place, Julian (Boon County) West Virginia, 25529. This is a 48 bed facility which serves residents from all over the state.

The J.M. "Chick" Buckbee Juvenile Center is located at One Jerry Lane, Augusta (Hampshire County) West Virginia, 26704. This center is a 24 bed facility which serves residents from the Potomac Highlands region in West Virginia.

The Gene Spadaro Juvenile Center is located at 106 Martin Drive, Mt. Hope (Fayette County) West Virginia, 25880. This center is a 24 bed facility which serves the residents south eastern region of the state.

The Robert Shell Juvenile Center is located at 2 O'Hanlon Place, Barboursville (Cabell County) West Virginia, 25504. This is a 24 bed facility which serves residents in the central western region of the state.

### **Youth Reporting Center Locations**

The Cabell County Youth Reporting Center is located at 2 O'Hanlon Place, Barboursville West Virginia, 25504. This is a community based program serving juvenile offenders of Cabell County.

The Stars Youth Reporting Center is located at 900 Emmett Rousch Drive Martinsburg WV, 25401. This is a community based program serving juvenile offenders in Berkeley County.

The Kanawha County Youth Reporting Center is located at Central Avenue in Charleston WV, 25301. This is a community based program serving juvenile offenders in Kanawha County.

Following is a list of staff the Division of Juvenile Services wishes to contract for, their required credentials, and the required duties. See Appendix A for the locations and projected FTE that will be required. Appendix B is the format by which to submit your proposal.

**Psychologist**

**Required Credentials**

All candidates must have a Master's in Psychology or PhD degree in psychology from an accredited college or university. All candidates must be currently licensed as a psychologist by the West Virginia Board of Examiner's of Psychologists or license eligible with supervision status. All candidates must have Professional experience which indicates knowledge of psychological testing, mental health counseling, group and individual psychotherapy, diagnosis and treatment of major mental disorders and psychological evaluation techniques.

**Required Duties**

**Northern WV Youth Diagnostic Center @ Salem WV**

The psychologist will be responsible for completion and submission of the psychological component of the comprehensive diagnostic evaluation on each diagnostic resident to include personality, academic and intellectual functioning, sex offender assessment interpretation, if applicable, and shall address criminogenic risk/need, responsivity and addiction severity. This evaluation must be provided in an approved format within allotted time frame. DJS will purchase all testing materials and will provide staff for typing of evaluations unless the psychologists prefer to type them themselves.

The psychologist will be an active member of the treatment team to include mandatory participation in weekly clinical meetings and will also present the psychological report summary at the resident's multi-disciplinary treatment team meeting.

**WV Industrial Home for Youth Wellness Center & Programming Center**

Psychological evaluations will also be provided by the psychologist for residents of the WV Industrial Home for Youth who will be transitioning to/from another placement and is in need of a new or updated psychological evaluation.

**Psychiatric Nurse**

**Required Credentials**

All candidates must be a Registered Nurse who is licensed to practice nursing in the State of West Virginia and possess a minimum of three (3) years experience working in a correctional facility. Candidates must demonstrate professional experience which indicates knowledge of mental health services, diagnosis and treatment of major mental disorders, and mental status techniques.

**Required Duties**

This position will be assigned to the Wellness Center of the WV Industrial Home for Youth in Salem. The main duties will be to monitor psychotropic medications, to assess treatment effectiveness and monitor medication side effects by ensuring all residents on the psychiatric caseload are staffed with the treatment team on a minimum of one time per week.

The psychiatric nurse will participate in weekly clinical meetings held for each resident on the unit. The psychiatric nurse will document information from the clinical team meetings in the resident's individual medical chart for those residents on the psychiatric case load.

The psychiatric nurse will complete the initial individualized psychiatric treatment plan for all new psychiatric intake evaluations for residents placed on the Intensive Behavioral Unit.

The psychiatric nurse will be included in the DJS mental health 24/7 on-call system.

## **Program Director**

### **WV Industrial Home for Youth Wellness Center**

#### **Required Credentials**

The Program Director candidates must have a Master's degree in Psychology, Counseling or Social Work with a minimum of five (5) years direct clinical evaluation, treatment and consultation services with the child and adolescent population. Candidates must have a minimum of three (3) years administrative experience responsible for the organization and implementation of training programs, supervision of program facilitators, program implementation, statistical data collection and data analysis.

#### **Required Duties:**

The Program Director will be responsible for the clinical oversight of the Wellness Center at the WV Industrial Home for Youth. Main duty is to supervise all clinical work of treatment staff of said unit.

The Program Director will meet weekly with the Director of Treatment and Programs at the WV Industrial Home for Youth and will participate in weekly management team meetings held by the Director of Treatment and Programs.

The Program Director is also responsible for providing a statistical report of services as directed by the WV Division of Juvenile Services to include at a minimum intakes and concerns on a monthly basis to the Director of Treatment and Programs at the WV Industrial Home for Youth.

The Program Director will provide in-service training to WV DJS staff on issues related to Adolescent Mental Health and Suicidal Behaviors.

## **Master's Level Therapist**

#### **Required Credentials**

All candidates must have Master's degree in psychology, social work or a related behavioral science field and must hold a current license or be license eligible with temporary or supervision status with their respective licensing board. Candidates must have professional experience which indicates knowledge of mental health counseling, group and individual psychotherapy, diagnosis and treatment of major mental disorders. Candidates must have experience working with children, adolescents and families in a mental health facility or working for a mental health agency. Candidates must have knowledge of behavioral management/modification techniques and experience with development and implementation of individualized treatment plans.

#### **Required Duties**

### **Wellness Center at Salem WV (2)**

The contractor will provide qualified mental health professional in the form of Master's Level Therapist who will be assigned to the unit to meet the individual needs of offenders. The Masters Level Therapist will provide

intensive group therapy weekly, individual therapy every other week at a minimum, crisis intervention, education on mental illness or acting out behaviors and related medication symptoms as needed.

In addition to psychiatric intervention, the Masters Level Therapist will develop and oversee a comprehensive, individualized, multidisciplinary treatment plan that will be maintained for each resident on the intensive behavioral unit. All treatment plans will be developed in a manner that is consistent with reintegration of the resident back into general population.

The Masters Level Therapists will actively participate in weekly clinical meetings held on each resident on the unit and will provide monitoring reports in regards to the resident's level of program participation and progress toward completion of individualized treatment goals.

#### **Adolescent Leadership Development Academy at Salem WV (2)**

Masters level therapist with a knowledge of behavioral modifications techniques to provide group, family and individual counseling, develop and implement comprehensive treatment plans, supervise the therapeutic work of bachelors level and non-degreed treatment staff, provide crisis intervention, serve as team leader of a clinical team who will access and interview potential residents of this program, converse with professionals such as judges, attorneys, probation officers, DHHR workers as well as family members and develop/implement behavioral management plans for each resident of the unit.

Responsible for providing a statistical report of services as directed by the WV Division of Juvenile Services to include at a minimum intakes and concerns on a monthly basis to the Assistant Director of Programs and Treatment.

#### **Program Coordinators at Gene Spadaro JC and Robert Shell JC (2)**

**These positions will be stationed at Mount Hope and Barboursville WV.**

Duties will include, but not be limited to, program development and implementation, supervision of clinical services provided by bachelor's level and non-degreed treatment staff, individual and group counseling, crisis intervention, development and maintenance of treatment plans, including updating goals and objectives, coordination and liaison with professionals such as judges, attorneys, prosecutors, DHHR workers and family members, and training of DJS staff on issues of treatment of juveniles in the juvenile justice system.

#### **Youth Reporting Centers (TBD) Various Locations (2.5)**

The contractor will provide a licensed Master's Level Therapist to work an average 20 hours per week at Youth Reporting Centers operated by the Division of Juvenile Services. These individuals will be responsible for but not limited to the following: providing intensive group and individual therapy to youth, participate in weekly clinical reviews, act as a clinical advisor to treatment staff, participate in the develop of service plans, conduct family therapy as needed, complete initial evaluations as needed (i.e. psychosocial), complete necessary written documentation on the youth in the program.

#### **Master's Level Social Worker**

##### **Required Credentials**

Candidates must have a Master's or Bachelors degree in social work, psychology or a related behavioral science field from an accredited college or university. Candidates must be currently licensed as a social worker with the West Virginia Board of Social Work Examiners.

##### **Required Duties**

#### **Adolescent Leadership Development Academy at Salem WV (2)**

The contractor will provide Master's Level Social Workers to serve as case managers. Case Manager will supervise all case related services to include maintenance of the individualized treatment plan, scheduling and facilitation of multi-disciplinary treatment team meetings, interactions with Judges, Prosecuting Attorneys, Probation Officers, family members, defense counsel as well as DHHR social workers. They will be

responsible for monthly progress reports to the court as well as the gathering of external collateral information needed in the development of a comprehensive plan of treatment for each resident.

**Psychometrician**

**Services will be provided at the Northern WV Youth Diagnostic Center in Salem WV and the Donald R. Kuhn Juvenile Diagnostic and Detention Center in Julian WV. Each facility will require an average of 20 hours per week.**

**Required Credentials**

Must have Bachelor's degree in psychology, social work or a related behavioral science field and shall display professional experience which indicates knowledge of design, administration, and interpretation of quantitative tests for the measurement of psychological variables such as intelligence, aptitude, and personality traits.

**Required Duties**

Will be on site and responsible for psychological testing of residents at Division Facilities. Duties will be assigned by and work will be supervised by a Licensed or Supervised Psychologists at each facility.

**The Division of Juvenile Services plans future expansions of services for our juvenile population. Future expansions include a possible program to provide residential Substance Abuse Treatment and expansions of our Sex Offender Treatment Unit. Additional specialized treatment personnel for these programs will be negotiated at a future date when these expansions are funded.**

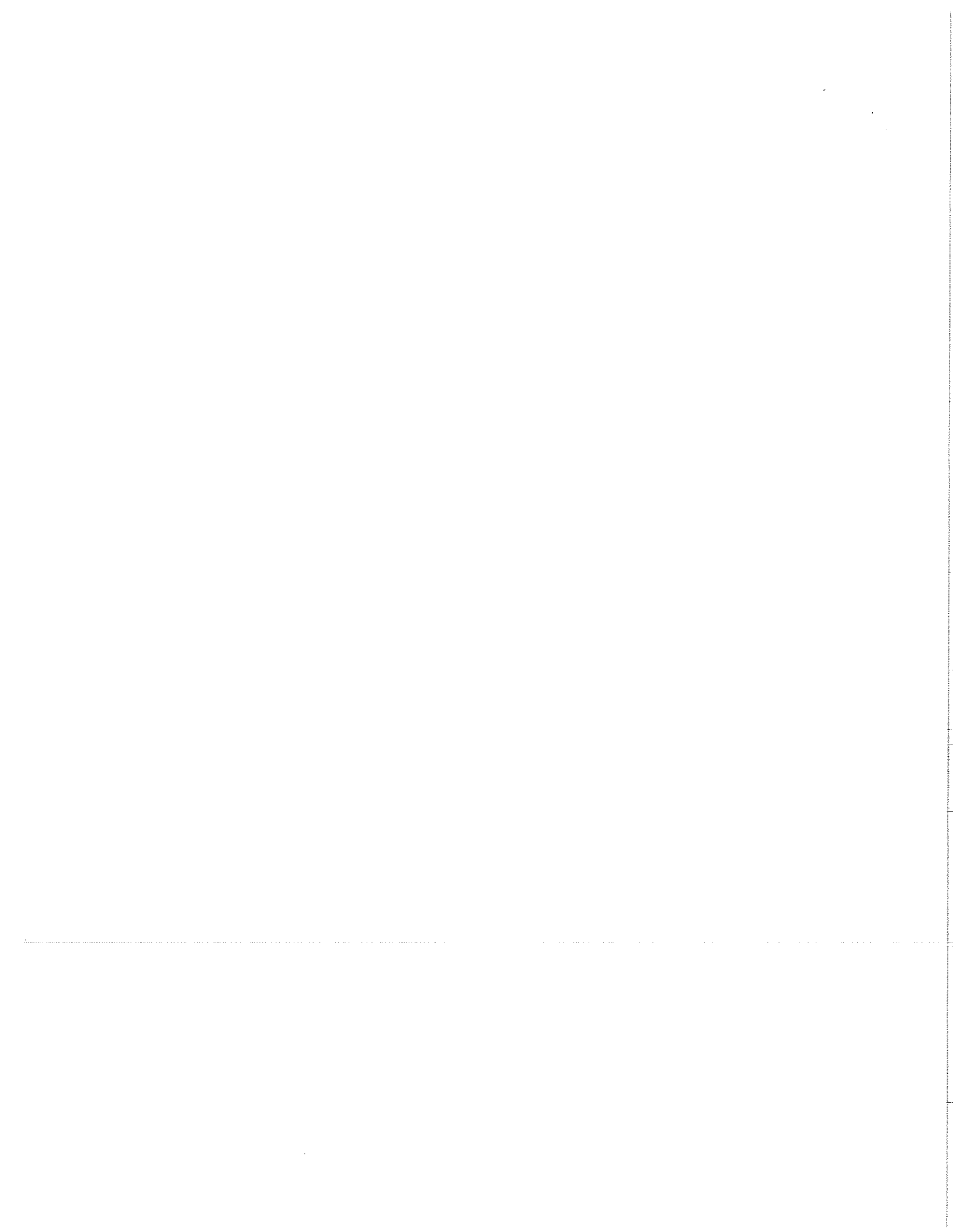

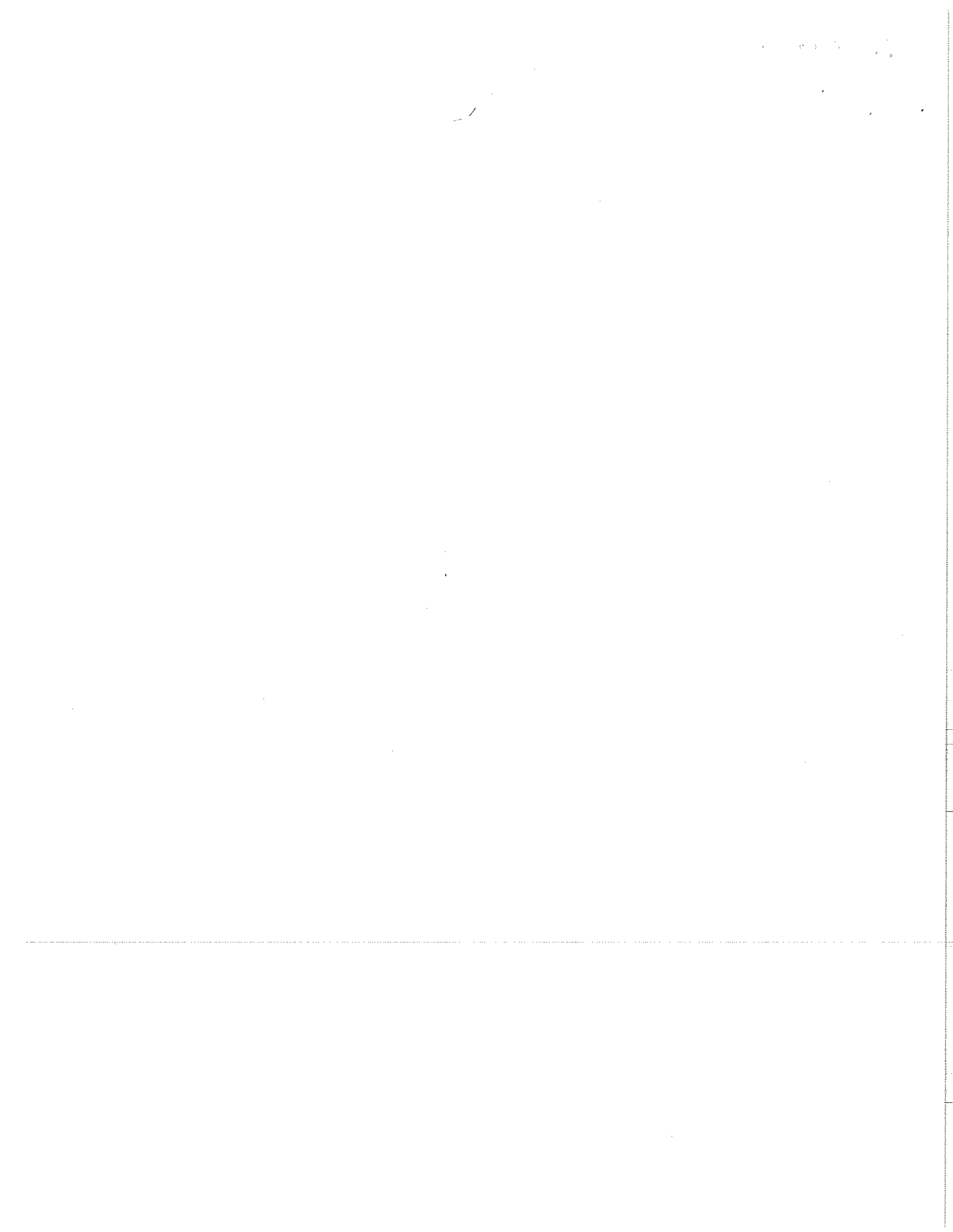

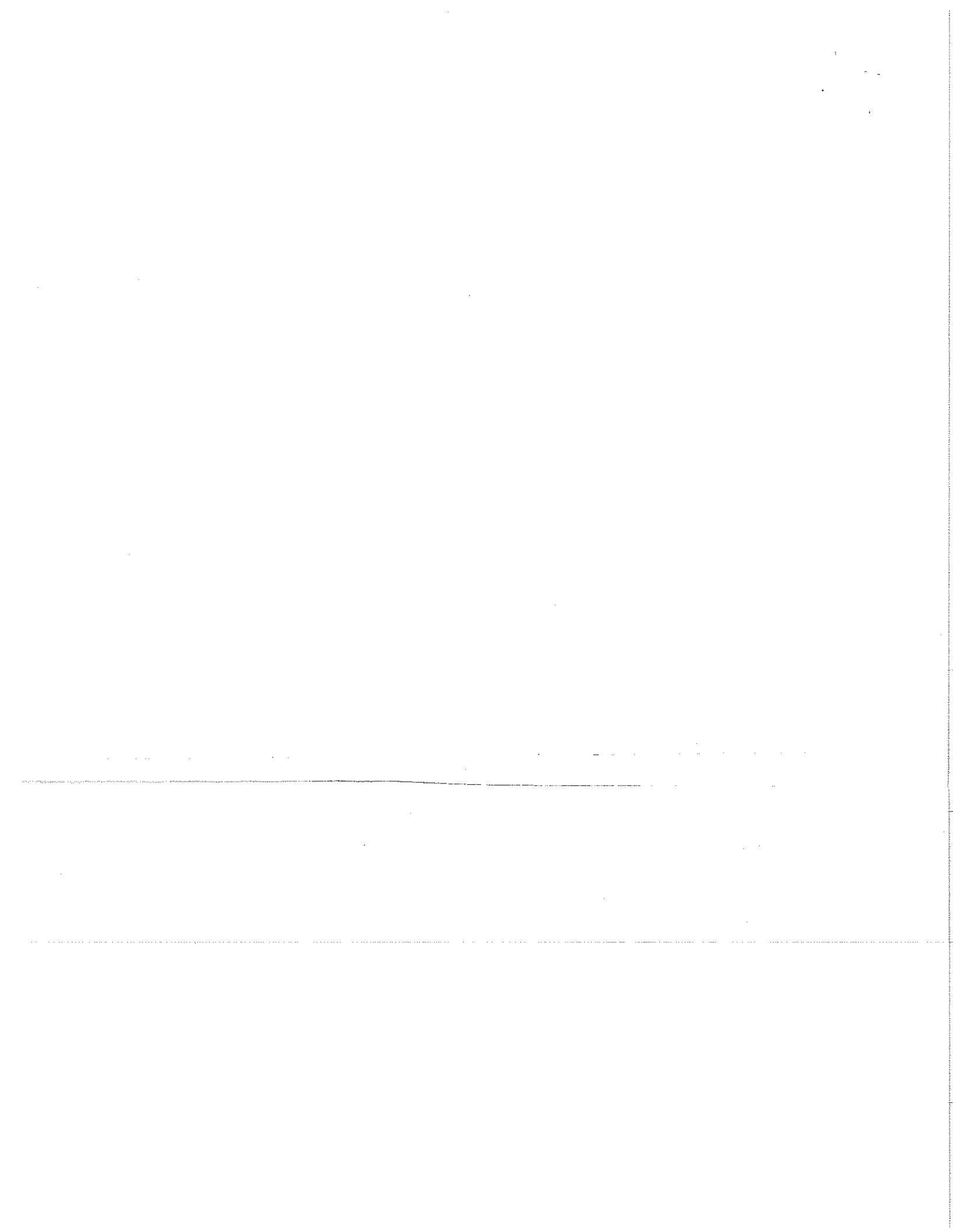
