3. All quotations are governed by the *West Virginia Code* and the *Legislative Rules* of the Purchasing Division.
4. Prior to any award, the apparent successful vendor must be properly registered with the Purchasing Division and have paid the required \$125 fee.
5. All services performed or goods delivered under State Purchase Order/Contracts are to be continued for the term of the Purchase Order/Contracts, contingent upon funds being appropriated by the Legislature or otherwise being made available. In the event funds are not appropriated or otherwise available for these services or goods, this Purchase Order/Contract becomes void and of no effect after June 30.
6. Payment may only be made after the delivery and acceptance of goods or services.
7. Interest may be paid for late payment in accordance with the *West Virginia Code*.
8. Vendor preference will be granted upon written request in accordance with the *West Virginia Code*.
9. The State of West Virginia is exempt from federal and state taxes and will not pay or reimburse such taxes.
10. The Director of Purchasing may cancel any Purchase Order/Contract upon 30 days written notice to the seller.
11. The laws of the State of West Virginia and the *Legislative Rules* of the Purchasing Division shall govern all rights and duties under the Contract, including without limitation the validity of this Purchase Order/Contract.
12. Any reference to automatic renewal is hereby deleted. The Contract may be renewed only upon mutual written agreement of the parties.

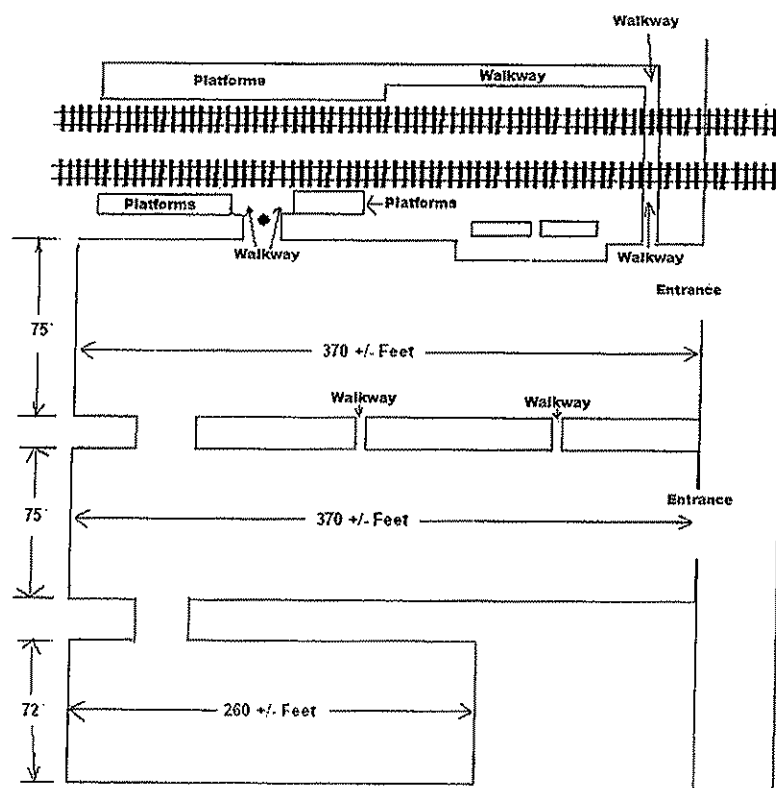

## **Section 2. Desired Attributes of System**

- System shall be capable of covering the entire parking lot and passenger loading platforms.
- System shall be able to store at least one week of video
- Cameras shall be of sufficient quality to allow identification of vehicle, individuals, and license plate numbers. Cameras should also be able to pan the parking lot if needed. They shall be Outdoor 6-60MM Vari Focal Lens 520 TVL RES, IR Cameras or equivalent. Five fixed point cameras and one panning camera will be installed on the existing poles. Successful vendor will determine the best location of the cameras for the best coverage.
- Vendor shall supply a 4 channel DVR with 160GB, USP, and IP with a lock box and dual fans.
