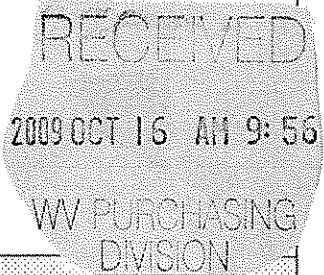

REQUEST FOR QUOTATION (RFQ) AND REQUEST FOR PROPOSAL (RFP)

1. Awards will be made in the best interest of the State of West Virginia.
2. The State may accept or reject in part, or in whole, any bid.
3. All quotations are governed by the *West Virginia Code* and the *Legislative Rules* of the Purchasing Division.
4. Prior to any award, the apparent successful vendor must be properly registered with the Purchasing Division and have paid the required \$125 fee.
5. All services performed or goods delivered under State Purchase Order/Contracts are to be continued for the term of the Purchase Order/Contracts, contingent upon funds being appropriated by the Legislature or otherwise being made available. In the event funds are not appropriated or otherwise available for these services or goods, this Purchase Order/Contract becomes void and of no effect after June 30.
6. Payment may only be made after the delivery and acceptance of goods or services.
7. Interest may be paid for late payment in accordance with the *West Virginia Code*.
8. Vendor preference will be granted upon written request in accordance with the *West Virginia Code*.
9. The State of West Virginia is exempt from federal and state taxes and will not pay or reimburse such taxes.
10. The Director of Purchasing may cancel any Purchase Order/Contract upon 30 days written notice to the seller.
11. The laws of the State of West Virginia and the *Legislative Rules* of the Purchasing Division shall govern all rights and duties under the Contract, including without limitation the validity of this Purchase Order/Contract.
12. Any reference to automatic renewal is hereby deleted. The Contract may be renewed only upon mutual written agreement of the parties.
13. **BANKRUPTCY:** In the event the vendor/contractor files for bankruptcy protection, the State may deem this contract null and void, and terminate such contract without further order.
14. **HIPAA BUSINESS ASSOCIATE ADDENDUM:** The West Virginia State Government HIPAA Business Associate Addendum (BAA), approved by the Attorney General, and available online at the Purchasing Division's web site (<http://www.state.wv.us/admin/purchase/vrc/hipaa.htm>) is hereby made part of the agreement. SCOPE OF CONTRACT

The purpose of this Contract shall be to supply WVDOH maintenance personnel with NCHRP-350 tested and approved Nucor Steel Marion provided breakaway hardware to be used for u-channel ground splices. The products included on this Contract shall be the u-channel breakaway splice hardware which is marketed and manufactured by Nucor Steel Marion, or WVDOH approved equal substitutes for the splice hardware manufactured by Nucor Steel Marion.

ITEMS

- Item #1 shall be 1 ea. Nucor Steel Marion threaded Silver Spacer Bar, or WVDOH approved equal, for use with the Nucor Steel Marion Lap Splice u-channel breakaway system.
- Item #2 shall be 1 ea. Nucor Steel Marion threaded Gold Spacer Bar, or WVDOH approved equal, for use with the Nucor Steel Marion Lap Splice u-channel breakaway system.
- Item #3 shall consist of 1 ea. Nucor Steel Marion cut washer, Grade 9 bolt, and self-locking flange nut, or WVDOH approved equals, for use with the Nucor Steel Marion Lap Splice u-channel breakaway system.

SUBSTITUTIONS FOR U-CHANNEL PRODUCER MARKETED AND MANUFACTURED HARDWARE

Any hardware proposed for substitution for the Nucor Steel Marion hardware, as described above, shall meet the following requirements:

- Item #1 – The spacer supplied shall function the same as the Nucor Steel Marion Silver Spacer Bar, and shall be fully threaded. All NCHRP-350 approvals that have been obtained for the Nucor Steel Marion Silver Spacer Bar, in combination with the Nucor Steel Marion cut washer, Grade 9 bolt, and self-locking flange nut shall be in place for the device supplied in combination with the components supplied under Item 3.
- Item #2 – The spacer supplied shall function the same as the Nucor Steel Marion Gold Spacer Bar, and shall be fully threaded. All NCHRP-350 approvals that have been obtained for the Nucor Steel Marion Gold Spacer Bar in combination with the Nucor Steel Marion cut washer, Grade 9 bolt, and self-locking flange nut shall be in place for the device supplied in combination with the components supplied under Item 3.
- Item #3 – The cut washer, Grade 9 bolt, and self-locking flange nut supplied shall function the same as the Nucor Steel Marion cut washer, Grade 9 bolt, and self-locking flange nut. All NCHRP-350 approvals that have been obtained for the Nucor Steel Marion cut washer, Grade 9 bolt, and self-locking flange nut, in combination with the Nucor Steel Marion Silver and Gold Spacer Bars, shall be in place for the components supplied in combination with the devices supplied under Item Numbers 1 and 2.

If a vendor proposes to supply substitute hardware meeting the requirements describe above, the vendor shall submit adequate specifications, approvals, and additional information determined to be necessary to the WVDOH demonstrating that the above requirements are met. By submitting a bid on these items, it is understood that the vendor also certifies that the devices and components that they are supplying do not violate any proprietary patents. Approval of the substitute devices and components proposed by the vendor must be obtained in writing from the WVDOH prior to the letting date of this Contract.

MINIMUM ORDERS

There shall be no minimum order requirement for this contract.

DELIVERY

All prices bid shall be FOB destination. The attached list of delivery addresses represents the address of each District Sign Shop.
