 3. Prior to any award, the apparent successful vendor must be properly registered with the Purchasing Division and have paid the required \$125 fee
 4. All services performed or goods delivered under State Purchase Order/Contracts are to be continued for the term of the Purchase Order/Contracts, contingent upon funds being appropriated by the Legislature or otherwise being made available. In the event funds are not appropriated or otherwise available for these services or goods this Purchase Order/Contract becomes void and of no effect after June 30.
 5. Payment may only be made after the delivery and acceptance of goods or services
 6. Interest may be paid for late payment in accordance with the *West Virginia Code*.
 7. Vendor preference will be granted upon written request in accordance with the *West Virginia Code*.
 8. The State of West Virginia is exempt from federal and state taxes and will not pay or reimburse such taxes.
 9. The Director of Purchasing may cancel any Purchase Order/Contract upon 30 days written notice to the seller.
 10. The laws of the State of West Virginia and the *Legislative Rules* of the Purchasing Division shall govern the purchasing process

Specifications and Requirements:

1. The shell material must be constructed of a minimum of 12 mil strength rated material.
2. Perimeter of bag must be electronically heat sealed for protection against leakage to comply with OSHA regulation 3130 involving containment of bodily fluids.
3. Material must remain flexible up to -70 degrees F (-57 degrees C) for cooler storage and/or outdoor winter operations without cracking.
4. Material must meet EPA chlorine free burn requirements for incineration disposal.
5. Material must be impervious to blood and normal body fluids.
6. Material must not deteriorate or mildew under normal conditions.
7. Shelf life must be in excess of ten (10) years
8. Must have a maximum temperature use of 180 degrees F (82 degrees C).
9. Must have a minimum temperature use of -70 degrees F (-57 degrees C)
10. Should be white in color.
11. Prenatal, Infant and Child size bags must have rust resistant straight zippers
12. Adult size bags must have rust resistant dual zippers and an envelope style access panel for easy loading and unloading as well as allowing autopsies to be performed without removing the bag.
13. Minimum sizes are as follows:
 - Prenatal – 12 x 18 inches with straight zippers
 - Infant – 22 x 30 inches with straight zippers
 - Child – 36 x 60 inches with straight zippers
 - Adult Large – 36 x 94 inches with dual zippers and envelope style access panels
 - Adult X-Large – 48 x 100 inches with dual zippers and envelope style access panels

Specifications and Requirements for Heavy Duty Bags with Handles:

1. The shell material must be constructed of a minimum of 17 mil strength rated material.
2. Bag must contain **NO** side seams on the 94" side and end seams must be electronically heat sealed.
3. Must have rust resistant dual zippers and an envelope style access panel for easy loading and unloading and allows bag to open from either end.
4. Access Panel must be a minimum of 30 x 88 inches.
5. Must have a minimum grab tensile of 248 x 224 lbs
6. Must have minimum tear strength of 66 x 54 lbs.
7. Must have minimum puncture resistance of 168 lbs.

"Related party" means a party, whether an individual, corporation, partnership, association limited liability company or any other form or business association or other entity whatsoever, related to any vendor by blood, marriage, ownership or contract through which the party has a relationship of ownership or other interest with the vendor so that the party will actually or by effect receive or control a portion of the benefit, profit or other consideration from performance of a vendor contract with the party receiving an amount that meets or exceed five percent of the total contract amount

EXCEPTION: The prohibition of this section does not apply where a vendor has contested any tax administered pursuant to chapter eleven of this code, workers' compensation premium, permit fee or environmental fee or assessment and the matter has not become final or where the vendor has entered into a payment plan or agreement and the vendor is not in default of any of the provisions of such plan or agreement.
