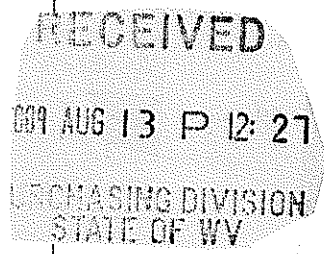

REQUEST FOR QUOTATION (RFQ) AND REQUEST FOR PROPOSAL (RFP)

1. Awards will be made in the best interest of the State of West Virginia.
2. The State may accept or reject in part, or in whole, any bid.
3. All quotations are governed by the *West Virginia Code* and the *Legislative Rules* of the Purchasing Division.
4. Prior to any award, the apparent successful vendor must be properly registered with the Purchasing Division and have paid the required \$125 fee.
5. All services performed or goods delivered under State Purchase Order/Contracts are to be continued for the term of the Purchase Order/Contracts, contingent upon funds being appropriated by the Legislature or otherwise being made available. In the event funds are not appropriated or otherwise available for these services or goods, this Purchase Order/Contract becomes void and of no effect after June 30.
6. Payment may only be made after the delivery and acceptance of goods or services.
7. Interest may be paid for late payment in accordance with the *West Virginia Code*.
8. Vendor preference will be granted upon written request in accordance with the *West Virginia Code*.
9. The State of West Virginia is exempt from federal and state taxes and will not pay or reimburse such taxes.
10. The Director of Purchasing may cancel any Purchase Order/Contract upon 30 days written notice to the seller.
11. The laws of the State of West Virginia and the *Legislative Rules* of the Purchasing Division shall govern all rights and duties under the Contract, including without limitation the validity of this Purchase Order/Contract.
12. Any reference to automatic renewal is hereby deleted. The Contract may be renewed only upon mutual written agreement of the parties.
13. **BANKRUPTCY:** In the event the vendor/contractor files for bankruptcy protection, the State may deem this contract null and void, and terminate such contract without further order.

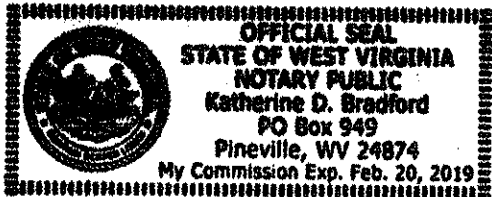

**Addendum #1 - Questions During Pre-Bid Meeting
For DEP 14708
Pendleton Creek Strip Project**

The following questions were identified from the Pre-Bid Conference. The answers provided herein take precedence over verbal answers at the PBC should there be any conflicts between the two.

- 1.) **Q.** Where is the spoil material to be placed that is generated from the excavation to establish the stream channel?
A. It is transported to the highwall area for backfilling.
- 2.) **Q.** Is any water treatment required?
A. Yes, any dewatering of impounded areas must be treated to meet effluent standards.
- 3.) **Q.** Will hay bales or silt fence be allowed for sediment control?
A. Hay bales will be allowed on areas other than the riparian zones. In the riparian zones only straw bales will be allowed. Silt fence will not be allowed.
- 4.) **Q.** Does the entire width of the clay max liner have gravel placed over it or just the width of the constructed stream channel?
A. The gravel is placed over the liner for just the width of the stream channel.
- 5.) **Q.** Do the logs in the stream channel construction have to be commercially purchased?
A. No, on-site materials may be used.
- 6.) **Q.** Since fertilizer is not to be applied in the riparian zone, is lime also not be applied?
A. Lime is to be applied, but not fertilizer.
- 7.) **Q.** Does the language regarding 2nd and 3rd step seeding in the specifications apply to the tree seedlings?
A. No, the language applies to the bid item for revegetation, not reforestation.
- 8.) **Q.** Can the branch cuttings for the riparian planting be commercially purchased?
A. Yes, as long as the species are native to the area where the project is located.
- 9.) **Q.** Is the stream channel construction located over the liner for its entire length?
A. Yes, the constructed stream channel meanders across the width of the liner, but it always remains within the width of the liner.
- 10.) **Q.** Will a winter shut down be allowed?
A. Yes.
- 11.) **Q.** Does the 270 day construction time include the time for winter shut down?
A. Yes.

- 12.) **Q.** How is the debris from clearing and grubbing to be handled?
A. Any timber over 8" is to be salvaged for the property owner; timber meeting the requirements for the 6" logs in the stream channel construction may be utilized; the remainder is to be burned or it may be chipped and disposed of on-site.
- 13.) **Q.** Can the old black top material be incorporated into the backfill?
A. It can be buried on-site, but it has to be segregated from the backfill by being encased in adequate soil cover material to prevent contamination.
- 14.) **Q.** Where 4' of loose material is required for reforestation, will the contractor be paid for undercut?
A. No, providing 4' of loose material is considered as seedling bed preparation which is part of the reforestation pay item.
- 15.) **Q.** Are there any piezometers located on-site?
A. No.
- 16.) **Q.** Can the contact information for a potential supplier of the stream channel construction materials be provided in the addendum?
A. No.

Specification 7.3.3.4 shall be deleted. The contractor is advised that construction may be started in the downstream reaches and proceed in an upstream direction.

Specification 10.4 shall be revised to indicate that relocation of utilities will be paid at invoice cost from the affected utility upon approval of the WVDEP should relocation be necessary.

The Contractor shall have 270 calendar days from the Notice to Proceed to complete construction activities on the project. The \$250 per day liquidated damage clause will be in effect after the 270 days. However, the total performance period will be 365 days from the date of the Notice to Proceed for invoicing purposes.
