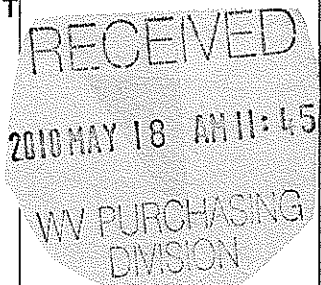

**REQUEST FOR QUOTATION (RFQ) AND REQUEST FOR PROPOSAL (RFP)**

1. Awards will be made in the best interest of the State of West Virginia.
2. The State may accept or reject in part, or in whole, any bid.
3. Prior to any award, the apparent successful vendor must be properly registered with the Purchasing Division and have paid the required \$125 fee.
4. All services performed or goods delivered under State Purchase Order/Contracts are to be continued for the term of the Purchase Order/Contracts, contingent upon funds being appropriated by the Legislature or otherwise being made available. In the event funds are not appropriated or otherwise available for these services or goods this Purchase Order/Contract becomes void and of no effect after June 30.
5. Payment may only be made after the delivery and acceptance of goods or services.
6. Interest may be paid for late payment in accordance with the *West Virginia Code*.
7. Vendor preference will be granted upon written request in accordance with the *West Virginia Code*.
8. The State of West Virginia is exempt from federal and state taxes and will not pay or reimburse such taxes.
9. The Director of Purchasing may cancel any Purchase Order/Contract upon 30 days written notice to the seller.
10. The laws of the State of West Virginia and the *Legislative Rules* of the Purchasing Division shall govern the purchasing process.
11. Any reference to automatic renewal is hereby deleted. The Contract may be renewed only upon mutual written agreement of the parties.
12. **BANKRUPTCY:** In the event the vendor/contractor files for bankruptcy protection, the State may deem this contract null and void, and terminate such contract without further order.

Addendum #1 - Questions During Pre-Bid Meeting

For DEP 14961

Meadowlane Mine Drainage

The following comments and questions were identified from the Pre-Bid Conference. The answers provided herein take precedence over verbal answers at the PBC should there be any conflict between the two.

Comments:

1. The preferred access will be through the disposal site. This will provide access to the primary work area without causing damage to the existing driveway by the main house. The Asphalt Paving pay item will be used to make any repairs that are necessary to the new access road coming off of US Rt 250.
2. The lawn area where the underdrain system is to be installed will need to be hand raked. This will be required for any disturbance below the tree line of the waste disposal area.

Questions:

1. Q. Is the trench depth going to be as deep as 16' at some points on the underdrain?  
A. Yes. The outer section next to US Rt 250 has some deep cuts. You can lay the material back but the trench may still require a trench box to ensure the workers safety.
2. Q. Is the intent of the underdrain depth to get below the basement floor?  
A. Yes. We want to make sure no water can get to the basement area of the house.
3. Q. Does the property owner of the disposal site want the trees?  
A. Yes. All trees 8" and over must be stockpiled for the property owner. (8" diameter)
4. Q. Can we put any material on the upper bench below the disposal area?  
A. No. All excess material must go in the disposal site.
5. Q. Is there B&O tax required on this project?  
A. Yes. It is in the city limits of Fairmont.
6. Q. Is the 40 mil liner to be seamed or can it be overlapped?  
A. It must be seamed. We want the barrier to be water tight.

The Contractor shall have 90 days from the date of the Notice to Proceed to complete construction activities on the project. The \$250.00 per day liquidated damages clause will be in effect after the 90 days. However, the total performance period will be 365 days from the date of the Notice to Proceed for invoicing purposes.

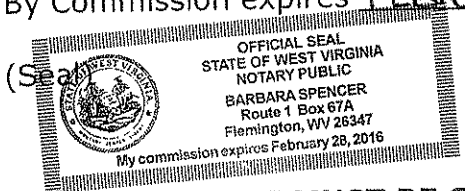

"Related party" means a party, whether an individual, corporation, partnership, association, limited liability company or any other form or business association or other entity whatsoever, related to any vendor by blood, marriage, ownership or contract through which the party has a relationship of ownership or other interest with the vendor so that the party will actually or by effect receive or control a portion of the benefit, profit or other consideration from performance of a vendor contract with the party receiving an amount that meets or exceeds five percent of the total contract amount.

**EXCEPTION:** The prohibition of this section does not apply where a vendor has contested any tax administered pursuant to chapter eleven of this code, workers' compensation premium, permit fee or environmental fee or assessment and the matter has not become final or where the vendor has entered into a payment plan or agreement and the vendor is not in default of any of the provisions of such plan or agreement.

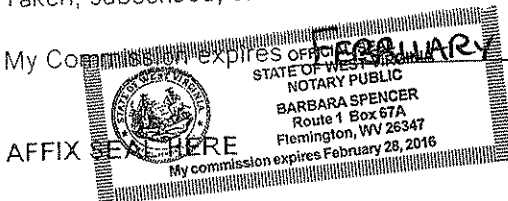
