### Athletic Shoe DJS010283

The West Virginia Division of Juvenile Services is soliciting bids for Athletic footwear to be worn by the Residents at various Juvenile facilities across the State

#### The Specifications are as follows:

- There will be two (2) models of shoes that will be bid:
  - (a) Lace-up mid-cut athletic shoe.
  - (b) Velcro closure mid-cut athletic shoe.
- Shoe must be a lightweight mid-cut or low cut Athletic shoe.
- Color Preference is to be Black with a Black Outer Sole.
- Color can be White with White Sole.
- Men's Shoes must be available in the following Sizes: 7-11 ½, 12, 13, 14, 15, 16, and 17. This is to include all half sizes between 7 and 12.
- Midsole or the cushioned part of the shoe must be made of lightweight DMX foam or Equal. Must cushion the entire length of the foot, and must be a minimum of 1/4" inches thick at the bottom where the foot rests. Tongue must be padded.
- Upper sole must be vented or perforated to allow for breathability and made of leather for greater elasticity. Must have a cushioned collar with reinforced padding and in the heel for greater support.
- Outsole or the bottom of the shoe is to be made of rubber with a Herringbone pattern or Equal for greater traction.
- Outsole must be non-slip, non-marking as not to damage a facility floor. Must be made to perform for both Indoor (wooden court) and outdoor (concrete) and (Black-top) use.
- Insole or the Interior bottom must be made of foam and securely attached to the midsole for greater arch support and must be a minimum of 3/8" inches thick.
- Velcro strap must be at a minimum one half (½") inches in width to firmly secure the shoe.

#### Performance Specifications

- Vendor must provide 15 pair of sample shoes that can be tested for 30 days prior to the award.
- The shoes must meet or pass the following criteria:
  - Wear- The residence will use the footwear through normal everyday athletic use and the wear will be monitored by DJS Staff.
  - Durability- During the normal everyday wear, with athletic activity included, the shoes will be free of structural defects, rips, tears, excessive outsole wear and will maintain cohesion.

**GENERAL TERMS & CONDITIONS  
REQUEST FOR QUOTATION (RFQ) AND REQUEST FOR PROPOSAL (RFP)**

1. Awards will be made in the best interest of the State of West Virginia.
2. The State may accept or reject in part, or in whole, any bid.
3. All quotations are governed by the *West Virginia Code* and the *Legislative Rules* of the Purchasing Division.
4. Prior to any award, the apparent successful vendor must be properly registered with the Purchasing Division and have paid the required \$125 fee.
5. All services performed or goods delivered under State Purchase Order/Contracts are to be continued for the term of the Purchase Order/Contracts, contingent upon funds being appropriated by the Legislature or otherwise being made available. In the event funds are not appropriated or otherwise available for these services or goods, this Purchase Order/Contract becomes void and of no effect after June 30.
6. Payment may only be made after the delivery and acceptance of goods or services.
7. Interest may be paid for late payment in accordance with the *West Virginia Code*.
8. Vendor preference will be granted upon written request in accordance with the *West Virginia Code*.
9. The State of West Virginia is exempt from federal and state taxes and will not pay or reimburse such taxes.
10. The Director of Purchasing may cancel any Purchase Order/Contract upon 30 days written notice to the seller.
11. The laws of the State of West Virginia and the *Legislative Rules* of the Purchasing Division shall govern all rights and duties under the Contract, including without limitation the validity of this Purchase Order/Contract.
12. Any reference to automatic renewal is hereby deleted. The Contract may be renewed only upon mutual written agreement of the parties.
13. **BANKRUPTCY:** In the event the vendor/contractor files for bankruptcy protection, the State may deem this contract null and void, and terminate such contract without further order.
14. **HIPAA BUSINESS ASSOCIATE ADDENDUM:** The West Virginia State Government HIPAA Business Associate Addendum (BAA), approved by the Attorney General, and available online at the Purchasing Division's web site (<http://www.state.wv.us/admin/purchase/vrc/hipaa.htm>) is hereby made part of the agreement. Provided that, the Agency meets the definition of a Cover Entity (45 CFR §160.103) and will be disclosing Protected Health Information (45 CFR §160.103) to the vendor.
15. **WEST VIRGINIA ALCOHOL & DRUG-FREE WORKPLACE ACT:** If this Contract constitutes a public improvement construction contract as set forth in Article 1D, Chapter 21 of the West Virginia Code ("The West Virginia Alcohol and Drug-Free Workplace Act"), then the following language shall hereby become part of this Contract: "The contractor and its subcontractors shall implement and maintain a written drug-free workplace policy in compliance with the West Virginia Alcohol and Drug-Free Workplace Act, as set forth in Article 1D, Chapter 21 of the West Virginia Code. It is understood and agreed that this Contract shall be cancelled by the awarding authority if the Contractor: 1) Fails to implement its drug-free workplace policy; 2) Fails to provide information regarding implementation of the contractor's drug-free workplace policy at the request of the public authority; or 3) Provides to the public authority false information regarding the contractor's drug-free workplace policy."
