1. Could you please confirm that the materials for the project will be exempt from sales tax? 

6. Could you please confirm that the pipe for the project will be corrugated exterior and interior single wall pipe and not corrugated exterior, smooth interior double wall pipe? – Answer - Corrugated exterior and interior single wall pipe as manufactured by Advanced Drainage Systems, Inc.
7. Could you please confirm that the following methods of construction are correct?
 - a. Fairway Perforated Drainage – Sod removed & disposed of, gravel to grade - Answer -yes
 - b. Fairway Solid Drainage – Sod removed and relayed - Answer -yes
 - c. Rough Perforated Drainage – Sod removed & disposed of, gravel to grade - Answer --yes, no need to used sod cutter in rough areas with perforated drainage.
 - d. Rough Solid Drainage – Sod removed & dispose of, seed & mulch - Answer -no**For Rough Solid Drainage – Remove sod with sod cutter and relay.**
8. Is it acceptable to hydroseed the trenches in the rough areas? – Answer -No
9. All work for fairways will be conducted off of plywood. Are we required to work off plywood for rough areas as well or will side casting of material directly on the ground be permitted? – Answer - No sidecasting of excavated material is permitted anywhere.
10. Could you please confirm that all perforated pipe in fairways will have the gravel exposed? – Answer -yes
11. The detail for 6" to 12" perforated pipe denotes only 1" on each side of the pipe. Is it permissible to use 3" on each side of the pipe? There will be a greater chance of settling with only 1" on each side for it will be difficult to get stone completely around the pipe. – Answer -Trench widths are to be as plan details – No exceptions.
12. Could you please confirm that there are no designated wetlands on the site? – Answer -There are no designated wetlands with the construction limits.

13. Are there any special treatments to be installed on the outfalls of the pipe (flared end sections, stone/rip-rap, animal guards, etc.) or will we simply daylight as noted? – Answer -Animal guards are required.

14. Will the 4" perforated lines that tie into the main lines be connected with tees and reducers or will a clay adapter be acceptable? For example, will a 4" perforated line connecting to a 12" line utilize a 12" tee with a 12" x 4" reducer or will we be permitted to cut a 4" hole in the 12" and insert a clay adapter to connect the 4"? –Answer -Cut a 4" hole in the 12" and insert a clay adapter to connect the 4".

15. Should the riser pipe for the Nyloplast InLine Drains be solid or perforated? – Answer – Solid

16. Should the backfill for cart path crossing be 1-1/2" crusher run per the technical specifications or 3/4" per the detail drawing? – Answer -3/4" as per the detail drawing.

18. How should we handle the cost associated with NPDES and Army Corp. permits that the DEP and the FEDS. will surely want done. The permits will not be in place before the bid openings and having dealt with these folks, along with the location we're working, these cost could be rather high. – Answer – Calculations of trench widths have been conducted and disturbed area is less than one acre. No additional permit requirements beyond the General NPDES Permit are required.

19. Specifications for the piping a Canaan Valley golf course call for a single wall corrugated piping, my question is, are you expecting smooth bore single wall with the outer part being corrugated, or should we price straight corrugated pipe with no wall. – Answer - Corrugated exterior and interior single wall pipe as manufactured by Advanced Drainage Systems, Inc.

20. Replace Technical Specification Section B, Paragraph 6, Sentence 1 "Where excavation occurs within fairway areas plus 15 feet either side, an approved sodcutter must be used to remove the top 2" of topsoil at trenches." And replaced with " Where excavation occurs within fairway areas plus 15 feet either side and **all other areas excavated for solid pipe**, an approved sodcutter must be used to remove the top 2" of topsoil at trenches."

21. The bidder if successful and awarded the contract, agrees that all work is to be complete within 180 consecutive calendar days following receipt of the Owner's written Notice to Proceed. For each calendar day of delay in achieving completion, the Contractor shall be liable for and shall pay the Owner liquidated damages in the amount of \$100 per day.



**GENERAL TERMS & CONDITIONS
REQUEST FOR QUOTATION (RFQ) AND REQUEST FOR PROPOSAL (RFP)**

1. Awards will be made in the best interest of the State of West Virginia.
2. The State may accept or reject in part, or in whole, any bid.
3. All quotations are governed by the *West Virginia Code* and the *Legislative Rules* of the Purchasing Division.
4. Prior to any award, the apparent successful vendor must be properly registered with the Purchasing Division and have paid the required \$125 fee.
5. All services performed or goods delivered under State Purchase Order/Contracts are to be continued for the term of the Purchase Order/Contracts, contingent upon funds being appropriated by the Legislature or otherwise being made available. In the event funds are not appropriated or otherwise available for these services or goods, this Purchase Order/Contract becomes void and of no effect after June 30.
6. Payment may only be made after the delivery and acceptance of goods or services.
7. Interest may be paid for late payment in accordance with the *West Virginia Code*.
8. Vendor preference will be granted upon written request in accordance with the *West Virginia Code*.
9. The State of West Virginia is exempt from federal and state taxes and will not pay or reimburse such taxes.
10. The Director of Purchasing may cancel any Purchase Order/Contract upon 30 days written notice to the seller.
11. The laws of the State of West Virginia and the *Legislative Rules* of the Purchasing Division shall govern all rights and duties under the Contract, including without limitation the validity of this Purchase Order/Contract.
12. Any reference to automatic renewal is hereby deleted. The Contract may be renewed only upon mutual written agreement of the parties.
13. **BANKRUPTCY:** In the event the vendor/contractor files for bankruptcy protection, the State may deem this contract null and void, and terminate such contract without further order.
