- 1 CMU masonry shall be 8 inch smooth face and colored. The color of the CMU masonry shall be selected by the Engineer through the material submittal process.
- 2 The CMU mortar shall be colored as well and will be selected through the same process.
- 3 All other specifications for CMU masonry shall remain the same as indicated in the project documents.
- 4 Drawing A1.1 is inconsistent with the concrete floor thickness. The minimum floor thickness shall be 6 inches.


