3. Prior to any award, the apparent successful vendor must be properly registered with the Purchasing Division and have paid the required \$125 fee.
4. All services performed or goods delivered under State Purchase Order/Contracts are to be continued for the term of the Purchase Order/Contracts, contingent upon funds being appropriated by the Legislature or otherwise being made available. In the event funds are not appropriated or otherwise available for these services or goods this Purchase Order/Contract becomes void and of no effect after June 30.
5. Payment may only be made after the delivery and acceptance of goods or services
6. Interest may be paid for late payment in accordance with the *West Virginia Code*.
7. Vendor preference will be granted upon written request in accordance with the *West Virginia Code*.
8. The State of West Virginia is exempt from federal and state taxes and will not pay or reimburse such taxes.
9. The Director of Purchasing may cancel any Purchase Order/Contract upon 30 days written notice to the seller.
10. The laws of the State of West Virginia and the *Legislative Rules* of the Purchasing Division shall govern the purchasing process.
11. Any reference to automatic renewal is hereby deleted. The Contract may be renewed only upon mutual written agreement of the parties.

The West Virginia State Police are soliciting competitive bids for a percentage mark down of the purchase of auto parts used to service the State Police vehicle fleet. Currently the West Virginia State Police maintains a fleet of approximately 900 vehicles. These vehicles include vehicles manufactured by Ford, Dodge and General Motors. The majority of these vehicles will be Ford Crown Victoria Police Interceptors, Chevrolet Impala, Chevrolet Trail Blazer, Dodge Durango, and Ford Explorer. GENERAL:

The Vendor awarded this contract aforementioned locations. Vendor will offer same day delivery by courier for parts ordered by the agency to the aforementioned location *unless the location of the vendor to the agency locations proves that it would be more expedient for the agency to travel to the vendor instead of waiting for delivery by the courier.* Parts to be purchased will include general maintenance items such as spark plugs, fan belts, windshield wiper blades, brake pads etc.... 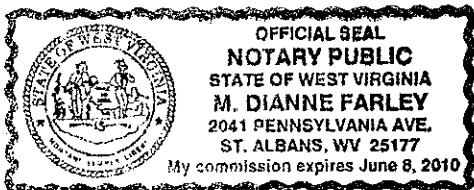
