Question#1: Section 08331, 2.6.J: How does the emergency override work? What is the door supposed to do when it is activated?

Answer#1: The emergency override allows manual operation of the door in case of power failure or failure of the remote control operation. See paragraphs 'F' and 'G'.

Question#2: Section 08331, 2.7.J.1: Are doors to be Baked-Enamel or Powder-Coated finish?

Answer#2: The specifications permit either. The powder-coat finish is preferred.

Question#3: Drawing SK-1, General Notes, 5: Location of warning light/horn is not shown. Are they to be mounted inside (NEMA1) or outside (NEMA4)?

Answer#3: The location is inside, shown on the sketch on the upper left hand side of the door (between note 2 and 8.)

Question#4: Drawing SK-1, General Notes, 8: Provide specifications for "New Height Alarm."

Answer#4: The existing doors have been damaged numerous times by vehicles hitting doors before they are fully opened. The intent of the alarm system is to warn drivers that door is not fully opened and vehicle is about to impact door.

Question#5: Provide specification for concrete.

Answer#5: 4,000 psi, ¾" aggregate, air-entrained concrete with slump less than three inches. Use a high early strength concrete for increased setting of concrete to place door openings back in service earlier.

Question#6: Are sales, use or city taxes applicable to this job?

Answer#6: The State of WV is exempt from all taxes, but the successful Contractor is responsible for all city (of Charleston, B&O, for instance) taxes. Licensure within the City is also required, but the fee is generally waived (by the City of Charleston) if the Contractor is working on a State project.

Question#7: Drawing SK-1, General Notes, 2, "...existing pipe clearances": The new insulated doors require approx 26-1/2" headroom (pre engineering (sic)). Existing pipes provide only 24" (approx). Exact clearance requirements won't be known until the final door design is approved, but if headroom is inadequate, is it acceptable to lower the door heights to accommodate piping or will pipes have to be relocated?

Answer#7: The head room and pipe clearance issues were noted on the drawings due to the Owner's concern about minimal clearances and past problems with door heights being shortened to accommodate clearances. Actual equipment sizes will vary from manufacturer to manufacturer, so each supplier will be responsible for providing a solution for their product. Pre-engineered products may have to be modified to minimize hood size and provide clearances. If clearances with standard equipment cannot be provided, contractor may request relocation of pipes.

Question#8: If pipes must be relocated, who is responsible for this?

Answer#8: The contractor will be responsible for the relocation.
